**S 3. SMOKY MOUNTAINS NATIONAL PARK PLATE CHANGES.** Filed 1/28/09. *TO ALLOW THE USE OF FEES COLLECTED FROM THE FRIENDS OF THE GREAT SMOKY MOUNTAINS NATIONAL PARK SPECIAL STATE ATTRACTION PLATE TO BE USED FOR ORDINARY ADMINISTRATIVE AND OPERATING EXPENSES.*

Amends GS 20-81.12(b2)(1c) as title indicates.

**S 3. SMOKY MOUNTAINS NATIONAL PARK PLATE CHANGES.** Filed 1/28/09. Senate amendment makes the following changes to 1st edition. Amends GS 20-79.4(b) to add four special registration plates designed as follows: (1) an ARTS NC (ARTS) plate bearing the phrase, "The Creative State," with a logo designed by the ARTS North Carolina, Inc.; (2) a Friends of Camp Daniel Boone (Camp) plate bearing that phrase as its title and including a logo provided by the Daniel Boone Council of the Boy Scouts of America; (3) a Mountains-to-Sea Trail plate (Sea Trail), bearing that phrase as its title with a background designed by the Friends of the Mountains-to-Sea Trail, Inc.; and (4) the Native Brook Trout (Trout) plate bearing that phrase as its title and a picture of a Brook Trout native to North Carolina in the background. Amends GS 20-79.7 to establish a special plate fee of \$30 for each of the four special registration plates.

Distributes \$10 of the fee amount collected for each of the plates to the Special Registration Plate Account and \$20 to the Collegiate and Cultural Attraction Plate Account (CCAPA). Amends GS 20-81.12 to direct the Division of Motor Vehicles to make a quarterly transfer of the money in the CCAPA earned from the sale of the (1) ARTS plate to ARTS North Carolina, Inc.; (2) Camp plate to the Daniel Boone Council of the Boy Scouts of America; (3) Sea Trail plate to the Friends of the Mountains-to-Sea Trail, Inc.; and (4) Trout plate to the North Carolina Wildlife Resources Commission. Provides that the development of each of the plates is contingent on each plate receiving at least 300 plate applications. Amends GS 20-63(b) to include the plates in those that are not required to be "First in Flight" plates.

Amends the title to *AN ACT TO ALLOW THE USE OF FEES COLLECTED FROM THE FRIENDS OF THE GREAT SMOKY MOUNTAIN NATIONAL PARK SPECIAL STATE ATTRACTION PLATE TO BE USED FOR ORDINARY ADMINISTRATIVE AND OPERATING EXPENSES AND TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE VARIOUS SPECIAL PLATES ON A BACKGROUND OTHER THAN 'FIRST IN FLIGHT.'*
