S 595. THE TERRI SCHIAVO ACT. Filed 3/12/09. *TO REQUEST THAT THE LEGISLATIVE RESEARCH COMMISSION STUDY THE ISSUE OF INTEGRATING A LIVING WILL, OR OTHER ADVANCED HEALTH CARE DIRECTIVE, WITH THE DRIVERS LICENSE PROCESS, SIMILAR TO ORGAN DONATION, WITH A STANDARDIZED LIVING WILL OR OTHER HEALTH CARE DIRECTIVE.*

As title indicates. Directs that the Legislative Research Commission's report be available at least 10 days before the 2010 Regular Session of the General Assembly.

S 595. ADVANCED DIRECTIVES ON DRIVERS LICENSE (NEW). Filed 3/12/09. Senate committee substitute makes the following changes to 1st edition. Deletes all provisions of the previous edition and replaces it with *AN ACT TO PROVIDE LOVED ONES WITH CLEAR CERTAINTY OF A LOVED ONE'S END OF LIFE DECISIONS BY NOTATING LIVING WILL DECISIONS ON DRIVER'S LICENSE.* Amends GS 20-7 to the direct Division of Motor Vehicles to include, in appropriate cases, a notation on a driver's license indicating that the licensee has a living will on file with the Secretary of State. Effective October 1, 2009, for licenses issued on or after that date.

May 14, 2009

S 595. ADVANCED DIRECTIVES ON DRIVERS LICENSE. Filed 3/12/09. Senate amendment makes the following changes to 2nd edition. Changes the title to *AN ACT TO PROVIDE A NOTATION ON A DRIVERS LICENSE OR SPECIAL IDENTIFICATION CARD THAT AN APPLICANT IS AN ORGAN DONOR OR HAS A LIVING WILL.* Amends GS 20-7(n) to require that a driver's license issued by the Division of Motor Vehicles must include an organ donation symbol pursuant to GS 20-7.3 (regarding the availability of organ, eye, and tissue donor cards at motor vehicle offices).

June 4, 2009

S 595. ADVANCED DIRECTIVES ON DRIVERS LICENSE. Filed 3/12/09. House committee substitute makes the following changes to 3rd edition. Changes the effective date from October 1, 2009, to October 1, 2010 and makes a technical correction.

June 15, 2010

S 595. PEDESTRIAN SAFETY IMPROVEMENTS (NEW). Filed 3/12/09. House committee substitute deletes the provisions of the 4th edition and replaces it with *AN ACT TO REQUIRE THE DEPARTMENT OF TRANSPORTATION TO ACCEPT AND USE MUNICIPAL FUNDING FOR PEDESTRIAN SAFETY IMPROVEMENTS ON STATE ROADS WITHIN MUNICIPAL LIMITS.* Amends GS 136-66.3 to require the Department of Transportation (DOT) to accept and use municipal funding for a pedestrian safety improvement project on a state road within the municipality's limits if (1) the municipality funds 100% of the project and (2) DOT retains the right to approve the design and oversee construction, erection, or installation of the project.
