S 689. MODIFY DPI/SBE/REPORTING REQUIREMENTS. Filed 3/19/09. TO MODIFY THE REPORTING REQUIREMENTS FOR THE DEPARTMENT OF PUBLIC INSTRUCTION AND THE STATE BOARD OF EDUCATION.

Repeals provision in 2007 Appropriations Act regarding use of teacher funds for full-time mentors and amends provision in 2008 Appropriations Act to require the State Board of Education to report to the Joint Legislative Education Oversight Committee by January 15 of each year on use of funds for mentoring services. Repeals provision in 2004 Appropriations Act regarding high school workforce development program. Amends GS 115C-238.55 regarding annual reports on cooperative innovative high school programs to require reports on January 15 (was, October 15) of each year. Amends GS 115C-12 to specify that annual reports on school violence and on dropout rates, suspensions, expulsions, and alternative placements must be made by March 15 of each year. Repeals provision in 2003 Budget Act regarding evaluation of initiatives to assist high-priority schools.

S 689. MODIFY DPI REPTG. REQTS./BLDG. CODE/HIGH SC. (NEW). Filed 3/19/09. House committee substitute makes the following changes to 1st edition. Amends GS 116-43.15 to provide that the *existing* facilities of any constituent institution of the University of North Carolina (UNC) and the *existing* facilities of any private college or university licensed in accordance with GS 116-15 that comply with the State Building Code and applicable local ordinances (was, applicable state, county, and local fire codes) for those facilities may be used without modification for public school students in joint or cooperative programs such as middle or early college programs and dual enrollment programs. Allows designs for new facilities for UNC or such private colleges and universities that comply with the State Building Code and applicable local ordinances to also be used without modification for public school students in joint or cooperative programs. Requires that these programs be considered 'Business – Group B' in the same manner as other college and university uses for the purpose of establishing Use and Occupancy Classifications.

Makes conforming change to the title.
