	the two available tracks, abstinence until marriage and abstinence-base
	comprehensive sexuality health education, and explain that a parent of
	guardian may chose to have his or her child not enroll in either track, and (ii
	ask that each parent or guardian select a track for his or her child and retur
	the signed consent form to the school. The consent form shall contain
	statement in bold print that if the signed form is not returned to the school
