- "(a2) Motorcycle Learner's Permit. The following persons are eligible for a motorcycle learner's permit:
 - (1) A person who is at least 16 years old but less than 18 years old and has a full provisional license issued by the Division.
 - A person who is at least 18 years old and has a license issued by the (2) Division.

To obtain a motorcycle learner's permit, an applicant shall pass a vision test, a road sign test, and a written test specified by the Division. An applicant who is less than 18 years old shall successfully complete the Motorcycle Safety Foundation Basic Rider Course or the North Carolina Motorcycle Safety Education Program Basic Rider Course. A motorcycle learner's permit expires 18 months twelve months after it is issued. issued and may be renewed for one additional six-month period. The holder of a motorcycle learner's permit may not drive a motorcycle with a passenger. The fee for a motorcycle learner's permit is the amount set in G.S. 20-7(1) for a learner's permit."";
