A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE VARIOUS
SPECIAL REGISTRATION PLATES.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

...

(10b) Armed Forces Expeditionary Medal Recipient. – Issuable to a recipient of the Armed Forces Expeditionary Medal. The plate shall bear the phrase "Armed Forces Expeditionary Medal" and a representation of the Armed Forces Expeditionary Medal. The Division may not issue the plate authorized by this subdivision unless it receives at least 300 applications for the plate.

...

(14d) Boy Scouts of America. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase "Boy Scouts of America" and an emblem representing the Boy Scouts of America.

...

(14a)(14f) Brain Injury Awareness. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase "Brain Injury Awareness" and the logo of the nonprofit group Brain Injury Association of North Carolina, Inc.

(18b) Carolinas Golf Association. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.81. The plate shall bear the phrase "Carolinas Golf Association" and an emblem of the Carolinas Golf Association.

(34c) Daniel Stowe Botanical Garden. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase "Daniel Stowe Botanical Garden" with a logo designed by the Daniel Stowe Botanical Garden Foundation, Inc.

45 members of the same municipality. The number of a municipality shall be
46 the order of the municipality in an alphabetical list of municipalities that
47 assigns number one to the first municipality in the list. The Division may not
48 issue the plate authorized by this subdivision unless it receives at least 300
49 applications for the plate.

2 accordance with G.S. 20-81.12. The plate shall bear the phrase "NC Horse
3 Council" and a logo designed by the North Carolina Horse Council, Inc.

6 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase
7 "Play Tennis" and the image of an implement of the tennis sport.

- 9 (86c) NC Wildlife Federation. – Issuable in the registered owner of a motor
10 vehicle in accordance with G.S. 20-81.12. The plate shall bear a logo
11 designed by the North Carolina Wildlife Federation, Inc.

14 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
15 letters "MG" with a logo representing the North Carolina Master Gardeners.

- 17 (95b) P.E.O. Sisterhood. – Issuable to the registered owner of a motor vehicle in
18 accordance with G.S. 20-81.12. The plate shall bear the phrase "P.E.O." and
19 a logo designed by P.E.O. International.

- 21 (96c) Phi Beta Sigma Fraternity. – Issuable to the registered owner of a motor
22 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase

- 26 (108c) School Board. – Issuable to a school board member in this State. The plate
27 shall bear the words "School Board" followed first by a number representing

30 the order of the school board in an alphabetical list of school boards that
31 assigns number one to the first school board in the list. The Division may not
32 issue the plate authorized by this subdivision unless it receives at least 300
33 applications for the plate.

SECTION 2. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of a Legion of Valor award, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Legion of Valor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

9 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

10 "(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate
11 and Cultural Attraction Plate Account are established within the Highway Fund. The Division
12 must credit the additional fee imposed for the special registration plates listed in subsection (a)
13 among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction
14 Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under
15 G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under
16 G.S. 113-44.15, as follows:

SECTION 4 G.S. 20-81.12(b2) reads as rewritten:

"(b2) State Attraction Plates. – The Division must receive 300 or more applications for a State attraction plate before the plate may be developed. The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of State attraction plates to the organizations named below in proportion to the number of State attraction plates sold representing that organization:

(1) Blue Ridge Parkway Foundation. – The revenue derived from the special plate shall be transferred quarterly to Blue Ridge Parkway Foundation for use in promoting and preserving the Blue Ridge Parkway as a scenic attraction in North Carolina. A person may obtain from the Division a special registration plate under this subdivision for the registered owner of a motor vehicle or a motorcycle. The registration fees and the restrictions on the issuance of a specialized registration plate for a motorcycle are the same as for any motor vehicle. The Division must receive a minimum of 300 applications to develop a special registration plate for a motorcycle.

~~(4e)~~(3) Friends of the Great Smoky Mountains National Park. – The revenue derived from the special plate shall be transferred quarterly to the Friends of the Great Smoky Mountains National Park, Inc., to be used for educational materials, preservation programs, capital improvements for the portion of the Great Smoky Mountains National Park that is located in North Carolina, and operating expenses of the Great Smoky Mountains National Park.

~~(4g)~~(5) Friends of the Appalachian Trail. – The revenue derived from the special plate shall be transferred quarterly to The Appalachian Trail Conference to be used for educational materials, preservation programs, trail maintenance, trailway and viewshed acquisitions, trailway and viewshed easement acquisitions, capital improvements for the portions of the Appalachian Trail and connecting trails that are located in North Carolina, and related administrative and operating expenses.

~~(4i)~~(7) North Carolina State Parks. – One-half of the revenue derived from the special plate shall be transferred quarterly to Natural Heritage Trust Fund established under G.S. 113-77.7, and the remaining revenue shall be transferred quarterly to the Parks and Recreation Trust Fund established under G.S. 113-44.15.

1 (9) "Old Baldy," Bald Head Island Lighthouse. – The revenue derived from the
2 special plate shall be transferred quarterly to the Old Baldy Foundation, Inc.,
3 for its programs in support of the Bald Head Island Lighthouse.

5 plate shall be transferred quarterly to the North Carolina Aquarium Society,
6 Inc., for its programs in support of the North Carolina Aquariums.

8 plate shall be transferred quarterly to The North Carolina Arboretum Society
9 and used to help the Society obtain grants for the North Carolina Arboretum

12 special plate shall be transferred quarterly to Friends of the Museum, North

26 "(b73) Daniel Stowe Botanical Garden. – The Division must receive 300 or more
27 applications for the Daniel Stowe Botanical Garden plate before the plate may be developed.
28 The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate
29 Account derived from the sale of Daniel Stowe Botanical Garden plates to the Daniel Stowe
30 Botanical Garden Foundation, Inc., to provide funding for the Daniel Stowe Botanical Garden
31 outreach program.

32 (b74) NC Wildlife Federation. – The Division must receive 300 or more applications for
33 the NC Wildlife Federation plate before the plate may be developed. The Division shall transfer
34 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
35 sale of NC Wildlife Federation plates to the North Carolina Wildlife Federation, Inc., to
36 provide funding for a grassroots program to involve anglers, hunters, and wildlife enthusiasts in
37 conservation issues affecting North Carolina.

38 (b75) North Carolina Master Gardener. – The Division must receive 300 or more
39 applications for the North Carolina Master Gardener plate before the plate may be developed.
40 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
41 Account derived from the sale of North Carolina Master Gardener plates to the Master
42 Gardener's Endowment fund maintained by the Agricultural Foundation of North Carolina
43 State University, to be used for educational programs by trained volunteers who work in
44 partnership with their county Cooperative Extension offices to extend information in consumer
45 horticulture.

46 (b76) Support NC Education. – The Division must receive 300 or more applications for
47 the Support NC Education plate before the plate may be developed. The Division shall transfer
48 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
49 sale of Support NC Education plates to the Board of Governors of The University of North
50 Carolina to be used to provide scholarship funding at the 16 constituent universities of The
51 University of North Carolina.

1 **(b77) Phi Beta Sigma Fraternity.** – The Division must receive 300 or more applications for
2 the Phi Beta Sigma Fraternity plate before the plate may be developed. The Division shall
3 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
4 from the sale of Phi Beta Sigma Fraternity plates to the Phi Beta Sigma Fraternity, Inc., to
5 provide funding for scholarships, education and professional development, or similar programs.
6 None of the proceeds from this special plate may be distributed to any board member as
7 compensation or as an honorarium.

8 **(b78) Travel and Tourism.** – The Division must receive 300 or more applications for the
9 Travel and Tourism plate before the plate may be developed. The Division shall transfer
10 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
11 sale of Travel and Tourism plates to the Division of Tourism, Film, and Sports Development to
12 be used for programs in support of travel and tourism in North Carolina.

13 **(b79) Home of American Golf.** – The Division must receive 300 or more applications for
14 the Home of American Golf plate before the plate may be developed. The Division must
15 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
16 from the sale of Home of American Golf plates to the Given Memorial Library, Inc., to provide
17 funding for the Given Memorial Library – The Tufts Archives.

18 **(b80) Carolinas Golf Association.** – The Division must receive 300 or more applications
19 for the Carolinas Golf Association plate before the plate may be developed. The Division shall
20 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
21 from the sale of Carolinas Golf Association plates to the Carolinas Golf Association to be used
22 to promote amateur golf in North Carolina.

23 **(b81) NC Horse Council.** – The Division must receive 300 or more applications for the
24 NC Horse Council plate before the plate may be developed. The Division shall transfer
25 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
26 sale of NC Horse Council plates to the North Carolina Horse Council, Inc., to promote and
27 enhance the equine industry in North Carolina.

28 **(b82) Support Soccer.** – The Division must receive 300 or more applications for the
29 Support Soccer plate before the plate may be developed. The Division shall transfer quarterly
30 the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of
31 Support Soccer plates to the North Carolina Soccer Hall of Fame, Inc., to provide funding to
32 promote the sport of soccer in North Carolina.

33 **(b83) Jaycees.** – The Division must receive 300 or more applications for the Jaycees plate
34 before the plate may be developed. The Division shall transfer quarterly the money in the
35 Collegiate and Cultural Attraction Plate Account derived from the sale of Jaycees plates to the
36 North Carolina JCI Senate, Inc., to be used to support and underwrite Jaycee activities in North
37 Carolina.

38 **(b84) First in Turf.** – The Division must receive 300 or more applications for the First in
39 Turf plate before the plate may be developed. The Division shall transfer quarterly the money
40 in the Collegiate and Cultural Attraction Plate Account derived from the sale of First in Turf
41 plates to the Center for Environmental Turfgrass Research at North Carolina State University
42 for its programs.

43 **(b85) Boy Scouts of America.** – The Division must receive 300 or more applications for
44 the Boy Scouts of America plate before the plate may be developed. The Division shall transfer
45 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
46 sale of Boy Scouts of America plates to the Old Hickory Council of the Boy Scouts of
47 America, where the proceeds will be divided equally among the Boy Scouts of America
48 Councils in this State to be used for educational programs, preservation programs, capital
49 improvements on facilities located in this State, and related administrative and operating
50 expenses.

1 (b86) Girl Scouts. – The Division must receive 300 or more applications for the Girl
2 Scouts plate before the plate may be developed. The Division shall transfer quarterly the money
3 in the Collegiate and Cultural Attraction Plate Account derived from the sale of Girl Scouts
4 plates to the Girl Scouts North Carolina Coastal Pines, where the proceeds will be divided
5 equally among the officially chartered Girl Scout Councils in this State to be used for
6 educational programs, preservation programs, capital improvements on facilities located in this
7 State, and related administrative and operating expenses.

8 (b87) S.T.A.R. – The Division must receive 300 or more applications for the S.T.A.R.
9 plate before the plate may be developed. The Division shall transfer quarterly the money in the
10 Collegiate and Cultural Attraction Plate Account derived from the sale of S.T.A.R. plates to
11 Save the Animals Rescue, Inc., to provide funding to rescue distressed horses.

12 (b88) P.E.O. Sisterhood. – The Division must receive 300 or more applications for the
13 P.E.O. Sisterhood plate before the plate may be developed. The Division shall transfer
14 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
15 sale of P.E.O. Sisterhood plates to P.E.O. International to be used for scholarships for young
16 women."
