"'(b89) Retired Piedmont Airlines Employee. – The Division must receive 300 or more applications for a Retired Piedmont Airlines Employee plate before the plate may be developed. The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of Retired Piedmont Airlines Employee plates to Piedmont Silver Eagles Charitable Funds, Inc., to be used for scholarships and family assistance for retired Piedmont Airlines employees and their families, including surviving spouses and dependents, suffering economic hardship.'

SECTION 6. G.S. 20-79.4(130) reads as rewritten:

'(130) U.S. Navy Specialty-Submarine Veteran. – Issuable to a veteran of the United States Navy Submarine Service. The plate shall bear the phrase "Silent Service United States Navy Submarine Veteran" and shall bear a representation of the Submarine Service Qualification pin-insignia overlaid upon a representation of the State of North Carolina.
