1 moves to amend the bill on page 3, between lines 20 and 21, by inserting:

4 (105a) Retired Piedmont Airlines Employee. – This plate is issuable to a retired  
5 Piedmont Airlines employee presenting to the Division, along with the  
6 application for the plate, a copy of the employee's letter of retirement. The  
7 plate authorized by this subdivision shall bear the phrase "PA" and the  
8 Piedmont Speed Bird logo."

10 and further moves to amend the bill, on page 5, between lines 33 and 34 by inserting:

20 "(b89) Retired Piedmont Airlines Employee. – The Division must receive 300 or more  
21 applications for a Retired Piedmont Airlines Employee plate before the plate may be  
22 developed. The Division must transfer quarterly the money in the Collegiate and Cultural  
23 Attraction Plate Account derived from the sale of Retired Piedmont Airlines Employee plates  
24 to Piedmont Silver Eagles Charitable Funds, Inc., to be used for scholarships and family  
25 assistance for retired Piedmont Airlines employees and their families, including surviving  
26 spouses and dependents, suffering economic hardship.'

27 SECTION 6. G.S. 20-79.4(130) reads as rewritten:

28 (130) U.S. Navy Specialty-Submarine Veteran. – Issuable to a veteran of the  
29 United States Navy Submariner-Submarine Service. The plate shall bear the  
30 phrase "Silent Service United States Navy Submarine Veteran" and shall bear  
31 a representation of the Submarine Service Qualification pin-insignia overlaid  
32 upon a representation of the State of North Carolina. The Division may not
