18 disabilities who are not currently being served through the CAP-MR/DD waiver to determine
19 (i) if those individuals could be better served through the CAP-MR/DD Tier 1 waiver , and (ii)
20 if the State appropriations currently funding services for those individuals would be sufficient
21 to provide the non-federal match for those individuals if they became eligible for the CAP-
22 MR/DD Tier 1 waiver. The Division shall report its findings by March 1, 2010 to the Joint
23 Legislative Oversight Committee on Mental Health, Developmental Disabilities, and Substance
24 Abuse Services, the House of Representative Appropriations Subcommittee on Health and
25 Human Services, the Senate Appropriations Committee on Health and Human Services, and the
26 Fiscal Research Division."
