5	The General Assembly of North Carolina enacts:			
6	<b>SECTION 1.</b> G.S. 105-113.4 reads as rewritten:			
7	"§ 105-113.4. Definitions.			
8		g definitions apply in this Article:		
9	(1)	Cigar A roll of tobacco wrapped in a substance that contains tobacco,		
10		other than a cigarette.		
11	(1a)	Cigarette. – Any of the following:		
12		a. A roll of tobacco wrapped in paper or in a substance that does not		
13		contain tobacco.		
14		b. A roll of tobacco wrapped in a substance that contains tobacco and		
15		that, because of its appearance, the type of tobacco used in the filler,		
16 17		or its packaging and labeling, is likely to be offered to or purchased		
17		by a consumer as a cigarette described in subpart a. of this subdivision.		
18 19	(2)	Cost price. – The price a person liable for the tax on tobacco products		
20	(2)	imposed by Part 3 of this Article paid for the products, before any discount,		
20		rebate, or allowance or the tax imposed by that Part.		
22	(3)	Distributor. – Either of the following:		
23		a. A person, wherever resident or located, who purchases non-tax-paid		
24		cigarettes directly from the manufacturer of the cigarettes and stores,		
25		sells, or otherwise disposes of the cigarettes.		
26		b. A person who manufactures or produces cigarettes or causes them to		
27		be manufactured or produced manufacturer of cigarettes.		
28	(4)	Repealed by Session Laws 1991, c. 689, s. 267.		
29	(4a)	Integrated wholesale dealer A wholesale dealer who is an affiliate of a		
30		manufacturer of tobacco products, other than cigarettes, is the only person to		
31		whom the manufacturer sells its products, and is not a retail dealer. An		
32		"affiliate" is a person who directly or indirectly controls, is controlled by, or		
33		is under common control with another person.		
34	(5)	Licensed distributor A distributor licensed under Part 2 of this Article.

4	(7)	Package The individual packet, can, box, or other container used to

9	(10)	Sale. – A transfer, a trade, an exchange, or a barter, in any manner or by any	
10		means, with or without consideration.	
11	(10a)	Secretary. – The Secretary of Revenue.

13	(11a)	Tobacco product. – A cigarette, a cigar, or any other product that contains	
14		tobacco and is intended for inhalation or oral use.	
15	(12)	Repealed by Session Laws 1993, c. 442, s. 1, effective January 1, 1994.	
16	(13)	Use The exercise of any right or power over cigarettes, incident to the	
17		ownership or possession thereof, other than the making of a sale thereof in	
18		the course of engaging in a business of selling cigarettes. The term includes	
19		the keeping or retention of cigarettes for use.	
20	(14)	Wholesale dealer A Either of the following:	
21		<u>a.</u> <u>A person who makes tobacco products other than cigarettes or who</u>	
22		acquires tobacco products other than cigarettes for sale to another	
23		wholesale dealer or to a retail dealer.	
24		b. A manufacturer of tobacco products other than cigarettes."
