1 moves to amend the bill on page 49, lines 11-18,
2 by rewriting those lines to read:

3 **"REPEAL IN-STATE TUITION FOR NONRESIDENTS WHO RECEIVE FULL**
4 **SCHOLARSHIPS**

5 **SECTION 9.25.** G.S. 116-143.6 is repealed."; and

7 Further moves to amend the bill on page 49, line 51, by adding at the end of that line a new
8 section to read:

9 **"REPEAL OF NONRESIDENT FULL SCHOLARSHIP TUITION WAIVER**

10 **SECTION 9.27.** Notwithstanding any other provisions of this act, the management
11 flexibility reduction in this act for the operating budget of The University of North Carolina for
12 the 2010-2011 fiscal year is increased by the sum of six million fifty-five thousand two
13 hundred forty-five dollars (\$6,055,245) in recurring funds."; and

15 Further moves to amend the bill on page 35, line 34, by adding at the end of that line a new
16 section to read:

17 **"CAREER AND TECHNICAL EDUCATION SUPPORT**

18 **SECTION 7.27.** Notwithstanding any other provisions of this act, the funding for
19 the Career and Technical Education (CTE) programs in the Department of Public Instruction is
20 increased by the sum of six million fifty-five thousand two hundred forty-five dollars
21 (\$6,055,245) in recurring funds, thus eliminating the budget reduction and thereby expanding
22 the allotment for the CTE programs by four million fifty-five thousand two hundred forty-five
23 dollars (\$4,055,245). The increased funding under this section shall be used to assist LEAs in
24 expanding, improving, modernizing, and developing quality Career and Technical Education
25 education programs."; and

27 By adjusting the appropriate totals accordingly.
