1 moves to amend the bill on page 2, line 31, by increasing the reduction on that line by  
2 \$8,000,000;

4 On page 2, line 8, by decreasing the reduction on that line by \$8,000,000; and by adjusting the  
5 appropriate totals accordingly;

7 On page 49, line 51, by adding a new provision at the end of that line to read:  
8 "**DISTINGUISHED PROFESSOR ENDOWMENT TRUST FUND /SUSPEND**  
9 **PAYMENTS FOR FISCAL YEAR**

10 **SECTION 9.27.(a)** Section 9.16 of S.L. 2009-451 reads as rewritten:  
11 **SECTION 9.16.** Notwithstanding Part 4A of Article 1 of Chapter 116 of the  
12 General Statutes, of the funds appropriated by this act to the Board of Governors of The  
13 University of North Carolina and allocated to the Distinguished Professors Endowment Trust  
14 Fund established in G.S. 116-41.14, the sum of eight million dollars (\$8,000,000) for the  
15 2009-2010 fiscal year ~~and the sum of eight million dollars (\$8,000,000) for the 2010-2011~~  
16 ~~fiscal year~~ shall first be used to match the grant from the C.D. Spangler Foundation. The  
17 balance of funds remaining from ~~each~~ the appropriation of eight million dollars (\$8,000,000), if  
18 any, after matching the grant from the C.D. Spangler Foundation, shall be used to address the  
19 backlog of professorships awaiting State matching funds.'

20 **SECTION 9.27.(b)** Notwithstanding, Part 4A of Article 1 of Chapter 116 of the  
21 General Statutes, no State matching funds shall be paid to match private funds or contributions  
22 to support or implement a distinguished professorship for the 2010-2011 fiscal year. The Board  
23 of Governors shall administer the Distinguished Professors Endowment Trust Fund to yield  
24 eight million dollars (\$8,000,000) in savings for the 2010-2011 fiscal year.";

26 On page 28, line 49, by deleting "**SECTION 7.13.**" and substituting "**SECTION 7.13.(a)**";

27  
28 On page 29, line 36, by adding a new subsection to read:  
29 "**SECTION 7.13.(b)** The LEA adjustment established in S.L. 2009-451 is reduced  
30 by eight million dollars (\$8,000,000) for the 2010-2011 fiscal year.";
