1 A BILL TO BE ENTITLED
2 AN ACT TO ALLOW PROBATION OFFICERS TO ACCESS OFFENDERS' JUVENILE
3 RECORDS, TO MAKE WARRANTLESS SEARCHES AND DRUG SCREENING
4 REGULAR CONDITIONS OF SUPERVISION, TO ADD ADDITIONAL
5 CONTROLLING MEASURES FOR OFFENDERS SUBJECT TO INTERMEDIATE
6 PUNISHMENT, AND TO MAKE CLARIFYING AMENDMENTS TO STREAMLINE
7 PROCEDURES FOR SUPERVISION OF OFFENDERS IN THE COMMUNITY.

8 The General Assembly of North Carolina enacts:

9 **SECTION 1.** G.S. 7B-3000 reads as rewritten:

10 **"§ 7B-3000. Juvenile court records.**

11 (a) The clerk shall maintain a complete record of all juvenile cases filed in the clerk's
12 office to be known as the juvenile record. The record shall include the summons and petition,
13 any secure or nonsecure custody order, any electronic or mechanical recording of hearings, and
14 any written motions, orders, or papers filed in the proceeding.

15 (b) All juvenile records shall be withheld from public inspection and, except as
16 provided in this subsection, may be examined only by order of the court. Except as provided in
17 subsection (c) of this section, the following persons may examine the juvenile's record and
18 obtain copies of written parts of the record without an order of the court:

19 (1) The juvenile;

20 (2) The juvenile's parent, guardian, or custodian, or the authorized representative
21 of the juvenile's parent, guardian, or custodian;

22 (3) The prosecutor; ~~and~~

23 (4) ~~Court eounselors;counselors;~~ and

24 (5) Probation officers in the Division of Community Corrections of the
25 Department of Correction, as provided in subsection (e1) of this section and
26 in G.S. 15A-1341(e).

27 Except as provided in subsection (c) of this section, the prosecutor may, in the prosecutor's
28 discretion, share information obtained from a juvenile's record with law enforcement officers
29 sworn in this State, but may not allow a law enforcement officer to photocopy any part of the
30 record.

31 (c) The court may direct the clerk to "seal" any portion of a juvenile's record. The clerk
32 shall secure any sealed portion of a juvenile's record in an envelope clearly marked "SEALED:
33 MAY BE EXAMINED ONLY BY ORDER OF THE COURT", or with similar notice, and

1 shall permit examination or copying of sealed portions of a juvenile's record only pursuant to a
2 court order specifically authorizing inspection or copying.

3 (d) Any portion of a juvenile's record consisting of an electronic or mechanical
4 recording of a hearing shall be transcribed only when notice of appeal has been timely given
5 and shall be copied electronically or mechanically, only by order of the court. After the time for
6 appeal has expired with no appeal having been filed, the court may enter a written order
7 directing the clerk to destroy the recording of the hearing.

8 (e) The juvenile's record of an adjudication of delinquency for an offense that would be
9 a felony if committed by an adult may be used by law enforcement, the magistrate, and the
10 prosecutor for pretrial release and plea negotiating decisions.

11 (e1) During any time in which a person is subject to probation supervision under Article
12 82 of Chapter 15A of the General Statutes, that person's juvenile record may be examined
13 without a court order by the probation officer in the Division of Community Corrections
14 assigned to supervise the person.

15 (f) The juvenile's record of an adjudication of delinquency for an offense that would be
16 a Class A, B1, B2, C, D, or E felony if committed by an adult may be used in a subsequent
17 criminal proceeding against the juvenile either under G.S. 8C-1, Rule 404(b), or to prove an
18 aggravating factor at sentencing under G.S. 15A-1340.4(a), 15A-1340.16(d), or 15A-2000(e).
19 The record may be so used only by order of the court in the subsequent criminal proceeding,
20 upon motion of the prosecutor, after an in camera hearing to determine whether the record in
21 question is admissible.

22 (g) Except as provided in subsection (d) of this section, a juvenile's record shall be
23 destroyed only as authorized by G.S. 7B-3200 or by rules adopted by the Administrative Office
24 of the Courts."

25 **SECTION 2.** G.S. 7B-3100(a) reads as rewritten:

26 "(a) The Department, after consultation with the Conference of Chief District Court
27 Judges, shall adopt rules designating certain local agencies that are authorized to share
28 information concerning juveniles in accordance with the provisions of this section. Agencies so
29 designated shall share with one another, upon request and to the extent permitted by federal law
30 and regulations, information that is in their possession that is relevant to any assessment of a
31 report of child abuse, neglect, or dependency or the provision or arrangement of protective
32 services in a child abuse, neglect, or dependency case by a local department of social services
33 pursuant to the authority granted under Chapter 7B of the General Statutes or to any case in
34 which a petition is filed alleging that a juvenile is abused, neglected, dependent, undisciplined,
35 or delinquent and shall continue to do so until the protective services case is closed by the local
36 department of social services, or if a petition is filed when the juvenile is no longer subject to
37 the jurisdiction of juvenile court. Agencies that may be designated as "agencies authorized to
38 share information" include local mental health facilities, local health departments, local
39 departments of social services, local law enforcement agencies, local school administrative
40 units, the district's district attorney's office, the Department of Juvenile Justice and Delinquency
41 Prevention, and the Office of Guardian ad Litem Services of the Administrative Office of the
42 Courts. Courts, and the Division of Community Corrections of the Department of Correction.
43 Any information shared among agencies pursuant to this section shall remain confidential, shall
44 be withheld from public inspection, and shall be used only for the protection of the juvenile and
45 others or to improve the educational opportunities of the juvenile, and shall be released in
46 accordance with the provisions of the Family Educational and Privacy Rights Act as set forth in
47 20 U.S.C. § 1232g. Nothing in this section or any other provision of law shall preclude any
48 other necessary sharing of information among agencies. Nothing herein shall be deemed to
49 require the disclosure or release of any information in the possession of a district attorney."

50 **SECTION 3.** G.S. 15A-1341 is amended by adding a new subsection to read:

1 "(e) Review of Defendant's Juvenile Record. – The probation officer assigned to the
2 defendant may examine the defendant's juvenile record in a manner consistent with
3 G.S. 7B-3000(e1)."

4 **SECTION 4.** G.S. 15A-1340.11 reads as rewritten:

5 "**§ 15A-1340.11. Definitions.**

6 The following definitions apply in this Article:

7 ...

8 (4a) House arrest with electronic monitoring. – Probation in which the offender is
9 required to remain at his or her residence unless the court or the probation
10 officer authorizes the offender to leave for the purpose of employment,
11 counseling, a course of study, or vocational training. The offender shall be
12 required to wear a device which permits the supervising agency to monitor
13 the offender's compliance with the ~~condition electronically.~~ condition.

14 (5) Intensive ~~probation supervision.~~ probation supervision. – Probation that requires the offender to
15 submit to ~~supervision by officers assigned to the Intensive Supervision~~
16 ~~Program established pursuant to G.S. 143B-262(c), and to comply with the~~
17 ~~rules adopted for that Program. Unless otherwise ordered by the court,~~
18 ~~intensive supervision also requires~~ rules adopted by the Division of
19 Community Corrections for intensive supervision, including, but not limited
20 to, multiple contacts by a probation officer per week, a specific period each
21 day during which the offender must be at his or her residence, and that the
22 offender remain gainfully and suitably employed or faithfully pursue
23 a course of study or of vocational training that will equip the offender for
24 suitable employment.

25 (6) Intermediate punishment. – A sentence in a criminal case that places an
26 offender on supervised probation and includes at least one of the following
27 conditions:

- 28 a. Special probation as defined in G.S. 15A-1351(a).
29 b. Assignment to a residential program.
30 c. House arrest with electronic monitoring.
31 d. Intensive ~~probation supervision.~~ probation supervision.
32 e. Assignment to a day-reporting center.
33 f. Assignment to a drug treatment court program.

34 "

35 **SECTION 5.** G.S. 143B-262(c) reads as rewritten:

36 "(c) The Division of Community Corrections of the Department shall establish within
37 the Division of Community Corrections a program of Intensive Supervision. This program shall
38 provide intensive supervision for probationers, post release supervisees, and parolees who
39 require close supervision in order to remain in the community pursuant to a community
40 penalties plan, community work plan, community restitution plan, or other plan of
41 rehabilitation. The intensive supervision program shall be available to both felons and
42 misdemeanants. Each offender shall be required to comply with the rules adopted for the
43 Program as well as rules for intensive supervision consistent with the requirements specified in
44 G.S. 15A-1340.11(5)."

45 **SECTION 6.** G.S. 153A-230.2(a) reads as rewritten:

46 "(a) There is created in the Office of State Budget and Management the County Satellite
47 Jail/Work Release Unit Fund to provide State grant funds for counties or groups of counties for
48 construction of satellite jail/work release units for certain misdemeanants who receive active
49 sentences. A county or group of counties may apply to the Office for a grant under this section.
50 The application shall be in a form established by the Office. The Office shall:

- 1 (1) Develop application and grant criteria based on the basic requirements listed
- 2 in this Part,
- 3 (2) Provide all Boards of County Commissioners and Sheriffs with the criteria
- 4 and appropriate application forms, technical assistance, if requested, and a
- 5 proposed written agreement,
- 6 (3) Review all applications,
- 7 (4) Select grantees and award grants,
- 8 (5) Award no more than seven hundred fifty thousand dollars (\$750,000) for any
- 9 one county or group of counties except that if a group of counties agrees to
- 10 jointly operate one unit for males and one unit for females, the maximum
- 11 amount may be awarded for each unit,
- 12 (6) Take into consideration the potential number of misdemeanants and the
- 13 percentage of the county's or counties' misdemeanor population to be
- 14 diverted from the State prison system,
- 15 (7) Take into consideration the utilization of existing buildings suitable for
- 16 renovation where appropriate,
- 17 (8) Take into consideration the timeliness with which a county proposes to
- 18 complete and occupy the unit,
- 19 (9) Take into consideration the appropriateness and cost effectiveness of the
- 20 proposal,
- 21 (10) Take into consideration the plan with which the county intends to coordinate
- 22 the unit with other community service programs such as intensive
- 23 ~~probation, supervision~~, community penalties, and community service.

24 When considering the items listed in subdivisions (6) through (10), the Office shall determine
25 the appropriate weight to be given each item."

26 **SECTION 7.** G.S. 164-42(a) reads as rewritten:

27 "(a) The Commission shall recommend structures for use by a sentencing court in
28 determining the most appropriate sentence to be imposed in a criminal case, including:

- 29 (1) Imposition of an active term of imprisonment;
- 30 (2) Imposition of a term of probation;
- 31 (3) Suspension of a sentence to imprisonment and imposition of probation with
- 32 conditions, including the appropriate probation option or options, including
- 33 house arrest, regular probation, intensive ~~probation, supervision~~, restitution,
- 34 and community service;
- 35 (4) Based upon the combination of offense and defendant characteristics in each
- 36 case, the presumptively appropriate length of a term of probation, or a term
- 37 of imprisonment;
- 38 (5) Ordering multiple sentences to terms of imprisonment to run concurrently or
- 39 consecutively;
- 40 (6) For a sentence to probation without a suspended sentence to imprisonment,
- 41 the maximum term of confinement to be imposed if the defendant violates
- 42 the conditions of probation."

43 **SECTION 8.(a)** G.S. 15A-1343(b) reads as rewritten:

44 "(b) Regular Conditions. – As regular conditions of probation, a defendant must:

- 45 (1) Commit no criminal offense in any jurisdiction.
- 46 (2) Remain within the jurisdiction of the court unless granted written permission
- 47 to leave by the court or his probation officer.
- 48 (3) Report as directed by the court or his probation officer to the officer at
- 49 reasonable times and places and in a reasonable manner, permit the officer to
- 50 visit him at reasonable times, answer all reasonable inquiries by the officer

- 1 and obtain prior approval from the officer for, and notify the officer of, any
2 change in address or employment.
- 3 (4) Satisfy child support and other family obligations as required by the court. If
4 the court requires the payment of child support, the amount of the payments
5 shall be determined as provided in G.S. 50-13.4(c).
- 6 (5) Possess no firearm, explosive device or other deadly weapon listed in
7 G.S. 14-269 without the written permission of the court.
- 8 (6) Pay a supervision fee as specified in subsection (c1).
- 9 (7) Remain gainfully and suitably employed or faithfully pursue a course of
10 study or of vocational training that will equip him for suitable employment.
11 A defendant pursuing a course of study or of vocational training shall abide
12 by all of the rules of the institution providing the education or training, and
13 the probation officer shall forward a copy of the probation judgment to that
14 institution and request to be notified of any violations of institutional rules
15 by the defendant.
- 16 (8) Notify the probation officer if he fails to obtain or retain satisfactory
17 employment.
- 18 (9) Pay the costs of court, any fine ordered by the court, and make restitution or
19 reparation as provided in subsection (d).
- 20 (10) Pay the State of North Carolina for the costs of appointed counsel, public
21 defender, or appellate defender to represent him in the case(s) for which he
22 was placed on probation.
- 23 (11) At a time to be designated by his probation officer, visit with his probation
24 officer a facility maintained by the Division of Prisons.
- 25 (12) Attend and complete an abuser treatment program if (i) the court finds the
26 defendant is responsible for acts of domestic violence and (ii) there is a
27 program, approved by the Domestic Violence Commission, reasonably
28 available to the defendant, unless the court finds that such would not be in
29 the best interests of justice.
- 30 (13) Submit at reasonable times to warrantless searches by a probation officer of
31 the probationer's person and of the probationer's vehicle and premises while
32 the probationer is present, for purposes reasonably related to the probation
33 supervision, but the probationer may not be required to submit to any other
34 search that would otherwise be unlawful. Whenever the warrantless search
35 consists of testing for the presence of illegal drugs, the probationer may also
36 be required to reimburse the Department of Correction for the actual cost of
37 drug screening and drug testing, if the results are positive.
- 38 (14) Submit to warrantless searches by a law enforcement officer of the
39 probationer's person and of the probationer's vehicle, upon a reasonable
40 suspicion that the probationer is engaged in criminal activity or is in
41 possession of a firearm, explosive device, or other deadly weapon listed in
42 G.S. 14-269 without written permission of the court.

43 A defendant shall not pay costs associated with a substance abuse monitoring program or
44 any other special condition of probation in lieu of, or prior to, the payments required by this
45 subsection.

46 In addition to these regular conditions of probation, a defendant required to serve an active
47 term of imprisonment as a condition of special probation pursuant to G.S. 15A-1344(e) or
48 G.S. 15A-1351(a) shall, as additional regular conditions of probation, obey the rules and
49 regulations of the Department of Correction governing the conduct of inmates while
50 imprisoned and report to a probation officer in the State of North Carolina within 72 hours of
51 his discharge from the active term of imprisonment.

1 Regular conditions of probation apply to each defendant placed on supervised probation
2 unless the presiding judge specifically exempts the defendant from one or more of the
3 conditions in open court and in the judgment of the court. It is not necessary for the presiding
4 judge to state each regular condition of probation in open court, but the conditions must be set
5 forth in the judgment of the court.

6 Defendants placed on unsupervised probation are subject to the provisions of this
7 subsection, except that defendants placed on unsupervised probation are not subject to the
8 regular conditions contained in subdivisions (2), (3), (6), (8), ~~and (11), (13), and (14) of~~
9 this subsection."

10 **SECTION 8.(b)** G.S. 15A-1343(b1) reads as rewritten:

11 "(b1) Special Conditions. – In addition to the regular conditions of probation specified in
12 subsection (b), the court may, as a condition of probation, require that during the probation the
13 defendant comply with one or more of the following special conditions:

- 14 (1) Undergo available medical or psychiatric treatment and remain in a specified
15 institution if required for that purpose.
- 16 (2) Attend or reside in a facility providing rehabilitation, counseling, treatment,
17 social skills, or employment training, instruction, recreation, or residence for
18 persons on probation.
- 19 (2a) Repealed by Session Laws 2002, ch. 126, s. 17.18, effective August 15,
20 2002.
- 21 (2b) Participate in and successfully complete a Drug Treatment Court Program
22 pursuant to Article 62 of Chapter 7A of the General Statutes.
- 23 (3) Submit to imprisonment required for special probation under
24 G.S. 15A-1351(a) or G.S. 15A-1344(e).
- 25 (3a) Repealed by Session Laws 1997-57, s. 3.
- 26 (3b) Submit to intensive supervision ~~by officers assigned to the Intensive~~
27 ~~Supervision Program established pursuant to G.S. 143B-262(e), and abide by~~
28 ~~the rules adopted for that Program. by the Division of Community~~
29 ~~Corrections for that level of supervision. Unless otherwise ordered by the~~
30 ~~court, intensive supervision also requires multiple contacts by a probation~~
31 ~~officer per week, a specific period each day during which the offender must~~
32 ~~be at his or her residence, and that the offender remain gainfully and suitably~~
33 ~~employed or faithfully pursue a course of study or of vocational training that~~
34 ~~will equip the offender for suitable employment.~~
- 35 (3c) Remain at his or her residence unless the court or the probation officer
36 authorizes the offender to leave for the purpose of employment, counseling,
37 a course of study, or vocational training. The offender shall be required to
38 wear a device which permits the supervising agency to monitor the
39 offender's compliance with the condition electronically and to pay a fee for
40 the device as specified in subsection (c2) of this section.
- 41 (4) Surrender his or her driver's license to the clerk of superior court, and not
42 operate a motor vehicle for a period specified by the court.
- 43 (5) Compensate the Department of Environment and Natural Resources or the
44 North Carolina Wildlife Resources Commission, as the case may be, for the
45 replacement costs of any marine and estuarine resources or any wildlife
46 resources which were taken, injured, removed, harmfully altered, damaged
47 or destroyed as a result of a criminal offense of which the defendant was
48 convicted. If any investigation is required by officers or agents of the
49 Department of Environment and Natural Resources or the Wildlife
50 Resources Commission in determining the extent of the destruction of
51 resources involved, the court may include compensation of the agency for

1 investigative costs as a condition of probation. This subdivision does not
2 apply in any case governed by G.S. 143-215.3(a)(7).

3 (6) Perform community or reparation service under the supervision of the
4 Division of Community Corrections and pay ~~any the~~ fee required by ~~law or~~
5 ~~ordered by the court~~ for participation in the community or reparation service
6 ~~program.~~ G.S. 143B-262.

7 (7) ~~Submit at reasonable times to warrantless searches by a probation officer of~~
8 ~~his or her person and of his or her vehicle and premises while the~~
9 ~~probationer is present, for purposes specified by the court and reasonably~~
10 ~~related to his or her probation supervision, but the probationer may not be~~
11 ~~required to submit to any other search that would otherwise be unlawful.~~
12 ~~Whenever the warrantless search consists of testing for the presence of~~
13 ~~illegal drugs, the probationer may also be required to reimburse the~~
14 ~~Department of Correction for the actual cost of drug screening and drug~~
15 ~~testing, if the results are positive.~~

16 (8) Not use, possess, or control any illegal drug or controlled substance unless it
17 has been prescribed for him or her by a licensed physician and is in the
18 original container with the prescription number affixed on it; not knowingly
19 associate with any known or previously convicted users, possessors or
20 sellers of any such illegal drugs or controlled substances; and not knowingly
21 be present at or frequent any place where such illegal drugs or controlled
22 substances are sold, kept, or used.

23 (8a) Purchase the least expensive annual statewide license or combination of
24 licenses to hunt, trap, or fish listed in G.S. 113-270.2, 113-270.3, 113-270.5,
25 113-271, 113-272, and 113-272.2 that would be required to engage lawfully
26 in the specific activity or activities in which the defendant was engaged and
27 which constitute the basis of the offense or offenses of which he was
28 convicted.

29 (9) If the offense is one in which there is evidence of physical, mental or sexual
30 abuse of a minor, the court should encourage the minor and the minor's
31 parents or custodians to participate in rehabilitative treatment and may order
32 the defendant to pay the cost of such treatment.

33 (9a) Repealed by Session Laws 2004-186, s. 1.1, effective December 1, 2004,
34 and applicable to offenses committed on or after that date.

35 (10) Satisfy any other conditions determined by the court to be reasonably related
36 to his rehabilitation."

37 **SECTION 8.(c)** G.S. 15A-1343 is amended by adding a new subsection to read:

38 "(b4) Intermediate Conditions. – The following conditions of probation apply to each
39 defendant subject to intermediate punishment:

40 (1) If required in the discretion of the defendant's probation officer, perform
41 community service under the supervision of the Division of Community
42 Corrections and pay the fee required by G.S. 143B-262.

43 (2) Not use, possess, or control alcohol.

44 (3) Not use, possess, or control any illegal drug or controlled substance unless it
45 has been prescribed for him or her by a licensed physician and is in the
46 original container with the prescription number affixed on it; not knowingly
47 associate with any known or previously convicted users, possessors, or
48 sellers of any such illegal drugs or controlled substances; and not knowingly
49 be present at or frequent any place where such illegal drugs or controlled
50 substances are sold, kept, or used.

- 1 (4) Remain within the county of residence unless granted permission to leave by
2 the court or the defendant's probation officer.
3 (5) Participate in any evaluation, counseling, treatment, or educational program
4 as directed by the probation officer, keeping all appointments and abiding by
5 the rules, regulations, and direction of each program.

6 These conditions apply to each defendant subject to intermediate punishment unless the
7 court specifically exempts the defendant from one or more of the conditions in its judgment or
8 order. It is not necessary for the presiding judge to state each of these conditions in open court,
9 but the conditions must be set forth in the judgment or order of the court."

10 **SECTION 9.** G.S. 15A-1342 is amended by adding a new subsection to read:

11 "(a1) Supervision of Defendants on Deferred Prosecution. – The Division of Community
12 Corrections of the Department of Correction may be ordered by the court to supervise an
13 offender's compliance with the terms of a deferred prosecution agreement entered into under
14 G.S. 15A-1341(a1). Violations of the terms of the agreement shall be reported to the court as
15 provided in this Article and to the district attorney in the district in which the agreement was
16 entered."

17 **SECTION 10.(a)** G.S. 15A-1344(d) reads as rewritten:

18 "(d) Extension and Modification; Response to Violations. – At any time prior to the
19 expiration or termination of the probation period or in accordance with subsection (f) of this
20 section, the court may after notice and hearing and for good cause shown extend the period of
21 probation up to the maximum allowed under G.S. 15A-1342(a) and may modify the conditions
22 of probation. ~~The probation period shall be tolled if the probationer shall have pending against~~
23 ~~him criminal charges in any court of competent jurisdiction, which, upon conviction, could~~
24 ~~result in revocation proceedings against him for violation of the terms of this probation. The A~~
25 ~~hearing extending or modifying probation~~ may be held in the absence of the defendant, if he
26 fails to appear for the hearing after a reasonable effort to notify him. If a ~~convicted defendant~~
27 ~~probationer~~ violates a condition of probation at any time prior to the expiration or termination
28 of the period of probation, the court, in accordance with the provisions of G.S. 15A-1345, may
29 continue him on probation, with or without modifying the conditions, may place the defendant
30 on special probation as provided in subsection (e), or, if continuation, modification, or special
31 probation is not appropriate, may revoke the probation and activate the suspended sentence
32 imposed at the time of initial sentencing, if any, or may order that charges as to which
33 prosecution has been deferred be brought to trial; provided that probation may not be revoked
34 solely for conviction of a Class 3 misdemeanor. The court, before activating a sentence to
35 imprisonment established when the defendant was placed on probation, may reduce the
36 sentence, but the reduction shall be consistent with subsection (d1) of this section. A sentence
37 activated upon revocation of probation commences on the day probation is revoked and runs
38 concurrently with any other period of probation, parole, or imprisonment to which the
39 defendant is subject during that period unless the revoking judge specifies that it is to run
40 consecutively with the other period."

41 **SECTION 10.(b)** G.S. 15A-1344 is amended by adding a new subsection to read:

42 "(g) If there are pending criminal charges against the probationer in any court of
43 competent jurisdiction, which, upon conviction, could result in revocation proceedings against
44 the probationer for violation of the terms of this probation, the probation period shall be tolled
45 until all pending criminal charges are resolved. The probationer shall remain subject to the
46 conditions of probation, including supervision fees, during the tolled period. If the probationer
47 is acquitted or if the new charge is dismissed, the time spent on probation during the tolled
48 period shall be credited against the period of probation."

49 **SECTION 11.** G.S. 14-72.1(f) is repealed.

50 **SECTION 12.(a)** G.S. 15A-1371(h) reads as rewritten:

1 "(h) Community Service Parole. – Notwithstanding the provisions of any other
2 subsection herein, prisoners serving sentences for impaired driving shall be eligible for
3 community service parole, in the discretion of the Post-Release Supervision and Parole
4 Commission.

5 Community service parole is early parole for the purpose of participation in a program of
6 community service under the supervision of a ~~probation/parole officer~~. the Division of
7 Community Corrections. A parolee who is paroled under this subsection must perform as a
8 condition of parole community service in an amount and over a period of time to be determined
9 by the Post-Release Supervision and Parole Commission. However, the total amount of
10 community service shall not exceed an amount equal to 32 hours for each month of active
11 service remaining in his minimum sentence. The Post-Release Supervision and Parole
12 Commission may grant early parole under this section without requiring the performance of
13 community service if it determines that such performance is inappropriate to a particular case.

14 The ~~probation/parole officer and the community service~~ judicial services coordinator shall
15 develop a program of community service for the parolee. The ~~community service~~ coordinator
16 shall report any willful failure to perform community service work to the probation/parole
17 officer. Parole may be revoked for any parolee who willfully fails to perform community
18 service work as directed by a ~~community service coordinator~~. the Division of Community
19 Corrections. The provisions of G.S. 15A-1376 shall apply to this violation of a condition of
20 parole.

21 Community service parole eligibility shall be available to a prisoner:

- 22 (1) Who is serving an active sentence the term of which exceeds six months;
23 and
- 24 (2) Who, in the opinion of the Post-Release Supervision and Parole
25 Commission, is unlikely to engage in further criminal conduct; and
- 26 (3) Who agrees to complete service of his sentence as herein specified; and
- 27 (4) Who has served one-half of his minimum sentence.

28 In computing the service requirements of subdivision (4) of this subsection, credit shall be
29 given for good time and gain time credit earned pursuant to G.S. 148-13. Nothing herein is
30 intended to create or shall be construed to create a right or entitlement to community service
31 parole in any prisoner."

32 **SECTION 12.(b)** G.S. 15A-1371(i) reads as rewritten:

33 "~~(i) A The fee of two hundred dollars (\$200.00) required by G.S. 143B-262.4 shall be~~
34 ~~paid by all persons who participate in the Community Service Parole Program. That fee must~~
35 ~~be paid to the clerk of court in the county in which the parolee is released. The fee must be paid~~
36 ~~in full within two weeks unless the Post-Release Supervision and Parole Commission, upon a~~
37 ~~showing of hardship by the person, allows the person additional time to pay the fee. The~~
38 ~~parolee may not be required to pay the fee before the person begins the community service~~

45 ~~subsections (i), (j), or (k), the community service shall be completed:~~

- 46 ~~(1) Within 90 days, if the amount of community service required is 72 hours or~~
47 ~~more; or~~
- 48 ~~(2) Within 60 days, if the amount of community service required is 48 hours; or~~
- 49 ~~(3) Within 30 days, if the amount of community service required is 24 hours.~~

1 The court may extend these time limits upon motion of the defendant if it finds that the
2 defendant has made a good faith effort to comply with the time limits specified in this
3 subsection. service, a minimum of 24 hours must be ordered."

4 **SECTION 14.** G.S. 20-179.3 is amended by adding a new subsection to read:

5 "(j1) Effect of Violation of Community Service Requirement. – Division of Community
6 Corrections staff shall report significant violations of the terms of a probation judgment related
7 to community service to the court that ordered the community service. The court shall then
8 conduct a hearing to determine if there was a willful failure to comply. The hearing may be
9 held in the district where the requirement was imposed, where the alleged violation occurred, or
10 where the probationer resides. If the court determines that there was a willful failure to pay the
11 prescribed fee or to complete the work as ordered within the applicable time limits, the court
12 shall revoke any limited driving privilege issued in the impaired driving case until community
13 service requirements have been met. In addition, the court may take any further action
14 authorized by Article 82 of Chapter 15A of the General Statutes for violation of a condition of
15 probation."

16 **SECTION 15.** G.S. 20-179.4 is repealed.

17 **SECTION 16.** G.S. 143B-262.4 reads as rewritten:

19 **program. Community service program.**

20 (a) The Department of Correction may conduct a ~~deferred prosecution, community~~
21 ~~service restitution, and volunteer program for youthful and adult offenders. program.~~ The
22 program shall provide oversight of offenders placed under the supervision of the Division of
23 Community Corrections and ordered to perform community service hours for criminal
24 violations, including driving while impaired violations under G.S. 20-138.1. This program shall
25 assign offenders, either on supervised or on unsupervised probation, to perform service to the
26 local community in an effort to promote the offender's rehabilitation and to provide services
27 that help restore or improve the community. The program shall provide appropriate work site
28 placement for offenders ordered to perform community service hours. The Department may
29 adopt rules to conduct the program. Each offender shall be required to comply with the rules
30 adopted for the program.

33 compliance with the requirements of the program. ~~The appointment of each coordinator shall~~

36 convenient place, for the use of ~~each coordinator~~ the employees assigned to that county.

37 (b) ~~Unless a fee is assessed pursuant to G.S. 20-179.4 or G.S. 15A-1371(i), a~~ A fee of
38 two hundred dollars (\$200.00) shall be paid by all persons who participate in the program or
39 receive services from the program staff. Only one fee may be assessed for each sentencing
40 transaction, even if the person is assigned to the program on more than one occasion, or while
41 on deferred prosecution, or while serving a sentence for the offense. A sentencing transaction
42 shall include all offenses considered and adjudicated during the same term of court. Fees
43 collected pursuant to this subsection shall be deposited in the General Fund. If the person is

45 which the person is ~~convicted.~~ convicted, regardless of whether the person is participating in

49 shall be paid to the clerk of court in the county in which the agreement is filed. If the person is

51 county in which the person is released on parole. Persons participating in the program for any

1 other reason shall pay the fee to the clerk of court in the county in which the services are
2 provided by the program staff. The fee shall be paid in full ~~within two weeks from the date the~~
3 ~~person is ordered to perform the community service, and~~ before the person may participate in
4 the community service program, except that:

5 (1) A person convicted in a court in this State may be given an extension of time
6 or allowed to begin the community service before the person pays the fee by
7 the court in which the person is convicted; or

8 (2) A person performing community service pursuant to a deferred prosecution
9 or similar agreement may be given an extension of time or allowed to begin
10 community service before the fee is paid by the official or agency

23 (d) A person is not liable for damages for any injury or loss sustained by an individual
24 performing community or reparation service under this section unless the injury is caused by
25 the person's gross negligence or intentional wrongdoing. As used in this subsection, "person"
26 includes any governmental unit or agency, nonprofit corporation, or other nonprofit agency that
27 is supervising the individual, or for whom the individual is performing community service
28 work, as well as any person employed by the agency or corporation while acting in the scope
29 and course of the person's employment. This subsection does not affect the immunity from civil
30 liability in tort available to local governmental units or agencies. Notice of the provisions of
31 this subsection shall be furnished to the individual at the time of assignment of community
32 service work by the ~~community~~ judicial service coordinator.

33 ~~(e) In order to maximize the efficiency and effectiveness of the community service~~
34 ~~program, (i) beginning September 1, 1995, community service program districts shall have the~~

36 ~~with persons hired on or after September 1, 1995, all community service program district~~
37 ~~supervisors employed by the Department of Correction to supervise each of the community~~
38 ~~service program districts shall reside in the district in which the supervisor works.~~

39 (f) The community service staff shall report to the court in which the community
40 service was ordered, a significant violation of the terms of the probation, or deferred
41 prosecution, related to community ~~service.~~ service, including a willful failure to pay any
42 moneys due the State under any court order or payment schedule adopted by the Division of
43 Community Corrections. The community service staff shall give notice of the hearing to
44 determine if there is a willful failure to comply to the person who was ordered to perform the
45 community service. This notice shall be given by either personal delivery to the person to be
46 notified or by depositing the notice in the United States mail in an envelope with postage
47 prepaid, addressed to the person at the address shown on the records of the community service
48 staff. The notice shall be mailed at least 10 days prior to any hearing and shall state the basis of
49 the alleged willful failure to comply. The court shall then conduct a hearing, even if the person
50 ordered to perform the community service fails to appear, to determine if there is a willful
51 failure to complete the work as ordered by the community service staff within the applicable

1 time limits. The hearing may be held in the county in which the probation judgment or deferred
2 prosecution requiring the performance of community service was imposed, the county in which
3 the violation occurred, or the county of residence of the person. If the court determines there is
4 a willful failure to comply, it shall revoke any drivers license issued to the person and notify the
5 Division of Motor Vehicles to revoke any drivers license issued to the person until the
6 community service requirement has been met. In addition, if the person is present, the court
7 may take any further action authorized by Article 82 of Chapter 15A of the General Statutes for
8 violation of a condition of probation."

9 **SECTION 17.** G.S. 143B-273.10(a) reads as rewritten:

10 "(a) A county board or a multicounty board shall consist of not less than 10 members
11 and shall, to the greatest extent possible, include the following:

- 12 (1) A county commissioner. In the case of a multicounty community corrections
13 advisory board, one county commissioner from each participating county
14 shall serve as a member.
- 15 (2) A county manager, or the county manager's designee.
- 16 (3) A judge of the superior court.

- 18 (5) A district attorney, or the district attorney's designee.
- 19 (6) A criminal defense attorney.
- 20 (7) A public defender.
- 21 (8) A county sheriff, or the sheriff's designee.

- 23 (10) ~~A probation officer.~~ Two representatives from the Division of Community
24 Corrections of the Department of Correction.
- 25 ~~(11) A community service coordinator.~~
- 26 (12) One member selected from each of the following service areas which are
27 available in the county or counties: mental health, public health, substance
28 abuse, employment and training, community-based corrections programs,
29 victim services programs.
- 30 (13) A member of the business community.
- 31 (14) A member of the community who has been a victim of a crime.
- 32 (15) Members at large, including persons who are recovering from chemical
33 dependency or are previous consumers of substance abuse treatment
34 services."

35 **SECTION 18.** The provisions of this act are severable. If any provision is held
36 invalid by a court of competent jurisdiction, the invalidity does not affect other provisions of
37 the act that can be given effect without the invalid provision.

38 **SECTION 19.** Section 8 of this act becomes effective December 1, 2009, and
39 applies to offenses committed on or after that date. Section 10(a) applies to hearings held on or
40 after December 1, 2009. The remainder of this act becomes effective December 1, 2009.
