1	(c) <u>Functions and Duties. – The Council shall assist the Commission in an advisory</u>
2	capacity. The Council shall meet on such schedule and provide such assistance as may be
3	requested of it by the Commission.
4	(d) <u>Members; Multiple Offices. – Membership on the Mountain Resources Technical</u>
5	Advisory Council is hereby declared to be an office that may be held concurrently with other
6	elective or appointive offices (except the office of Commission member) in addition to the
7	maximum number of offices permitted to be held by one person under G.S. 128-1.1.
8	(e) Chairman and Vice-Chairman. – A chairman and vice-chairman shall be elected
9	annually by the Council.
0	(f) Compensation. – The members of the Advisory Council who are not State
1	employees shall receive per diem and necessary travel and subsistence expenses in accordance
2	with the provisions of G.S. 138-5."
3	SECTION 2. This act becomes effective July 1, 2009.
