11 "**SECTION 2.** G.S. 90-95(h) is amended by adding a new subdivision to read:

12 (3c) Any person who sells, manufactures, delivers, transports, or possesses 28
13 grams or more of amphetamine or any mixture containing such substance
14 shall be guilty of a felony which felony shall be known as "trafficking in
15 amphetamine" and if the quantity of such substance or mixture involved:

- 16 a. Is 28 grams or more, but less than 200 grams, such person shall be
17 punished as a Class H felon and shall be sentenced to a minimum
18 term of 25 months and a maximum term of 30 months in the State's
19 prison and shall be fined not less than five thousand dollars (\$5,000);
20 b. Is 200 grams or more, but less than 400 grams, such person shall be
21 punished as a Class G felon and shall be sentenced to a minimum
22 term of 35 months and a maximum term of 42 months in the State's
23 prison and shall be fined not less than twenty-five thousand dollars
24 (\$25,000);
25 c. Is 400 grams or more, such person shall be punished as a Class E
26 felon and shall be sentenced to a minimum term of 90 months and a
27 maximum term of 117 months in the State's prison and shall be fined
28 at least one hundred thousand dollars (\$100,000)."
