TITLE CHANGE

The conferees appointed to resolve the differences between the Senate and the House of Representatives on House Bill 1973, A BILL TO BE ENTITLED AN ACT TO MODIFY EXISTING ECONOMIC DEVELOPMENT INCENTIVES AND TO INCENT NEW ECONOMIC DEVELOPMENT OPPORTUNITIES; TO PROVIDE FOR THE FORMATION OF A LIMITED LIABILITY COMPANY AS A LOW-PROFIT LIMITED LIABILITY COMPANY; TO CREATE THE UWHARRIE REGIONAL RESOURCES COMMISSION; TO PROVIDE FUNDING FOR THE DNA DATABASE AND DATABANK; TO CLARIFY THE APPLICATION OF THE ENVIRONMENTAL POLICY ACT TO CERTAIN ECONOMIC DEVELOPMENT INCENTIVE PAYMENTS; AND TO INCREASE THE PERIOD OF TIME FOR WHICH THE SECRETARY OF REVENUE MAY ALLOW A CORPORATION TO USE AN ALTERNATIVE APPORTIONMENT FORMULA, Senate Finance Committee Substitute Adopted 7/1/10 Sixth Edition Engrossed 7/7/10, submit the following report:
