A BILL TO BE ENTITLED

AN ACT TO CLARIFY THE CRIMINAL STATUTES ON SELF-DEALING; TO CREATE THE PUBLIC FUNDING OF COUNCIL OF STATE ELECTIONS COMMISSION; TO INCREASE THE PUNISHMENT FOR MAKING CAMPAIGN CONTRIBUTIONS IN THE NAME OF ANOTHER; TO INCREASE ACCESSIBILITY TO INFORMATION RELATED TO CANDIDATE CAMPAIGN COMMITTEES AND TO INFORMATION RELATED TO STATE CONTRACTS AND GRANTS; TO STRENGTHEN PUBLIC CONFIDENCE IN GOVERNMENT BY CHANGING THE REVOLVING DOOR PERIOD AND APPLICABILITY; TO CODIFY CERTAIN POSITIONS IN STATE GOVERNMENT AS A PUBLIC SERVANT UNDER THE STATE GOVERNMENT ETHICS ACT; TO STRENGTHEN TRANSPARENCY OF GOVERNMENT THROUGH ADDITIONAL DISCLOSURES BY PUBLIC SERVANTS, INCLUDING CAMPAIGN CONTRIBUTIONS PRIOR TO APPOINTMENT; TO INCREASE ACCOUNTABILITY OF PUBLIC SERVANTS, APPOINTEES OF THE GOVERNOR, AND STATE EMPLOYEES BY PERMITTING THE GOVERNOR TO ADOPT MINIMUM STANDARDS OF ETHICAL CONDUCT; TO CLARIFY THE INDIRECT GIFT BAN AND CLARIFY REPORTING BY LOBBYIST PRINCIPALS; TO STRENGTHEN TRANSPARENCY OF GOVERNMENT THROUGH INCREASING AND CLARIFYING ACCESSIBILITY TO LEGISLATIVE RECORDS AND OTHER PUBLIC RECORDS; TO MAKE TECHNICAL CHANGES TO THE ETHICS LAW; AND TO EXPEDITE REVIEW OF PRELIMINARY INVESTIGATIONS OF ALLEGATIONS OF WRONGDOING UNDER CHAPTERS 120 AND 138A OF THE GENERAL STATUTES.

The General Assembly of North Carolina enacts:

SECTION 1.(a) G.S. 126-14 reads as rewritten:

"§ 126-14. Promise or threat to obtain political contribution or support.

(a) It is unlawful for a State employee or a person appointed to State office, other than elective office or office on a board, commission, committee, or council whose function is advisory only, whether or not subject to the Personnel Act, to coerce:

1 (1) a State employee subject to the Personnel Act,
2 (2) a probationary State employee,
3 (3) a temporary State employee, or
4 (4) an applicant for a position subject to the Personnel Act
5 to support or contribute to a political candidate, political committee as defined in
6 G.S. 163-278.6, or political party or to change the party designation of ~~his~~the individual's voter
7 registration by threatening that change in employment status or discipline or preferential
8 personnel treatment will occur with regard to ~~a person~~an individual listed in subdivisions (1)
9 ~~through (4)~~through (4) of this subsection.

10 (a1) It is unlawful for an individual as defined in G.S. 138A-3(30)a. to coerce a person as
11 described in G.S. 138A-32(d)(1), (2), or (3) to support or contribute to a political candidate, a
12 political committee as defined in G.S. 163-278.6, or a political party by threatening discipline
13 or promising preferential treatment with regard to that person's business with the individual's
14 State office or that person's activities regulated by the individual's State office.

15 (b) Any person violating this section shall be guilty of a Class 2 misdemeanor.

16 (c) A State employee subject to the Personnel Act, probationary State employee, or
17 temporary State employee who without probable cause falsely accuses a State employee or a
18 person appointed to State office of violating this section shall be subject to discipline or change
19 in employment status in accordance with the provisions of G.S. 126-35, 126-37, and 126-38
20 and may, as otherwise provided by law, be subject to criminal penalties for perjury or civil
21 liability for libel, slander, or malicious prosecution."

22 **SECTION 1.(b)** This section becomes effective December 1, 2010, and applies to
23 offenses committed on or after that date.

24 **SECTION 2.(a)** G.S. 14-234(a) reads as rewritten:

25 "**§ 14-234. Public officers or employees benefiting from public contracts; exceptions.**

- 26 (a) (1) No public officer or employee who is involved in making or administering a
27 contract on behalf of a public agency may derive a direct benefit from the
28 contract except as provided in this section, or as otherwise allowed by law.
29 (2) A public officer or employee who will derive a direct benefit from a contract
30 with the public agency he or she serves, but who is not involved in making
31 or administering the contract, shall not attempt to influence any other person
32 who is involved in making or administering the contract.
33 (3) No public officer or employee may solicit or receive any gift, ~~favor,~~ reward,
34 service, or promise of reward—reward, including a promise of future
35 employment, in exchange for recommending, influencing, or attempting to
36 influence the award of a contract by the public agency he or she serves."

37 **SECTION 2.(b)** This section becomes effective December 1, 2010, and applies to
38 offenses committed on or after that date.

39 **SECTION 3.(a)** G.S. 14-217 reads as rewritten:

40 "**§ 14-217. Bribery of officials.**

41 (a) If any person holding ~~office~~office, or who has filed a notice of candidacy for or
42 been nominated for such office, under the laws of this State who, except in payment of his legal
43 salary, fees or perquisites, shall receive, or consent to receive, directly or indirectly, anything of
44 value or personal advantage, or the promise thereof, for performing or omitting to perform any
45 official act, which lay within the scope of his official authority and was connected with the
46 discharge of his official and legal duties, or with the express or implied understanding that his
47 official action, or omission to act, is to be in any degree influenced thereby, he shall be
48 punished as a Class F felon.

49 (b) Indictments issued under these provisions shall specify:

- 50 (1) The thing of value or personal advantage sought to be obtained; and
51 (2) The specific act or omission sought to be obtained; and

1 (3) That the act or omission sought to be obtained lay within the scope of the
2 defendant's official authority and was connected with the discharge of his
3 official and legal duties.

4 (c) Repealed by Session Laws 1993 (Reg. Sess., 1994), c. 539, s. 1207.

5 (d) For purposes of this section, a thing of value or personal advantage shall include a
6 campaign contribution made or received under Article 22A of Chapter 163 of the General
7 Statutes."

8 **SECTION 3.(b)** This section becomes effective December 1, 2010, and applies to
9 offenses committed on or after that date.

10 **SECTION 4.(a)** G.S. 120C-304(b) reads as rewritten:

11 "(b) No public servant or former public servant as defined in G.S. 138A-3(30)a. may
12 register as a lobbyist under this Chapter while in office or within six months after leaving
13 office."

14 **SECTION 4.(b)** G.S. 120C-304(c) reads as rewritten:

15 "(c) No public servant or former public servant as defined in G.S. 138A-3(30)c. may
16 register as a lobbyist under this Chapter within six months after separation from employment as
17 a public servant. No other employee of any State agency may register as a lobbyist under this
18 Chapter to lobby the State agency that previously employed the former employee within six
19 months after voluntary separation or separation for cause from that State agency."

20 **SECTION 4.(c)** G.S. 120C-200 is amended by adding a new subsection to read:

21 "(f) In addition to the information required for registration under subsection (b) of this
22 section, former employees of a State agency who register as a lobbyist within six months after
23 voluntary separation or separation for cause from employment with a State agency shall also
24 indicate which State agency with which the former employee was employed."

25 **SECTION 4.(d)** This section becomes effective October 1, 2010, and applies to
26 individuals who leave office or separate from employment on or after that date.

27 **SECTION 5.(a)** Article 5 of Chapter 120C of the General Statutes is amended by
28 adding a new section to read:

29 **"§ 120C-502. Local government liaison equivalents.**

30 (a) An individual who is an employee of a governmental unit whose principal duties, in
31 practice or as set forth in that individual's job description, include lobbying for legislative
32 action shall register under G.S. 120C-200.

33 (b) G.S. 120C-501 shall apply to an individual required to register under subsection (a)
34 of this section.

35 (c) For purposes of publication of the registry under G.S. 120C-220, the Secretary of
36 State shall treat individuals registered under this section as liaison personnel.

37 **SECTION 5.(b)** G.S. 120C-700(3) reads as rewritten:

38 "(3) A duly elected or appointed official or employee of the State, the United
39 States, a county, municipality, school district, or other governmental agency,
40 when acting solely in connection with matters pertaining to the office and
41 public duties, except for a person designated as liaison personnel under
42 G.S. 120C-500. G.S. 120C-500 or G.S. 120C-502. For purposes of this
43 subdivision, an individual appointed as a county or city attorney under Part 7
44 of Article 5 of Chapter 153A of the General Statutes or Part 6 of Article 7 of
45 Chapter 160A of the General Statutes, respectively, shall be considered an
46 employee of the county or city.

47 **SECTION 5.(c)** This section becomes effective January 1, 2011.

48 **SECTION 6.(a)** G.S. 163-278.27 reads as rewritten:

49 **"§ 163-278.27. Criminal penalties; duty to report and prosecute.**

50 (a) Any individual, candidate, political committee, referendum committee, treasurer,
51 person or media who intentionally violates the applicable provisions of G.S. 163-278.7,

1 163-278.8, 163-278.9, 163-278.10, 163-278.11, 163-278.12, 163-278.13, 163-278.13B,
2 163-278.14, 163-278.16, 163-278.16B, 163-278.17, 163-278.18, 163-278.19, 163-278.20,
3 163-278.39, 163-278.40A, 163-278.40B, 163-278.40C, 163-278.40D, 163-278.40E, or
4 163-278.40J is guilty of a Class 2 misdemeanor. The statute of limitations as stated in G.S. 15-1
5 shall run from the day the last report is due to be filed with the appropriate board of elections
6 for the election cycle for which the violation occurred.

7 (a1) A violation of G.S. 163-278.32 by making a certification knowing the information
8 to be untrue is a Class I felony.

9 (a2) A person or individual who intentionally violates G.S. 163-278.14(a) or
10 G.S. 163-278.19(a) and the unlawful contributions total more than ten thousand dollars
11 (\$10,000) per election is guilty of a Class I felony.

12 (b) Whenever the Board has knowledge of or has reason to believe there has been a
13 violation of any section of this Article, it shall report that fact, together with accompanying
14 details, to the following prosecuting authorities:

15 (1) In the case of a candidate for nomination or election to the State Senate or
16 State House of Representatives: report to the district attorney of the
17 prosecutorial district in which the candidate for nomination or election
18 resides;

19 (2) In the case of a candidate for nomination or election to the office of
20 Governor, Lieutenant Governor, Secretary of State, State Auditor, State
21 Treasurer, State Superintendent of Public Instruction, State Attorney
22 General, State Commissioner of Agriculture, State Commissioner of Labor,
23 State Commissioner of Insurance, and all other State elective offices, Justice
24 of the Supreme Court, Judge of the Court of Appeals, judge of a superior
25 court, judge of a district court, and district attorney of the superior court:
26 report to the district attorney of the prosecutorial district in which Wake
27 County is located;

28 (3) In the case of an individual other than a candidate, including, without
29 limitation, violations by members of political committees, referendum
30 committees or treasurers: report to the district attorney of the prosecutorial
31 district in which the individual resides; and

32 (4) In the case of a person or any group of individuals: report to the district
33 attorney or district attorneys ~~of~~of the prosecutorial district or districts in
34 which any of the officers, directors, agents, employees or members of the
35 person or group reside.

36 (c) Upon receipt of such a report from the Board, the appropriate district attorney shall
37 prosecute the individual or persons alleged to have violated a section or sections of this Article.

38 (d) As a condition of probation, a sentencing judge may order that the costs incurred by
39 the State Board of Elections in investigating and aiding the prosecution of a case be paid to the
40 State Board of Elections by the defendant on such terms and conditions as set by the judge."

41 **SECTION 6.(b)** G.S. 163-278.14(a) reads as rewritten:

42 "(a) No individual, political committee, or other entity shall make any contribution
43 anonymously or in the name of another. No candidate, political committee, referendum
44 committee, political party, or treasurer shall knowingly accept any contribution made by any
45 individual or person in the name of another individual or person or made anonymously. If a
46 candidate, political committee, referendum committee, political party, or treasurer receives
47 anonymous contributions or contributions determined to have been made in the name of
48 another, he shall pay the money over to the Board, by check, and all such moneys received by
49 the Board shall be deposited in the Civil Penalty and Forfeiture Fund of the State of North
50 Carolina. This subsection shall not apply to any contribution by an individual with the lawful

1 authority to act on behalf of another individual, whether through power of attorney, trustee, or
2 other lawful authority."

3 **SECTION 6.(c)** This section becomes effective December 1, 2010, and applies to
4 offenses committed on or after that date.

5 **SECTION 7.** G.S. 150B-38(a) is amended by adding a new subdivision to read:

6 "(6) The State Board of Elections in the administration of any investigation or
7 audit under the provisions of Article 22A of Chapter 163 of the General
8 Statutes."

9 **SECTION 8.** In order to foster and facilitate transparency of information relating
10 to political campaigns, the State Board of Elections shall create an easily searchable database to
11 provide any member of the public with access to the database to search by geographic location,
12 occupation, employer, contributor, or contributee, within an election cycle and over a period of
13 time as specified by the searcher of any report filed by a political committee or referendum
14 committee under Article 22A of Chapter 163 of the General Statutes with the State Board of
15 Elections.

16 **SECTION 9.** Article 2 of Chapter 143C of the General Statutes is amended by
17 adding new sections to read:

18 **"§ 143C-2-5. Grants and contracts database.**

19 (a) The Director of the Budget shall require the Office of State Budget and
20 Management, with the support of the Office of Information Technology Services, to build and
21 maintain a database and Web site for providing a single, searchable Web site on State spending
22 for grants and contracts to be known as NC OpenBook.

23 (b) Each head of a principal department listed in G.S. 143B-6 shall conduct a review
24 monthly of all State contracts and grants administered by that principal department.

25 (c) All State institutions, departments, bureaus, agencies, or commissions subject to the
26 authority of the Director of the Budget that maintain a Web site shall be required to include an
27 access link to the NC OpenBook Web site on the home page of the agency Web site. Each
28 agency shall also prominently display a search engine on the agency Web site home page to
29 allow for ease of searching for information, including contracts and grants, on the agency's
30 Web site.

31 **"§ 143C-2-6. Contents of database and Web site.**

32 (a) The Office of State Controller, the Department of Administration, and the Office of
33 Information Technology Services shall provide the Office of State Budget and Management
34 with the statewide information on State contracts necessary for the development and
35 maintenance of the database and Web site required by this Article, with the information
36 updated at least monthly.

37 (b) The Office of State Budget and Management shall work with the Office of the State
38 Auditor and the Grant Information Center to incorporate data on grants into the database and
39 Web site required by this Article. All State institutions, departments, bureaus, agencies, or
40 commissions subject to the authority of the Governor shall make necessary changes to existing
41 reporting processes for contracts and grants to ensure the goals of this Article are met.

42 (c) All State contracts and grants awarded in amounts in excess of ten thousand dollars
43 (\$10,000) shall be included in the database and Web site required by this Article. The following
44 information shall be provided for each contract or grant:

45 (1) The name of the entity receiving the award.

46 (2) The amount of the award or estimated award.

47 (3) Information on the award, including type of transaction, funding agency, and
48 duration of the contract or grant.

49 (4) The location of the entity receiving the award.

50 (5) Background information on the entity receiving the award.

51 (6) Time lines for anticipated completion of the work required.

- 1 (7) Expected outcomes of the contract or grant and specific deliverables
2 required.
3 (8) Contact information for the responsible State government officer or
4 administrator of the contract or grant."

5 **SECTION 10.** G.S. 138A-3(30) reads as rewritten:

6 "(30) Public servants. – All of the following:

- 7 a. Constitutional officers of the State and individuals elected or
8 appointed as constitutional officers of the State prior to taking office.
9 b. Employees of the Office of the Governor.
10 c. Heads of all principal State departments, as set forth in G.S. 143B-6,
11 who are appointed by the Governor.
12 d. The chief deputy and chief administrative assistant of each individual
13 designated under sub-subdivision a. or c. of this subdivision.
14 e. Confidential assistants and secretaries as defined in G.S. 126-5(c)(2),
15 to individuals designated under sub-subdivision a., c., or d. of this
16 subdivision.
17 f. Employees in exempt positions designated in accordance with
18 G.S. 126-5(d)(1), (2), or (2a) and confidential secretaries to these
19 individuals.
20 g. Any other employees or appointees in the principal State departments
21 as may be designated by the Governor to the extent that the
22 designation does not conflict with the State Personnel Act.
23 h. Judicial employees.
24 i. All voting members of boards, including ex officio members,
25 permanent designees of any voting member, and members serving by
26 executive, legislative, or judicial branch appointment.
27 j. For The University of North Carolina, the voting members of the
28 Board of Governors of The University of North Carolina, the
29 president, the vice-presidents, and the chancellors, the
30 vice-chancellors, and voting members of the boards of trustees of the
31 constituent institutions.
32 k. For the Community College System, the voting members of the State
33 Board of Community Colleges, the President and the chief financial
34 officer of the Community College System, the president, chief
35 financial officer, and chief administrative officer of each community
36 college, and voting members of the boards of trustees of each
37 community college.
38 l. Members of the ~~Commission~~Commission, the executive director,
39 and the assistant executive director of the Commission.
40 m. Individuals under contract with the State working in or against a
41 position included under this subdivision.
42 n. The director of the Office of State Personnel.
43 o. The State Controller.
44 p. The chief information officer, deputy chief information officers,
45 chief financial officers, and general counsel of the Office of
46 Information Technology Services.
47 q. The director of the State Museum of Art.
48 r. The executive director of the Agency for Public
49 Telecommunications.
50 s. The Commissioner of Motor Vehicles.

- 1 t. The Commissioner of Banks and the chief deputy commissioners of
2 the Banking Commission.
3 u. The executive director of the North Carolina Housing Finance
4 Agency.
5 v. The executive director, chief financial officer, and chief operating
6 officer of the North Carolina Turnpike Authority."

7 **SECTION 11.** G.S. 143B-478 is amended by adding a new subsection to read:

8 "(f) The Commission shall be treated as a board for purposes of Chapter 138A of the
9 General Statutes."

10 **SECTION 12.** G.S. 138A-22 is amended by adding a new subsection to read:

11 "(d1) In addition to subsections (a) and (d) of this section, a covered person holding
12 elected office or a former covered person who held elected office subject to this Article shall
13 file a statement of economic interest in all of the following instances, as specified:

- 14 (1) Filed on or before April 15 of the year following the year a covered person
15 or former covered person does not file a notice of candidacy or petition for
16 election, or does not receive a certificate of election, to the position making
17 that individual a covered person, with all information provided in the
18 statement of economic interest current as of the last day of December of the
19 preceding year.
20 (2) Filed on or before April 15 of the year following the year the covered person
21 or former covered person resigns from the position making that individual a
22 covered person, with all information provided in the statement of economic
23 interest current as of the last day in the position."

24 **SECTION 13.(a)** G.S. 138A-24(a) reads as rewritten:

25 **"§ 138A-24. Contents of statement.**

26 (a) Any statement of economic interest filed under this Article shall be on a form
27 prescribed by the ~~Commission and sworn to by the filing person.~~ Commission. Answers must
28 be provided to all questions. The form shall include the following information about the filing
29 person and the filing person's immediate family:

- 30 (1) Except as otherwise provided in this subdivision, the name, current mailing
31 address, occupation, employer, and business of the filing person. Any
32 individual holding or seeking elected office for which residence is a
33 qualification for office shall include a home address. A judicial officer may
34 use a current mailing address instead of the home address on the form
35 required in this subsection. The ~~judicial officer filing person~~ may also use
36 the initials instead of the name of any unemancipated child of the ~~judicial~~
37 ~~officer filing person~~ who also resides in the household of the ~~judicial~~
38 ~~officer filing person~~. If the ~~judicial officer filing person~~ provides the initials
39 of an unemancipated child, the ~~judicial officer filing person~~ shall
40 concurrently provide the name of the unemancipated child to the
41 Commission. The name of an unemancipated child provided by the ~~judicial~~
42 ~~officer filing person~~ to the Commission shall not be a public record under
43 Chapter 132 of the General Statutes and is privileged and confidential.
44 (2) A list of each asset and liability included in this subdivision of whatever
45 nature (including legal, equitable, or beneficial interest) with a value of at
46 least ten thousand dollars (\$10,000) owned by the filing person and the filing
47 person's immediate family, except assets or liabilities held in a blind trust.
48 This list shall include the following:
49 a. All real estate located in the State owned wholly or in part by the
50 filing person or the filing person's immediate family, including

- 1 descriptions adequate to determine the location by city and county of
2 each parcel.
- 3 b. Real estate that is currently leased or rented to or from the State.
- 4 c. Personal property sold to or bought from the State within the
5 preceding two years.
- 6 d. Personal property currently leased or rented to or from the State.
- 7 e. The name of each publicly owned company. For purposes of this
8 sub-subdivision, the term "publicly owned company" shall not
9 include a widely held investment fund, including a mutual fund,
10 regulated investment company, or pension or deferred compensation
11 plan, if all of the following apply:
- 12 1. The filing person or a member of the filing person's
13 immediate family neither exercises nor has the ability to
14 exercise control over the financial interests held by the fund.
- 15 2. The fund is publicly traded, or the fund's assets are widely
16 diversified.
- 17 f. The name of each nonpublicly owned company or business entity,
18 including interests in sole proprietorships, partnerships, limited
19 partnerships, joint ventures, limited liability companies, limited
20 liability partnerships, and closely held corporations.
- 21 g. For each company or business entity listed under sub-subdivision f.
22 of this subdivision, if known, a list of any other companies or
23 business entities in which the company or business entity owns
24 securities or equity interests exceeding a value of ten thousand
25 dollars (\$10,000).
- 26 ~~h. A list of all nonpublicly owned businesses of which the filing person~~
27 ~~and the filing person's immediate family is an officer, employee,~~
28 ~~director, partner, owner, or member or manager of a limited liability~~
29 ~~company.~~
- 30 i. For any company or business entity listed under sub-subdivisions f.,
31 g., and h. of this subdivision, if known, any company or business
32 entity that has any material business dealings, contracts, or other
33 involvement with the State, or is regulated by the State, including a
34 brief description of the business activity.
- 35 j. For a vested trust created, established, or controlled by the filing
36 person of which the filing person or the members of the filing
37 person's immediate family are the beneficiaries, excluding a blind
38 trust, the name and address of the trustee, a description of the trust,
39 and the filing person's relationship to the trust.
- 40 k. A list of all liabilities, excluding indebtedness on the filing person's
41 primary personal residence, by type of creditor and debtor.
- 42 l. Repealed by Session Laws 2007-348, s. 34. See Editor's note for
43 effective date.
- 44 m. A list of all stock options in a company or business not otherwise
45 disclosed on this statement.
- 46 (3) The name of each source (not specific amounts) of income of more than five
47 thousand dollars (\$5,000) received during the previous year by business or
48 industry type, if that source is not listed under subdivision (2) of this
49 subsection. Income shall include salary, wages, professional fees, honoraria,
50 interest, dividends, rental income, and business income from any source

- 1 other than capital gains, federal government retirement, military retirement,
2 or social security income.
- 3 (4) If the filing person is a practicing attorney, an indication of whether the
4 filing person, or the law firm with which the filing person is affiliated,
5 earned legal fees during the past year in excess of ten thousand dollars
6 (\$10,000) from any of the following categories of legal representation:
- 7 a. Administrative law.
 - 8 b. Admiralty law.
 - 9 c. Corporate law.
 - 10 d. Criminal law.
 - 11 e. Decedents' estates law.
 - 12 f. Environmental law.
 - 13 g. Insurance law.
 - 14 h. Labor law.
 - 15 i. Local government law.
 - 16 j. Negligence or other tort litigation law.
 - 17 k. Real property law.
 - 18 l. Securities law.
 - 19 m. Taxation law.
 - 20 n. Utilities regulation law.
- 21 (5) Except for a filing person in compliance under subdivision (4) of this

49 filing person filed or was nominated as a candidate for office, as described in
50 G.S. 138A-22, or was appointed or employed as a covered person.

25 the filing person: (i) collected contributions from multiple contributors, took

42 **SECTION 22.(e)** G.S. 120-104(c) reads as rewritten:

45 G.S. 138A-13(b1)."

46 **SECTION 22.(f)** G.S. 120C-800(b) reads as rewritten:

47 "(b) If the person making the reportable expenditure in subsection (a) of this section is

49 also outside North Carolina at the time the designated individual accepts the reportable

27 of the Commission if there is reason to believe that a covered person or legislative employee

30 upon which the complaint is based, except when the conduct is material to the continuing

33 information even if not formally provided to the Commission in the form of a complaint. The
34 Commission may utilize the services of a hired investigator when conducting inquiries."

35 **SECTION 23.(e)** G.S. 138A-12(f) reads as rewritten:

17 is the subject of the complaint within 10 days of the date of the Committee's decision to initiate
18 an investigation. The Commission shall conclude the preliminary inquiry within 20 business

47 information acquired under subsection (a) of this section if in his the judge's opinion, the same
48 disclosure is necessary to a proper administration of justice."

49 **SECTION 24.(c)** This section becomes effective October 1, 2010.

50 **SECTION 25.(a)** The Legislative Ethics Committee shall study the need for
51 additional regulation of campaign contributions to State officials and candidates for State office

1 by persons doing business with, or regulated by, the office held by the State official. In
2 particular, the Committee shall study the need to regulate campaign activities by persons doing
3 or seeking to do business of any kind, engaged in activities that are regulated or controlled by,
4 or having financial interests that may be substantially and materially affected, in a manner
5 distinguishable from the public generally, by the performance or nonperformance of the State
6 official. The Committee shall also study the statement of economic interest required to be filed
7 under Article 4 of Chapter 138A of the General Statutes, particularly whether that statement
8 accurately and informatively discloses required information.

9 **SECTION 25.(b)** The Committee shall report its findings and recommendations to
10 the 2011 Regular Session of the General Assembly on or before April 1, 2011.

11 **SECTION 26.(a)** There is established the Public Funding of Council of State
12 Elections Commission, which shall consist of the following members:

- 13 (1) Five members appointed by the Speaker of the House of Representatives, to
14 include:
- 15 a. Two members of the House of Representatives, of whom no more
16 than one shall be of the same political party as the Speaker of the
17 House of Representatives.
 - 18 b. An individual in business recommended by the North Carolina

 - 20 c. An individual representing groups opposing public financing of

 - 22 d. An individual who has received public financing for a campaign.
- 23 (2) Five members appointed by the President Pro Tempore of the Senate, to
24 include:
- 25 a. Two members of the Senate, of whom no more than one shall be of
26 the same political party as the President Pro Tempore of the Senate.
 - 27 b. An individual in business recommended by a business association
28 other than the North Carolina Chamber.
 - 29 c. An individual representing groups advocating and supporting public
30 financing of elections.
 - 31 d. An individual representing the North Carolina State Bar.

32 **SECTION 26.(b)** The Commission shall study issues related to the continuation of
33 public funding for Council of State elections, including:

- 34 (1) The existing program, funding sources for existing programs, and the
35 financial needs of the existing program;
- 36 (2) Whether to expand the program to the remainder of the Council of State, and
37 the financial needs to accomplish that expansion;
- 38 (3) Potential funding mechanisms to fund the needs of the existing program and
39 the expansion; and
- 40 (4) Any other matter pertinent to public financing of campaigns for elected
41 office, including issues raised by the First Amendment and all legal
42 precedents related to those issues.

43 **SECTION 26.(c)** The President Pro Tempore of the Senate and the Speaker of the
44 House of Representatives shall each appoint a co-chair from among their respective appointees.
45 A co-chair or other member of the Commission continues to serve until a successor is
46 appointed. A vacancy shall be filled within 30 days by the officer who made the original
47 appointment. Members serve at the pleasure of the appointing officer.

48 **SECTION 26.(d)** The Commission shall meet upon the call of its House and
49 Senate co-chairs. A quorum of the Commission is a majority of its members. No action may be
50 taken except by a majority vote at a meeting at which a quorum is present.

1 **SECTION 26.(e)** The Commission while in the discharge of its official duties, may
2 exercise all powers provided for under G.S. 120-19 and Article 5A of Chapter 120 of the
3 General Statutes. The Commission may contract for professional, clerical, or consultant
4 services, as provided by G.S. 120-32.02.

5 **SECTION 26.(f)** Members of the Commission shall receive per diem, subsistence,
6 and travel allowance as provided in G.S. 120-3.1, 138-5 and 138-6, as appropriate.

7 **SECTION 26.(g)** The Legislative Services Officer shall assign professional and
8 clerical staff to assist the Commission in its work. The Director of Legislative Assistants of the
9 House of Representatives and the Director of Legislative Assistants of the Senate shall assign
10 clerical support staff to the Commission.

11 **SECTION 26.(h)** The Commission shall report the results of its study and its
12 recommendations to the 2011 General Assembly no later than March 1, 2011.

13 **SECTION 27.** Notwithstanding Page J-8, Item 29, of the Joint Conference
14 Committee Report on the Continuation, Expansion and Capital Budgets dated June 28, 2010, of
15 the funds appropriated to the State Ethics Commission, the sum of ninety-one thousand five
16 hundred forty-one dollars (\$91,541) in recurring funds and two thousand two hundred fifty
17 dollars (\$2,250) in nonrecurring funds shall be used to fund two Paralegal III positions and
18 provide operating expenses to respond to customer service queries regarding State ethics law
19 compliance and any additional ethics rules or standards implemented by the Governor.

20 **SECTION 28.** Except as otherwise provided, this act is effective when it becomes
21 law.
