30 The General Assembly of North Carolina enacts:

31 **SECTION 1.** G.S. 20-63(b) reads as rewritten:

1 "(b) Every license plate shall have displayed upon it the registration number assigned to
2 the vehicle for which it is issued, the name of the State of North Carolina, which may be
3 abbreviated, and the year number for which it is issued or the date of expiration. A plate issued
4 for a commercial vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more,
5 must bear the word "commercial," unless the plate is a special registration plate authorized in
6 G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The
7 plate issued for vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word
8 "weighted".

9 Except as otherwise provided in this subsection, a registration plate issued by the Division
10 for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less
11 shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight"
12 printed at the top of the plate above all other letters and numerals. The background of the plate
13 shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying
14 slightly upward and to the right. The following special registration plates do not have to be a
15 "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be
16 approved by the Division and the State Highway Patrol for clarity and ease of identification.

11 **SECTION 2.** G.S. 20-79.4(b) reads as rewritten:

- 12 "(b) Types. – The Division shall issue the following types of special registration plates:
- 13 (1) 82nd Airborne Division Association Member. – Issuable to a member of the
14 82nd Airborne Division Association, Inc. The plate shall bear the insignia of
15 the 82nd Airborne Division Association, Inc. The Division may not issue the
16 plate authorized by this subdivision unless it receives at least 300
17 applications for the plate.
 - 18 (1a) Active and Retired Federal Employees. – Issuable to a member of the
19 National Active and Retired Federal Employees Association, Inc., in
20 accordance with G.S. 20-81.12. The plate shall bear the insignia of the
21 National Active and Retired Federal Employees Association, Inc.
 - 22 (2) Administrative Officer of the Courts. – Issuable to the Director of the
23 Administrative Office of the Courts. The plate shall bear the phrase "J-20".
 - 24 (2a) Adoption Works. – Issuable to the registered owner of a motor vehicle in
25 accordance with G.S. 20-81.12. The plate shall bear the phrase "Adoption
26 Works" and a logo provided by the Children's Home Society of North
27 Carolina.
 - 28 (3) AIDS Awareness. – Issuable to the registered owner of a motor vehicle in
29 accordance with G.S. 20-81.12. The plate shall bear the phrase "Find a Cure"
30 beside the logo of a red ribbon on the left side of the plate.
 - 31 (4) Air Medal Recipient. – Issuable to the recipient of the Air Medal. The plate
32 shall bear the emblem of the Air Medal and the words "Air Medal".
 - 33 (5) Alpha Kappa Alpha Sorority. – Issuable to the registered owner of a motor
34 vehicle. The plate shall bear the sorority's symbol and name. The Division
35 may not issue the plate authorized by this subdivision unless it receives at
36 least 300 applications for the plate.
 - 37 (6) Alpha Phi Alpha Fraternity. – Issuable to a member or supporter of the
38 Alpha Phi Alpha Fraternity in accordance with G.S. 20-81.12. The plate
39 shall bear the fraternity's symbol and name.
 - 40 (7) ALS Research. – Issuable to the registered owner of a motor vehicle in
41 accordance with G.S. 20-81.12. The plate shall bear the phrase "Nothing
42 Less, Cure ALS" and the logo of the nonprofit group the ALS Association,
43 Jim "Catfish" Hunter Chapter.
 - 44 (8) Alternative Fuel Vehicles. – Issuable to the registered owner of an
45 alternative fuel vehicle. The plate shall bear the words "Alternative Fuel
46 Vehicle". The Division must receive 300 or more applications for the plate
47 before it may be developed.
 - 48 (9) Amateur Radio Operator. – Issuable to an amateur radio operator who holds
49 an unexpired and unrevoked amateur radio license issued by the Federal
50 Communications Commission and who asserts to the Division that a portable
51 transceiver is carried in the vehicle. The plate shall bear the phrase "Amateur

- 1 Radio". The plate shall bear the operator's official amateur radio call letters,
2 or call letters with numerical or letter suffixes so that an owner of more than
3 one vehicle may have the call letters on each.
- 4 (10) American Legion. – Issuable to a member of the American Legion. The plate
5 shall bear the words "American Legion" and the emblem of the American
6 Legion. The Division may not issue the plate authorized by this subdivision
7 unless it receives at least 300 applications for the plate.
- 8 (11) Animal Lovers. – Issuable to the registered owner of a motor vehicle in
9 accordance with G.S. 20-81.12. The plate may bear a picture of a dog and
10 cat and the phrase "I Care."
- 11 (11a) American Red Cross. – Issuable to the registered owner of a motor vehicle in
12 accordance with G.S. 20-81.12. The plate shall bear the phrase "American
13 Red Cross Saving Lives" and a red cross.
- 14 (12) ARC of North Carolina. – Issuable to the registered owner of a motor
15 vehicle in accordance with G.S. 20-81.12. The plate shall bear the logo of
16 The ARC of North Carolina, Inc., and the phrase "The ARC".
- 17 (12a) Armed Forces Expeditionary Medal Recipient. – Issuable to a recipient of
18 the Armed Forces Expeditionary Medal. The plate shall bear the phrase
19 "Armed Forces Expeditionary Medal" and a representation of the Armed
20 Forces Expeditionary Medal. The Division may not issue the plate
21 authorized by this subdivision unless it receives at least 300 applications for
22 the plate.
- 23 (12a) ARTS NC. – Issuable to the registered owner of a motor vehicle in
24 accordance with G.S. 20-81.12. The plate shall bear the phrase "The
25 Creative State" with a logo designed by ARTS North Carolina, Inc.
- 26 (13) Audubon North Carolina. – Issuable to the registered owner of a motor
27 vehicle in accordance with G.S. 20-81.12. The plate shall bear the National
28 Audubon Society, Inc., logo and a representation of a bird native to North
29 Carolina.
- 30 (14) Autism Society of North Carolina. – Issuable to the registered owner of a
31 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
32 phrase "Autism Society of North Carolina", the phrase "Providing Support,
33 Promoting Opportunities", and the logo of the Autism Society.
- 34 (15) Aviation Maintenance Technician. – Issuable to a person who is a Federal
35 Aviation Authority certified Aviation Maintenance Technician. The plate
36 shall bear the logo of the F.A.A. Airworthiness Program and the initials
37 "A.M.T." The Division may not issue the plate authorized by this
38 subdivision unless it receives at least 300 applications for the plate.
- 39 (16) Back Country Horsemen of North Carolina. – Issuable to the registered
40 owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall
41 bear a picture of a horseman trail riding and bear the phrase "Back Country
42 Horsemen of NC."
- 43 (16a) Battle of Kings Mountain. – Issuable to the registered owner of a motor
44 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase
45 "Battle of Kings Mountain" with a representation of Kings Mountain on it.
- 46 (17) Be Active NC. – Issuable to the registered owner of a motor vehicle in
47 accordance with G.S. 20-81.12. The plate shall bear the phrase "Be Active
48 NC" and a representation of the "Be Active NC" logo.
- 49 (17a) Blue Knights. – Issuable to a member of the Blue Knights International Law
50 Enforcement Officers Motorcycle Club, Inc. The plate shall bear the emblem
51 of the Blue Knights International Law Enforcement Officers Motorcycle

- 1 Club, Inc. The Division must receive 300 or more applications for the plate
2 before this plate may be developed.
- 3 (17b) Boy Scouts of America. – Issuable to the registered owner of a motor vehicle
4 in accordance with G.S. 20-81.12. The plate shall bear the phrase "Boy
5 Scouts of America" and an emblem representing the Boy Scouts of America.
- 6 (18) Brain Injury Awareness. – Issuable to the registered owner of a motor
7 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase
8 "Brain Injury Awareness" and the logo of the nonprofit group Brain Injury
9 Association of North Carolina, Inc.
- 10 (19) Breast Cancer Awareness. – Issuable to the registered owner of a motor
11 vehicle. The plate shall bear the phrase "Early Detection Saves Lives" and a
12 representation of a pink ribbon. The Division must receive 300 or more
13 applications for the plate before it may be developed.
- 14 (20) Breast Cancer Earlier Detection. – Issuable to the registered owner of a
15 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
16 phrase "Friends for An Earlier Breast Cancer Test."
- 17 (20a) Brenner Children's Hospital. – Issuable to the registered owner of a motor
18 vehicle in accordance with G.S. 20-81.12. The plate shall bear the emblem
19 of Wake Forest University Baptist Medical Center's Brenner Children's
20 Hospital.
- 21 (21) Bronze Star Combat Recipient. – Issuable to a recipient of the Bronze Star
22 Medal for valor in combat. The plate shall bear the emblem of the Bronze
23 Star with a "Combat V" emblem and the words "Bronze Star." To be eligible
24 for this plate, the applicant must provide documentation that the medal was
25 issued for valor in combat.
- 26 (22) Bronze Star Recipient. – Issuable to a recipient of the Bronze Star. The plate
27 shall bear the emblem of the Bronze Star and the words "Bronze Star".
- 28 (23) Buddy Pelletier Surfing Foundation. – Issuable to the registered owner of a
29 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
30 words "Buddy Pelletier Surfing Foundation" and bear the logo of the
31 Foundation.
- 32 (24) Buffalo Soldiers. – Issuable to the registered owner of a motor vehicle in
33 accordance with G.S. 20-81.12. The plate shall bear the words "The Buffalo
34 Soldiers" and the logo of the 9th & 10th (Horse) Cavalry Association of the
35 Buffalo Soldiers Greater North Carolina Chapter (BSGNCC).
- 36 (24a) Carolina Raptor Center. – Issuable to the registered owner of a motor vehicle
37 in accordance with G.S. 20-81.12. The plate shall bear the words
38 "Imagination in Flight" and the emblem of the Carolina Raptor Center.
- 39 (24b) Carolina Regional Volleyball Association. – Issuable to the registered owner
40 of a motor vehicle in accordance with G.S. 20-82.12. The plate shall bear a
41 phrase and logo selected by the Association.
- 42 (25) Carolina's Aviation Museum. – ~~This plate is issuable~~ Issuable to the
43 registered owner of a motor vehicle in accordance with G.S. 20-81.12. The
44 plate shall bear the phrase "Carolina's Aviation Museum" and a logo
45 provided by the museum.
- 46 (25a) Carolinas Credit Union Foundation. – Issuable to the registered owner of a
47 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
48 phrase "Carolinas Credit Union Foundation" with an emblem of the
49 Carolinas Credit Union Foundation, Inc.
- 50 (25b) Carolinas Golf Association. – Issuable to the registered owner of a motor
51 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase

- 1 "Carolinas Golf Association" and an emblem of the Carolinas Golf
2 Association.
- 3 (26) Celebrate Adoption. – Issuable to the registered owner of a motor vehicle.
4 The plate shall bear the phrase "Celebrate Adoption" and a representation of
5 a white ribbon with a red heart on it. The Division must receive 300 or more
6 applications for the plate before it may be developed.
- 7 (26a) Childhood Cancer Awareness. – Issuable to the registered owner of a motor
8 vehicle. The plate shall bear the phrase "Childhood Cancer Hurts" beside the
9 logo of a gold ribbon on the left side of the plate. The Division must receive
10 300 or more applications for the plate before it may be developed.
- 11 (27) Civic Club. – Issuable to a member of a nationally recognized civic
12 organization whose member clubs in the State are exempt from State
13 corporate income tax under G.S. 105-130.11(a)(5). Examples of these clubs
14 include Jaycees, Kiwanis, Optimist, Rotary, Ruritan, and Shrine. The plate
15 shall bear a word or phrase identifying the civic club and the emblem of the
16 civic club. The Division may not issue a civic club plate authorized by this
17 subdivision unless it receives at least 300 applications for that civic club
18 plate.
- 19 (28) Civil Air Patrol Member. – Issuable to an active member of the North
20 Carolina Wing of the Civil Air Patrol. The plate shall bear the phrase "Civil
21 Air Patrol". A plate issued to an officer member shall begin with the number
22 "201" and the number shall reflect the seniority of the member; a plate
23 issued to an enlisted member, a senior member, or a cadet member shall
24 begin with the number "501".
- 25 (29) Class D Citizen's Radio Station Operator. – Issuable to a Class D citizen's
26 radio station operator. For an operator who has been issued Class D citizen's
27 radio station call letters by the Federal Communications Commission, the
28 plate shall bear the operator's official Class D citizen's radio station call
29 letters. For an operator who has not been issued Class D citizen's radio
30 station call letters by the Federal Communications Commission, the plate
31 shall bear the phrase "Citizen's Band Radio".
- 32 (30) Clerk of Superior Court. – Issuable to a current or retired clerk of superior
33 court. A plate issued to a current clerk shall bear the phrase "Clerk Superior
34 Court" and the letter "C" followed by a number that indicates the county the
35 clerk serves. A plate issued to a retired clerk shall bear the phrase "Clerk
36 Superior Court, Retired", the letter "C" followed by a number that indicates
37 the county the clerk served, and the letter "X" indicating the clerk's retired
38 status.
- 39 (31) Coast Guard Auxiliary Member. – Issuable to an active member of the
40 United States Coast Guard Auxiliary. The plate shall bear the phrase "Coast
41 Guard Auxiliary".
- 42 (32) Coastal Conservation Association. – Issuable to the registered owner of a
43 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
44 logo and name of the Coastal Conservation Association.
- 45 (33) Cold War Veteran. – Issuable to a veteran of the armed services of the
46 United States who served during the Cold War era, September 2, 1945,
47 through December 26, 1991, and who was separated from the armed services
48 under honorable conditions. The plate shall bear the words "Cold War
49 Veteran" and an insignia representing the Cold War era. The Division may
50 not issue the plate authorized by this subdivision unless it receives at least
51 300 applications for the plate.

- 1 (34) Collegiate Insignia Plate. – Issuable to the registered owner of a motor
2 vehicle in accordance with G.S. 20-81.12. The plate may bear a phrase or an
3 insignia representing a public or private college or university.
- 4 (35) ~~Combat Infantry Action Badge or Ribbon Recipient.~~ – Issuable to a recipient
5 of the ~~Combat Infantry Badge, Action Badge or Ribbon.~~ The plate shall bear
6 ~~the a word or phrase "Combat Infantry Badge" identifying the combat badge~~
7 ~~or ribbon being issued~~ and a representation of the ~~Combat Infantry~~
8 ~~Badge, combat action badge or ribbon awarded.~~ The Division may not issue
9 the plate authorized by this subdivision unless it receives at least 300
10 combined applications for all versions of the plate. This plate shall include,
11 but is not limited to, the following combat action badges and ribbons:
- 12 a. Air Force Combat Action Medal Recipient.
13 b. Combat Action Badge Recipient.
14 c. Combat Action Ribbon Recipient.
15 d. Combat Infantry Badge Recipient.
16 e. Combat Medical Badge Recipient.
- 17 (36) Combat Veteran. – Issuable to a veteran of the Armed Forces who served in
18 a combat zone, or in waters adjacent to a combat zone, during a period of
19 war and who was separated from the Armed Forces under honorable
20 conditions. The Division may not issue the plate authorized by this
21 subdivision unless it receives at least 300 applications for the plate. A
22 "period of war" is any of the following:
- 23 a. World War I, which began April 16, 1917, and ended November 11,
24 1918.
- 25 b. World War II, which began December 7, 1941, and ended December
26 31, 1946.
- 27 c. The Korean Conflict, which began June 27, 1950, and ended January
28 31, 1955.
- 29 d. The Vietnam Era, which began August 5, 1964, and ended May 7,
30 1975.
- 31 e. The Persian Gulf War.
- 32 f. Any other campaign, expedition, or engagement for which the United
33 States Department of Defense authorizes a campaign badge or medal.
- 34 (37) Commercial Fishing. – Issuable to the registered owner of a motor vehicle in
35 accordance with G.S. 20-81.12. The plate may bear a phrase and picture
36 appropriate to the subject of commercial fishing in North Carolina. The
37 Division may not issue the plate authorized by this subdivision unless it
38 receives at least 300 applications for the plate.
- 39 (38) Corvette Club. – Issuable to the registered owner of a motor vehicle. The
40 plate shall bear the flags logo of the Chevrolet Corvette. The Division may
41 not issue the plate authorized by this subdivision unless it receives at least
42 300 applications for the plate.
- 43 (39) County Commissioner. – Issuable to a county commissioner of a county in
44 this State. The plate shall bear the words "County Commissioner" followed
45 first by a number representing the commissioner's county and then by a letter
46 or number that distinguishes plates issued to county commissioners of the
47 same county. The number of a county shall be the order of the county in an
48 alphabetical list of counties that assigns number one to the first county in the
49 list and a letter or number to distinguish different cars owned by the county
50 commissioners in that county. The Division may not issue the plate

- 1 authorized by this subdivision unless it receives at least 300 applications for
2 the plate.
- 3 (40) Crystal Coast. – Issuable to the registered owner of a motor vehicle in
4 accordance with G.S. 20-81.12. The plate shall bear the words "Crystal
5 Coast Artificial Reef Association" and a representation of a SCUBA diving
6 flag.
- 7 (40a) CureSearch. – Issuable to the registered owner of a motor vehicle in
8 accordance with G.S. 20-81.12. The plate shall bear the phrase "CureSearch"
9 with a logo designed by the National Childhood Cancer Foundation.
- 10 (40a) Daniel Stowe Botanical Garden. – Issuable to the registered owner of a
11 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
12 phrase "Daniel Stowe Botanical Garden" with a logo designed by the Daniel
13 Stowe Botanical Garden Foundation, Inc.
- 14 (41) Daughters of the American Revolution. – Issuable to the registered owner of
15 a motor vehicle. The plate may bear a phrase and picture appropriate to the
16 organization. The Division may not issue the plate authorized by this
17 subdivision unless it receives at least 300 applications for the plate.
- 18 (42) Delta Sigma Theta Sorority. – Issuable to the registered owner of a motor
19 vehicle. The plate shall bear the sorority's name and symbol. The Division
20 must receive 300 or more applications for the plate before it may be
21 developed.

49 December 7, 1941. The plate will bear the phrase "Pearl Harbor Survivor"
50 and the insignia of the Pearl Harbor Survivors' Association.

- 1 (109a) P.E.O. Sisterhood. – Issuable to the registered owner of a motor vehicle in
2 accordance with G.S. 20-81.12. The plate shall bear the phrase "P.E.O." and
3 a logo designed by P.E.O. International.
- 4 (110) Personalized. – Issuable to the registered owner of a motor vehicle. The plate
5 will bear the letters or letters and numbers requested by the owner. The
6 Division may refuse to issue a plate with a letter combination that is
7 offensive to good taste and decency. The Division may not issue a plate that
8 duplicates another plate.
- 9 (110a) Phi Beta Sigma Fraternity. – Issuable to the registered owner of a motor

39 accordance with G.S. 20-81.12. The plate shall bear the words "Following In
40 Their Footsteps" and shall bear a picture of a transit.
- 41 (141) Sweet Potato. – Issuable to the registered owner of a motor vehicle. The
42 plate may bear a phrase and picture representing the State's official
43 vegetable, the sweet potato. The Division may not issue the plate authorized
44 by this subdivision unless it receives at least 300 applications for the plate.
- 45 (142) Tarheel Classic Thunderbird Club. – Issuable to the registered owner of a
46 motor vehicle. The plate shall bear the logo of the Tarheel Classic
47 Thunderbird Club and the phrase "Tarheel Classic Thunderbird Club". The
48 Division may not issue the plate authorized by this subdivision unless it
49 receives at least 300 applications for the plate.
- 50 (143) Tobacco Heritage. – Issuable to the registered owner of a motor vehicle. The
51 plate shall bear a picture of a tobacco leaf and plow. The Division may not

- 1 issue the plate authorized by this subdivision unless it receives at least 300

- 3 (143a) Town of Oak Island. – Issuable to the registered owner of a motor vehicle.
4 The plate shall bear the seal of the Town of Oak Island and the letters

6 unless it receives at least 300 applications for the plate.
- 7 (144) Transportation Personnel. – Issuable to various members of the Divisions of
8 the Department of Transportation. The plate shall bear the letters "DOT"
9 followed by a number from 1 to 85, as designated by the Governor.
- 10 (144a) Travel and Tourism. – Issuable to the registered owner of a motor vehicle in
11 accordance with G.S. 20-81.12. The plate shall bear the phrase
12 "www.visitnc.com."
- 13 (144b) United States Service Academy. – Issuable to a graduate of one of the
14 service academies, who can provide documentation of graduation, in
15 accordance with G.S. 20-81.12. The plate shall bear the name of the specific
16 service academy with an emblem that designates the specific service
17 academy being represented.
- 18 (145) US Equine Rescue League. – Issuable to the registered owner of a motor
19 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase
20 "United States Equine Rescue League", and a depiction of two horses in a
21 circle.
- 22 (146) U.S. Navy ~~Specialty~~ Submarine Veteran. – Issuable to a veteran of the
23 United States Navy ~~Submariner~~ Submarine Service. The plate shall bear the
24 phrase "~~Silent Service Veteran~~" "United States Navy Submarine Veteran"
25 and shall bear a representation of the Submarine Service Qualification
26 ~~pin~~ insignia overlaid upon a representation of the State of North Carolina.
27 The Division may not issue the plate authorized by this subdivision unless it
28 receives at least ~~300~~ 150 applications for the plate.
- 29 (147) U.S. Representative. – Issuable to a United States Representative for North
30 Carolina. The plate shall bear the phrase "U.S. House" and shall be issued on
31 the basis of Congressional district numbers.
- 32 (148) U.S. Senator. – Issuable to a United States Senator for North Carolina. The
33 plates shall bear the phrase "U.S. Senate" and shall be issued on the basis of
34 seniority represented by the numbers 1 and 2.
- 35 (149) University Health Systems of Eastern Carolina. – Issuable to the registered
36 owner of a motor vehicle in accordance with G.S. 20-81.12. The plate may
37 bear a phrase or insignia representing the University Health Systems of
38 Eastern Carolina.
- 39 (150) The V Foundation for Cancer Research. – Issuable to the registered owner of
40 a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear a
41 phrase and insignia representing The V Foundation for Cancer Research.
- 42 (151) Veterans of Foreign Wars. – Issuable to a member or a supporter of the
43 Veterans of Foreign Wars. The plate shall bear the words "Veterans of
44 Foreign Wars" or "VFW" and the emblem of the VFW. The Division may
45 not issue the plate authorized by this subdivision unless it receives at least
46 300 applications for the plate.
- 47 (151a) Victory Junction Gang Camp. – Issuable to the registered owner of a motor
48 vehicle. The plate shall bear the phrase "Victory Junction Gang Camp." The
49 Division must receive 300 or more applications for the plate before it may be
50 developed.

(152) Watermelon. – Issuable to the registered owner of a motor vehicle. The plate shall bear a picture representing a slice of watermelon. The Division may not issue the plate authorized by this subdivision unless it receives at least 300 applications for the plate.

(153) Wildlife Resources. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear a picture representing a native wildlife species occurring in North Carolina.

(154) Zeta Phi Beta Sorority. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the sorority's name and symbol.

SECTION 3. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of a Legion of Valor award, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Legion of Valor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

40 ARTS North Carolina, Inc., to provide funding to promote the arts in North Carolina.

2 the Farmland Preservation plate before the plate may be developed. The Division must transfer
3 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
4 sale of Farmland Preservation plates to the North Carolina Agricultural Development and
5 Farmland Preservation Trust Fund established pursuant to G.S. 106-744.

6 (b88) First in Turf. – The Division must receive 300 or more applications for the First in
7 Turf plate before the plate may be developed. The Division shall transfer quarterly the money
8 in the Collegiate and Cultural Attraction Plate Account derived from the sale of First in Turf
9 plates to the Center for Environmental Turfgrass Research at North Carolina State University
10 for its programs.

11 (b89) Friends of Camp Daniel Boone. – The Division must receive 300 or more
12 applications for the Friends of Camp Daniel Boone plate before the plate may be developed.
13 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
14 Account derived from the sale of Friends of Camp Daniel Boone plates to the Daniel Boone
15 Council of the Boy Scouts of America to be used to support Camp Daniel Boone's programs
16 and to pay administrative and operating expenses.

17 (b90) Girl Scouts. – The Division must receive 300 or more applications for the Girl
18 Scouts plate before the plate may be developed. The Division shall transfer quarterly the money
19 in the Collegiate and Cultural Attraction Plate Account derived from the sale of Girl Scouts
20 plates to the Girl Scouts North Carolina Coastal Pines, where the proceeds will be divided
21 equally among the officially chartered Girl Scout Councils in this State to be used for
22 educational programs, preservation programs, capital improvements on facilities located in this
23 State, and related administrative and operating expenses.

24 (b91) Green Industry Council. – The Division must receive 300 or more applications for
25 the Green Industry Council plate before the plate may be developed. The Division shall transfer
26 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
27 sale of Green Industry plates to the Green Industry Council to be used to provide an umbrella
28 of advocacy for green industry issues, the promotion of the green industry, and educational
29 activities.

30 (b92) Home of American Golf. – The Division must receive 300 or more applications for
31 the Home of American Golf plate before the plate may be developed. The Division must
32 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
33 from the sale of Home of American Golf plates to the Given Memorial Library, Inc., to provide
34 funding for the Given Memorial Library – The Tufts Archives.

35 (b93) Jaycees. – The Division must receive 300 or more applications for the Jaycees plate
36 before the plate may be developed. The Division shall transfer quarterly the money in the
37 Collegiate and Cultural Attraction Plate Account derived from the sale of Jaycees plates to the
38 North Carolina JCI Senate, Inc., to be used to support and underwrite Jaycee activities in North
39 Carolina.

40 (b94) Mountains-to-Sea Trail. – The Division must receive 300 or more applications for
41 the Mountains-to-Sea Trail plate before the plate may be developed. The Division shall transfer
42 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
43 sale of Mountains-to-Sea Trail plates to the Friends of the Mountains-to-Sea Trail, Inc., to be
44 used to fund trail projects and related administrative and operating expenses.

45 (b95) National Law Enforcement Officers Memorial. – The Division must receive 300 or
46 more applications for a National Law Enforcement Officers Memorial plate before the plate
47 may be developed. The Division must transfer quarterly the money in the Collegiate and
48 Cultural Attraction Plate Account derived from the sale of National Law Enforcement Officers
49 Memorial plates to the National Law Enforcement Officers Memorial Fund to support the
50 National Law Enforcement Officers Memorial in Washington, D.C.

1 (b96) Native Brook Trout. – The Division must receive 300 or more applications for the
2 Native Brook Trout plate before the plate may be developed. The Division must transfer
3 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
4 sale of Native Brook Trout plates to the North Carolina Wildlife Resources Commission to be
5 used to fund public access to, and habitat protection of, brook trout waters.

6 (b97) NC Beekeepers. – The Division must receive 300 or more applications for the NC
7 Beekeepers plate before the plate may be developed. The Division shall transfer quarterly the
8 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of NC
9 Beekeepers plates to the North Carolina State Beekeepers Association, Inc., to be used to
10 educate the public about the importance of bees to our agricultural economy.

11 (b98) NC Civil War. – The Division must receive 300 or more applications for the NC
12 Civil War plate before the plate may be developed. The Division must transfer quarterly the
13 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of NC
14 Civil War plates to the North Carolina Department of Cultural Resources, Office of Archives
15 and History, to provide funding to acquire, interpret, and preserve North Carolina's Civil War
16 history.

17 (b99) NC Fisheries Association. – The Division must receive 300 or more applications for
18 the NC Fisheries Association plate before the plate may be developed. The Division must
19 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
20 from the sale of NC Fisheries Association plates to the NC Fisheries Association to facilitate
21 the promotion of North Carolina families, heritage, and seafood through accessible data about
22 the ever-changing commercial fishing industry.

23 (b100) NC Horse Council. – The Division must receive 300 or more applications for the
24 NC Horse Council plate before the plate may be developed. The Division shall transfer
25 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
26 sale of NC Horse Council plates to the North Carolina Horse Council, Inc., to promote and
27 enhance the equine industry in North Carolina.

28 (b101) NC Mining. – The Division must receive 300 or more applications for the NC
29 Mining plate before the plate may be developed. The Division must transfer quarterly the
30 money in the Collegiate and Cultural Attraction Plate Account derived from the sale of NC
31 Mining plates to the North Carolina Gold Foundation, Inc., to provide funding for information
32 and education about mining in North Carolina.

33 (b102) NC Veterinary Medical Association. – The Division must receive 300 or more
34 applications for the NC Veterinary Medical Association plate before the plate may be
35 developed. The Division shall transfer quarterly the money in the Collegiate and Cultural
36 Attraction Plate Account derived from the sale of NC Veterinary Medical Association plates to
37 the Friends of NCVMA Foundation, Inc., to be used to provide compassionate, quality health
38 care for all animals, to protect the health of the public, to strengthen the human-animal bond,
39 and to provide advanced continuing education for the public.

40 (b103) NC Wildlife Federation. – The Division must receive 300 or more applications for
41 the NC Wildlife Federation plate before the plate may be developed. The Division shall transfer
42 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
43 sale of NC Wildlife Federation plates to the North Carolina Wildlife Federation, Inc., to
44 provide funding for a grassroots program to involve anglers, hunters, and wildlife enthusiasts in
45 conservation issues affecting North Carolina.

46 (b104) Neuse River Foundation. – The Division must receive 300 or more applications for
47 the Neuse River Foundation plate before the plate may be developed. The Division shall
48 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
49 from the sale of Neuse River Foundation plates to the Neuse River Foundation, Inc., to provide
50 funding for the cleanup, preservation, and oversight of the Neuse River and the river's
51 watersheds and basins.

1 (b105) North Carolina Emergency Management Association. – The Division must receive
2 300 or more applications for the North Carolina Emergency Management Association plate
3 before the plate may be developed. The Division shall transfer quarterly the money in the
4 Collegiate and Cultural Attraction Plate Account derived from the sale of North Carolina
5 Emergency Management Association plates to the North Carolina Emergency Management
6 Association to be used for training and education purposes.

7 (b106) North Carolina Master Gardener. – The Division must receive 300 or more
8 applications for the North Carolina Master Gardener plate before the plate may be developed.
9 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
10 Account derived from the sale of North Carolina Master Gardener plates to the Master
11 Gardener's Endowment fund maintained by the Agricultural Foundation of North Carolina
12 State University, to be used for educational programs by trained volunteers who work in
13 partnership with their county Cooperative Extension offices to extend information in consumer
14 horticulture.

15 (b107) North Carolina Senior Games. – The Division must receive 300 or more
16 applications for the North Carolina Senior Games plate before the plate may be developed. The
17 Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
18 Account derived from the sale of North Carolina Senior Games plates to the North Carolina
19 Senior Games, Inc., to promote senior games in North Carolina.

20 (b108) Outer Banks Preservation Association. – The Division must receive 300 or more
21 applications for an Outer Banks Preservation Association plate before the plate may be
22 developed. The Division must transfer quarterly the money in the Collegiate and Cultural
23 Attraction Plate Account derived from the sale of Outer Banks Preservation Association plates
24 to the Outer Banks Preservation Association to facilitate the protection of the public's right to
25 access beaches in North Carolina.

26 (b109) Pamlico-Tar River Foundation. – The Division must receive 300 or more
27 applications for the Pamlico-Tar River Foundation plate before the plate may be developed.
28 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
29 Account derived from the sale of Pamlico-Tar River Foundation plates to the Pamlico-Tar
30 River Foundation, Inc., to provide funding for the cleanup, preservation, and oversight of the
31 Pamlico and Tar Rivers, and their watersheds and basin.

32 (b110) P.E.O. Sisterhood. – The Division must receive 300 or more applications for the
33 P.E.O. Sisterhood plate before the plate may be developed. The Division shall transfer
34 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
35 sale of P.E.O. Sisterhood plates to P.E.O. International to be used for scholarships for young
36 women.

37 (b111) Phi Beta Sigma Fraternity. – The Division must receive 300 or more applications for
38 the Phi Beta Sigma Fraternity plate before the plate may be developed. The Division shall
39 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
40 from the sale of Phi Beta Sigma Fraternity plates to the Phi Beta Sigma Fraternity, Inc., to
41 provide funding for scholarships, education and professional development, or similar programs.
42 None of the proceeds from this special plate may be distributed to any board member as
43 compensation or as an honorarium.

44 (b112) Retired Piedmont Airlines Employee. – The Division must receive 300 or more
45 applications for a Retired Piedmont Airlines Employee plate before the plate may be
46 developed. The Division must transfer quarterly the money in the Collegiate and Cultural
47 Attraction Plate Account derived from the sale of Retired Piedmont Airlines Employee plates
48 to Piedmont Silver Eagles Charitable Funds, Inc., to be used for scholarships and family
49 assistance for retired Piedmont Airlines employees and their families, including surviving
50 spouses and dependents, suffering economic hardship.

1 (b113) S.T.A.R. – The Division must receive 300 or more applications for the S.T.A.R.
2 plate before the plate may be developed. The Division shall transfer quarterly the money in the
3 Collegiate and Cultural Attraction Plate Account derived from the sale of S.T.A.R. plates to
4 Save the Animals Rescue, Inc., to provide funding to rescue distressed horses.

5 (b114) Support NC Education. – The Division must receive 300 or more applications for
6 the Support NC Education plate before the plate may be developed. The Division shall transfer
7 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
8 sale of Support NC Education plates to the Board of Governors of The University of North
9 Carolina to be used to provide scholarship funding at the 16 constituent universities of The
10 University of North Carolina.

11 (b115) Support Soccer. – The Division must receive 300 or more applications for the
12 Support Soccer plate before the plate may be developed. The Division shall transfer quarterly
13 the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of
14 Support Soccer plates to the North Carolina Soccer Hall of Fame, Inc., to provide funding to
15 promote the sport of soccer in North Carolina.

16 (b116) Travel and Tourism. – The Division must receive 300 or more applications for the
17 Travel and Tourism plate before the plate may be developed. The Division shall transfer
18 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
19 sale of Travel and Tourism plates to the Division of Tourism, Film, and Sports Development to
20 be used for programs in support of travel and tourism in North Carolina.

21 (b117) United States Service Academy. – The Division, with the cooperation of each
22 service academy, shall develop a special plate for each of the service academies. The Division
23 must receive a combined total of 300 or more applications for all the plates authorized by this
24 subsection before a specific service academy plate may be developed. Only graduates of the
25 service academies may receive a special plate upon furnishing the Division proof of graduation.
26 The Division must transfer quarterly the money in the Collegiate and Cultural Attraction Plate
27 Account derived from the sale of United States Service Academy plates to NC Support Our
28 Troops, Inc., to be used to provide support and assistance to the troops and their families."

29 **SECTION 8.** This act is effective when it becomes law.
