1 A BILL TO BE ENTITLED  
2 AN ACT TO PROVIDE FOR ALTERNATIVE MEANS OF TESTIMONY FOR PERSONS  
3 WITH DEVELOPMENTAL DISABILITIES AND PERSONS WITH MENTAL  
4 RETARDATION, AS RECOMMENDED BY THE JOINT STUDY COMMITTEE ON  
5 AUTISM SPECTRUM DISORDER AND PUBLIC SAFETY.

6 The General Assembly of North Carolina enacts:

7 SECTION 1. Article 6 of Chapter 8C of the General Statutes is amended by adding  
8 a new section to read:

9 **"Rule 616. Alternative testimony of witnesses with developmental disabilities or mental  
10 retardation in civil cases and special proceedings.**

11 (a) Definitions. – The following definitions apply to this section:

12 (1) The definitions set out in G.S. 122C-3.

13 (2) "Remote testimony" means a method by which a witness testifies outside of  
14 an open forum and outside of the physical presence of a party or parties.

15 (b) Remote Testimony Authorized. – A person with a developmental disability or a  
16 person with mental retardation who is competent to testify may testify by remote testimony in a  
17 civil proceeding or special proceeding if the court determines by clear and convincing evidence  
18 that the witness would suffer serious emotional distress from testifying in the presence of a  
19 named party or parties or from testifying in an open forum and that the ability of the witness to  
20 communicate with the trier of fact would be impaired by testifying in the presence of a named  
21 party or parties or from testifying in an open forum.

22 (c) Hearing Procedure. – Upon motion of a party or the court's own motion, and for  
23 good cause shown, the court shall hold an evidentiary hearing to determine whether to allow  
24 remote testimony. The hearing shall be recorded unless recordation is waived by all parties.  
25 The presence of the witness is not required at the hearing unless so ordered by the presiding  
26 judge.

27 (d) Order. – An order allowing or disallowing the use of remote testimony shall state  
28 the findings and conclusions of law that support the court's determination. An order allowing  
29 the use of remote testimony also shall do all of the following:

30 (1) State the method by which the witness is to testify.

31 (2) List any individual or category of individuals allowed to be in or required to  
32 be excluded from the presence of the witness during testimony.

33 (3) State any special conditions necessary to facilitate the cross-examination of  
34 the witness.

1           (4) State any condition or limitation upon the participation of individuals in the  
2           presence of the witness during the testimony.

3           (5) State any other conditions necessary for taking or presenting testimony.

4       (e) Testimony. – The method of remote testimony shall allow the trier of fact and all  
5 parties to observe the demeanor of the witness as the witness testifies in a similar manner as if  
6 the witness were testifying in the open forum. Except as provided in this section, the court shall  
7 ensure that the counsel for all parties is physically present where the witness testifies and has a  
8 full and fair opportunity for examination and cross-examination of the witness. In a proceeding  
9 where a party is representing itself, the court may limit or deny the party from being physically  
10 present during testimony if the court finds that the witness would suffer serious emotional  
11 distress from testifying in the presence of the party. A party may waive the right to have  
12 counsel physically present where the witness testifies.

13       (f) Nonexclusive Procedure and Standard. – Nothing in this section shall prohibit the  
14 use or application of any other method or procedure authorized or required by law for the  
15 introduction into evidence of statements or testimony of a person with a developmental  
16 disability or a person with mental retardation."

17       **SECTION 2.** Article 73 of Chapter 15A of the General Statutes is amended by  
18 adding a new section to read:

19 **"§ 15A-1225.2. Witnesses with developmental disabilities or mental retardation; remote**  
20 **testimony.**

21       (a) Definitions. – The following definitions apply to this section:

22           (1) The definitions set out in G.S. 122C-3.

23           (2) "Remote testimony" means a method by which a witness testifies outside of  
24 an open forum and outside of the physical presence of a party or parties.

25       (b) Remote Testimony Authorized. – A person with a developmental disability or a  
26 person with mental retardation who is competent to testify may testify by remote testimony in a  
27 prosecution of a person charged with violating a criminal law of this State and in any hearing or  
28 proceeding conducted under Subchapter II of Chapter 7B of the General Statutes where a  
29 juvenile is alleged to have committed an offense that would be a criminal offense if committed  
30 by an adult if the court determines by clear and convincing evidence that the witness would  
31 suffer serious emotional distress from testifying in the presence of the defendant and that the  
32 ability of the witness to communicate with the trier of fact would be impaired by testifying in  
33 the presence of the defendant.

34       (c) Hearing Procedure. – Upon motion of a party or the court's own motion, and for  
35 good cause shown, the court shall hold an evidentiary hearing to determine whether to allow  
36 remote testimony. The hearing shall be recorded unless recordation is waived by all parties.  
37 The presence of the witness is not required at the hearing unless so ordered by the presiding  
38 judge.

39       (d) Order. – An order allowing or disallowing the use of remote testimony shall state  
40 the findings and conclusions of law that support the court's determination. An order allowing  
41 the use of remote testimony also shall do all of the following:

42           (1) State the method by which the witness is to testify.

43           (2) List any individual or category of individuals allowed to be in or required to  
44 be excluded from the presence of the witness during testimony.

45           (3) State any special conditions necessary to facilitate the cross-examination of  
46 the witness.

47           (4) State any condition or limitation upon the participation of individuals in the  
48 presence of the witness during the testimony.

49           (5) State any other conditions necessary for taking or presenting testimony.

50       (e) Testimony. – The method of remote testimony shall allow the trier of fact and all  
51 parties to observe the demeanor of the witness as the witness testifies in a similar manner as if

1 the witness were testifying in the open forum. The court shall ensure that the counsel for all  
2 parties, except a pro se defendant, is physically present where the witness testifies and has a full  
3 and fair opportunity for examination and cross-examination of the witness. The court shall  
4 ensure that the defendant or juvenile respondent has the ability to communicate privately with  
5 defense counsel during the remote testimony. A party may waive the right to have counsel  
6 physically present where the witness testifies. Nothing in this section shall be construed to limit  
7 the provisions of G.S. 15A-1225.

8 (f) Nonexclusive Procedure and Standard. – Nothing in this section shall prohibit the  
9 use or application of any other method or procedure authorized or required by law for the  
10 introduction into evidence of statements or testimony of a person with a developmental  
11 disability or a person with mental retardation."

12 **SECTION 3.** This act becomes effective December 1, 2009, and applies to any  
13 hearings or trials held on or after that date. Nothing in this act shall be construed to abrogate  
14 any judicial rulings or decisions prior to the effective date of this act that allowed or disallowed  
15 witness testimony in any criminal proceeding or abrogate any judicial rulings that prohibit a  
16 psychological evaluation of an unwilling witness.
