A BILL TO BE ENTITLED

AN ACT TO DEFER THE PROPERTY TAX DUE ON REAL PROPERTY HELD FOR
SALE BY A BUILDER.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 105-273 is amended by adding a new subdivision to read:

"(3a) "Builder" means a taxpayer licensed as a general contractor under G.S. 87-1 and engaged in the business of buying real property, making improvements to it, and then reselling it."

SECTION 2. Article 12 of Chapter 105 of the General Statutes is amended by adding a new section to read:

"§ 105-277.1D. Inventory property tax deferral.

(a) Classification. – A residence owned and constructed by a builder is designated a special class of property under Section 2(2) of Article V of the North Carolina Constitution and is taxable in accordance with this section. For purposes of this section, a "residence" is an improvement, other than remodeling, rehabilitating, or refinishing, by a builder to real property that is intended to be sold and used as an individual's residence, that is unoccupied, and for which a certificate of occupancy authorized by law has been issued.

(b) Deferred Taxes. – A builder may defer the portion of tax imposed on real property that represents the increase in value of the property attributable solely to improvements resulting from the construction by the builder of a residence on the property. The difference between the taxes due under this section and the taxes that would have been payable in the absence of this section are a lien on the real property of the taxpayer as provided in G.S. 105-355(a). The difference in taxes for the fiscal years preceding the current tax year shall be carried forward in the records of the taxing unit or units as deferred taxes. The deferred taxes are due and payable in accordance with G.S. 105-277.1F when the property loses its eligibility for deferral because of the occurrence of a disqualifying event. A disqualifying event occurs at the earliest of (i) when the builder transfers the residence, (ii) when the residence is occupied by the builder or by someone other than the builder with the builder's consent, (iii) five years from the time the improved property was first subject to being listed for taxation by the builder, or (iv) three years from the time the improved property first received the property tax benefit provided by this section. On or before September 1 of each year, the collector shall notify each builder to whom a tax deferral has previously been granted of the accumulated sum of deferred taxes and interest.

1 (c) Creditor Limitations. – A mortgagee or trustee that elects to pay any tax deferred by
2 the builder subject to a mortgage or deed of trust does not acquire a right to foreclose as a result
3 of the election. Except for requirements dictated by federal law or regulation, any provision in a
4 mortgage, deed of trust, or other agreement that prohibits the builder from deferring taxes on
5 property under this section is void.

6 (d) Construction. – This section does not affect the attachment of a lien for personal
7 property taxes against a tax-deferred residence.

8 (e) Application. – An application for property tax relief provided by this section should
9 be filed during the regular listing period but may be filed after the regular listing period upon a
10 showing of good cause by the applicant for failure to make a timely application, as determined
11 and approved by the board of equalization and review or, if that board is not in session, by the
12 board of county commissioners. An untimely application approved under this subsection
13 applies only to property taxes levied by the county or municipality in the calendar year in
14 which the untimely application is filed. Decisions of the county board may be appealed to the
15 Property Tax Commission. Persons may apply for this property tax relief by entering the
16 appropriate information on a form made available by the assessor under G.S. 105-282.1."

17 **SECTION 3.** G.S. 105-277.1F(a) is amended by adding a new subdivision to read:

18 "(2a) G.S. 105-277.1D, the inventory property tax deferral."

19 **SECTION 4.** This act is effective for taxes imposed for taxable years beginning on
20 or after July 1, 2009. Notwithstanding G.S. 105-277.1D(e), an application filed within 60 days
21 of the effective date of this act shall be accepted by the county tax assessor as timely filed.
22 This act is repealed effective for taxes imposed for taxable years beginning on or after July 1,
23 2012. Residences receiving the property tax benefit provided by this act are not affected by the
24 repeal of this act until the occurrence of a disqualifying event.
