A BILL TO BE ENTITLED

AN ACT TO DEDICATE AND ACCEPT CERTAIN PROPERTIES AS PART OF THE
STATE NATURE AND HISTORIC PRESERVE AND TO REMOVE CERTAIN LANDS
FROM THE STATE NATURE AND HISTORIC PRESERVE.

Whereas, Section 5 of Article XIV of the North Carolina Constitution authorizes the
dedication of State and local government properties as part of the State Nature and Historic
Preserve upon acceptance by a law enacted by a three-fifths vote of the members of each house
of the General Assembly and provides for removal of properties from the State Nature and
Historic Preserve by a law enacted by a three-fifths vote of the members of each house of the
General Assembly; and

Whereas, the General Assembly enacted the State Nature and Historic Preserve
Dedication Act, Chapter 443 of the 1973 Session Laws, to prescribe the conditions and
procedures under which properties may be specifically dedicated for the purposes set out in
Section 5 of Article XIV of the North Carolina Constitution; and

Whereas, more than 15,000 acres have been added to the State Parks System since
the last dedication and acceptance of properties as part of the State Nature and Historic
Preserve pursuant to a petition of the Council of State dated May 1, 2007; and

Whereas, in accordance with G.S. 143-260.8, on May 5, 2009, the Council of State
voted to petition the General Assembly to enact a law pursuant to Section 5 of Article XIV of
the North Carolina Constitution to dedicate and accept properties added to the State Parks
System and designated in the petition for inclusion as parts of the State Nature and Historic
Preserve; and

Whereas, as a part of its petition of May 5, 2009, the Council of State also requested
the General Assembly to remove certain properties from the State Nature and Historic
Preserve; and

Whereas, G.S. 113-44.14 provides for additions to, and deletions from, the State
Parks System upon authorization by the General Assembly; Now, therefore,
The General Assembly of North Carolina enacts:

SECTION 1. G.S. 143-260.10 reads as rewritten:

"§ 143-260.10. Components of State Nature and Historic Preserve.

The following are components of the State Nature and Historic Preserve accepted by the
North Carolina General Assembly pursuant to G.S. 143-260.8:

- 1 (1) All lands and waters within the boundaries of the following units of the State
2 Parks System as of ~~1 May 2007~~May 5, 2009: Baldhead Island State Natural
3 Area, Bay Tree Lake State Park, Bear Paw State Natural Area, Beech Creek
4 Bog State Natural Area, Bullhead Mountain State Natural Area, Bushy Lake
5 State Natural Area, Carolina Beach State Park, Carvers Creek State Park,
6 ~~Chimney Rock State Park~~, Cliffs of the Neuse State Park, Chowan Swamp
7 State Natural Area, Deep River State Trail, Dismal Swamp State Park, Elk
8 Knob State Park, Fort Fisher State Recreation Area, Fort Macon State Park,

27 Nature and Historic Preserve by Chapter 450, Section 1 of the 1985 Session
28 Laws. The tract excluded from the State Nature and Historic Preserve under
29 this subdivision is deleted from the State Parks System in accordance with
30 G.S. 113-44.14. The State of North Carolina may only exchange this land for
31 other land for the expansion of William B. Umstead State Park or sell and
32 use the proceeds for that purpose. The State of North Carolina may not
33 otherwise sell or exchange this land.

- 35 (4) All lands within the boundaries of Morrow Mountain State Park as of ~~1 May~~

39 surveyed and platted by Thomas W. Harris R.L.S., on a map dated August
40 27, 1988, and filed in the State Property Office, reference to which is hereby
41 made for a more complete description.

- 43 (6) All land within the boundaries of Crowders Mountain State Park as of ~~1 May~~

46 are deleted from the State Parks System in accordance with G.S. 113-44.14.
47 The State of North Carolina may only exchange this land for other land for
48 the expansion of Crowders Mountain State Park or sell this land and use the
49 proceeds for that purpose. The State may not otherwise sell or exchange this

30 portion of those certain tracts or parcels of land at Jockey's Ridge State Park
31 in Dare County, Nags Head Township, described in Deed Book 227, Page
32 499, and Deed Book 227, Page 501, and containing 33,901 square feet as
33 shown on the survey prepared by Styons Surveying Services entitled "Raw
34 Water Well Site 13 Jockey's Ridge State Park" dated March 7, 2001, and
35 filed in the State Property Office; the portion of that certain tract or parcel of
36 land at Jockey's Ridge State Park in Dare County, Nags Head Township,
37 described in Deed Book 222, Page 726, and containing 42,909 square feet as
38 shown on the survey prepared by Styons Surveying Services entitled "Raw
39 Water Well Site 14 Jockey's Ridge State Park" dated March 7, 2001, and
40 filed in the State Property Office; and the portion of that certain tract or
41 parcel of land at Jockey's Ridge State Park in Dare County, Nags Head
42 Township, described in Deed Book 224, Page 790, and Deed Book 224,
43 Page 794, and containing 34,471 square feet as shown on the survey
44 prepared by Styons Surveying Services entitled "Raw Water Well Site 15
45 Jockey's Ridge State Park" dated March 7, 2001, and filed in the State
46 Property Office.
- 47 (16) All lands and waters located within the boundaries of Mount Jefferson State
48 Natural Area as of ~~1 May 2007~~ May 5, 2009. With respect to the
49 communications tower site on the top of Mount Jefferson and located on that
50 certain tract or parcel of land at Mount Jefferson State Natural Area in Ashe
51 County, West Jefferson Township, described in Deed Book F-3, Page 94, the

1 State may provide space at the communications tower site to State public
2 safety and emergency management agencies for the placement of antennas,
3 repeaters, and other communications devices for public communications
4 purposes. Notwithstanding G.S. 146-29.2, the State may lease space at the
5 communications tower site to local governments in Ashe County for the
6 placement of antennas, repeaters, and other communications devices for
7 public communications purposes. State agencies and local governments that
8 are authorized to place communications devices at the communications
9 tower site pursuant to this subdivision may also locate at or near the
10 communications tower site communications equipment that is necessary for
11 the proper operation of the communications devices. The use of the
12 communications tower site pursuant to this subdivision is authorized by the
13 General Assembly as a purpose other than the public purposes specified in
14 Article XIV, Section 5, of the North Carolina Constitution, Article 25B of
15 Chapter 143 of the General Statutes, and Article 2C of Chapter 113 of the
16 General Statutes.

17 (17) All lands and waters within the Eno River State Park as of ~~1 May 2007~~ May
18 5, 2009, with the exception of the following ~~tract:~~ tracts:

19 a. The portion of that certain tract or parcel of land at Eno River State
20 Park in Durham County, Durham Outside Township, described in
21 Deed Book 435, Page 673, and Plat Book 87, Page 66, containing
22 11,000 square feet and being the portion of Lot No. 2 shown as the
23 existing scenic easement hereby removed on the drawing prepared by
24 Sear-Brown entitled "Recombination Plat Eno Forest Subdivision"
25 bearing the preparer's file name 00-208-07.dwg, and filed with State
26 Property Office. The tract excluded from the State Nature and
27 Historic Preserve under this subdivision is deleted from the State
28 Parks System pursuant to G.S. 113-44.14. The State of North
29 Carolina may only exchange this land for other land for the
30 expansion of Eno River State Park or sell this land and use the
31 proceeds for that purpose. The State may not otherwise sell or
32 exchange this land.

33 b. The portion of that certain tract or parcel of land at Eno River State
34 Park in Orange County, described in Deed Book 3878, Page 461, and
35 Plat Book 98, Page 11, containing 5,313 square feet and required for
36 the permanent easements for bridge replacement project B-4216 on
37 SR 1002 (St. Mary's Road), as shown in the drawing entitled
38 "Preliminary Plans, Project Reference No. B-4216" prepared for
39 North Carolina Department of Transportation by Mulkey Engineers
40 and Consultants dated March 10, 2009, and filed with the State
41 Property Office. The tracts excluded from the State Nature and
42 Historic Preserve under this section are deleted from the State Parks
43 System pursuant to G.S. 113-44.14. The State of North Carolina may
44 only exchange this land for other land for the expansion of Eno River
45 State Park or sell this land and use the proceeds for that purpose. The
46 State may not otherwise sell or exchange this land.

47 (18) All land and waters within the boundaries of Hemlock Bluffs State Natural
48 Area as of ~~1 May 2007~~ May 5, 2009, with the exception of the following
49 tracts: The portion of that certain tract or parcel of land at Hemlock Bluffs
50 State Natural Area in Wake County, Swift Creek Township, described in
51 Deed Book 2461, Page 037, containing 2,025 square feet and being the

1 portion of this tract shown as proposed R/W on the drawing prepared by
2 Titan Atlantic Group entitled "Right of Way Acquisition Map for Town of
3 Cary Widening of Kildaire Farm Road (SR 1300) from Autumgate Drive to
4 Palace Green" sheet 1 of 3 bearing the preparer's file name Town of Cary
5 Case File No. TOC 01-37, dated 26 September 2003, and filed with the State
6 Property Office; and the portion of those certain tracts or parcels of land at
7 Hemlock Bluffs State Natural Area in Wake County, Swift Creek Township,

15 Nature and Historic Preserve under this subdivision are deleted from the
16 State Parks System pursuant to G.S. 113-44.14. The State of North Carolina
17 may only exchange this land for other land for the expansion of Hemlock
18 Bluffs State Natural Area or sell this land and use the proceeds for that
19 purpose. The State may not otherwise sell or exchange this land.

20 (19) All lands and waters within the boundaries of Lake James State Park as of 4
21 ~~May 2007~~, May 5, 2009, with the exception of the following tracts:

22 a. The portion of that certain tract or parcel of land at Lake James State
23 Park containing 13.85 acres, and being 100 feet to the east and 150
24 feet to the west of a centerline shown on a survey by Witherspoon
25 Surveying PLLC, dated February 9, 2007, and filed in the State
26 Property Office. The State of North Carolina may grant a temporary
27 easement to Duke Energy Corporation across this tract to facilitate
28 the Catawba Dam Embankment Seismic Stability Improvements
29 Project. The grant of the easement within Lake James State Park to
30 Duke Energy Corporation under this sub-subdivision constitutes
31 authorization by the General Assembly that the described tract of
32 land may be used for a purpose other than the public purposes
33 specified in Article XIV, Section 5, of the North Carolina
34 Constitution, Article 25B of Chapter 143 of the General Statutes, and
35 Article 2C of Chapter 113 of the General Statutes. The State of North
36 Carolina may use the proceeds from the easement only for the
37 expansion or improvement of Lake James State Park or another State
38 park. The State may not otherwise sell or exchange this land.

39 b. The portion of that certain tract or parcel of land at Lake James State
40 Park in McDowell County, Nebo Township, described in Deed Book
41 377, Page 423, and also shown as Tract B on the plat of survey
42 prepared by Kenneth D. Suttles, RLS, dated December 4, 1987,
43 entitled "Lake James State Park," Sheet 1 of 2, recorded in Plat Book
44 4, Page 275 of the McDowell County Registry, for a 40-foot
45 right-of-way beginning at the southwest corner of Tract B and
46 continuing along the southern boundary S 86 38' 51" E for 400 feet to
47 the now or former John D. Walker property. The State of North
48 Carolina may grant an easement across this tract to extinguish
49 prescriptive easements on Tract B to improve management of the
50 State park property. The State may not otherwise sell or exchange
51 this land. The easement excluded from the State Nature and Historic

- 1 Preserve under this subdivision is deleted from the State Parks
2 System pursuant to G.S. 113-44.14.
- 3 (20) All lands and waters within the boundaries of Lake Waccamaw State Park as
4 of ~~May 1, 2007~~, May 5, 2009, with the exception of the following tracts: The
5 portions of that certain tract or parcel of land at Lake Waccamaw State Park
6 in Columbus County described in Deed Book 835, Page 590, containing
7 48,210 square feet and being the portion of this tract shown as new R/W and
8 permanent utility easement on drawing prepared by State of North Carolina
9 Department of Transportation entitled "Map of Proposed Right of Way
10 Property of State of North Carolina (Parks and Recreation) Columbus
11 County" for Tip B-3830 on SR 1947 (Bella Coola Road) done by John E.
12 Kaukola, PLS No. 3999 and compiled 1-18-2008, and filed with the State
13 Property Office. The tracts excluded from the State Nature and Historic
14 Preserve under this section are deleted from the State Parks System pursuant
15 to G.S. 113-44.14. The State of North Carolina may only exchange this land
16 for other land for the expansion of Lake Waccamaw State Park or sell this
17 land and use the proceeds for that purpose. The State may not otherwise sell
18 or exchange this land.
- 19 (21) All lands and waters within the boundaries of Chimney Rock State Park as
20 of May 5, 2009, with the exception of the following tract: The portion of that
21 certain tract or parcel of land at Chimney Rock State Park in Rutherford
22 County being a portion of Parcel 2 as described in Deed Book 933, Page
23 598, containing 346 square feet and being shown as proposed right-of-way
24 for bridge replacement project B-4258 on U.S. 64 over the Broad River on
25 drawing prepared by Kimley-Horn and Associates for the North Carolina
26 Department of Transportation and revised October 26, 2007, and filed with
27 the State Property Office. The tracts excluded from the State Nature and
28 Historic Preserve under this section are deleted from the State Parks System
29 pursuant to G.S. 113-44.14. The State of North Carolina may only exchange
30 this land for other land for the expansion of Chimney Rock State Park or sell
31 this land and use the proceeds for that purpose. The State may not otherwise
32 sell or exchange this land.
- 33 (22) All State-owned land and waters within the boundaries of the
34 Mountains-to-Sea Trail as of May 5, 2009, with the exception of the
35 following tract: The portion of that certain tract or parcel in Johnston County
36 described in Deed Book 3634, Page 278, containing 4.72 acres and being
37 described as proposed easement area for Piedmont Natural Gas Company
38 transmission line on drawing entitled "Easement Survey Prepared for
39 Piedmont Natural Gas Company, Line 142, Easement to be Acquired from
40 the State of North Carolina" by McKim & Creed and dated July 31, 2008,
41 and revised March 11, 2009. The State of North Carolina may grant an
42 easement to Piedmont Natural Gas Company across this tract to facilitate the
43 transmission of natural gas. The grant of the easement within the
44 Mountains-to-Sea Trail to Piedmont Natural Gas Company under this
45 section constitutes authorization by the General Assembly that the described
46 tract of land may be used for a purpose other than the public purposes
47 specified in Section 5 of Article XIV of the North Carolina Constitution,
48 Article 25B of Chapter 143 of the General Statutes, and Article 2C of
49 Chapter 113 of the General Statutes. The State of North Carolina may use
50 the proceeds from the easement only for the expansion or improvement of

1 the Mountains-to-Sea Trail or another State park. The State may not
2 otherwise sell or exchange this land."
3 **SECTION 2.** This act is effective when it becomes law.
