A BILL TO BE ENTITLED

AN ACT TO ESTABLISH THE DRUG, SUPPLIES, AND MEDICAL DEVICE  
REPOSITORY PROGRAM IN THE NORTH CAROLINA BOARD OF PHARMACY.

The General Assembly of North Carolina enacts:

**SECTION 1.** Part 1 of Article 7 of Chapter 130A of the General Statutes is amended by adding the following new section to read:

**"§ 130A-216. Drug and medical device repository program established.**

(a) As used in this section unless the context clearly requires otherwise, the following definitions apply:

- (1) Board. – The North Carolina Board of Pharmacy.
- (2) Drug. – A human drug required by federal law or regulation to be dispensed only by a prescription, including finished dosage forms and active ingredients subject to 21 U.S.C. § 353(b).
- (3) Dispense. – To deliver a drug to an eligible patient pursuant to the lawful order of a practitioner, including the administering, prescribing, packaging, labeling, or compounding necessary to prepare the drug for that delivery.
- (4) Eligible patient. – An uninsured or underinsured patient who meets the eligibility criteria established by the Department, health care facility, or pharmacy.
- (5) Free clinic facility. – A private, nonprofit, community-based organization that (i) provides health care services at little or no charge to low-income, uninsured, and underinsured persons through the use of volunteer health care professionals and partnerships with other health providers and (ii) is licensed by the State.
- (6) Pharmacist. – A person licensed by the North Carolina Board of Pharmacy to practice pharmacy.
- (7) Pharmaceutical care. – The provision of drug therapy and other patient-care services related to drug therapy intended to achieve definite outcomes that improve a patient's quality of life, including identifying potential and actual drug-related problems, resolving actual drug-related problems, and preventing potential drug-related problems.
- (8) Pharmacy. – A licensed place of business where drugs are compounded or dispensed and pharmaceutical care is provided.

1           (9)   Practitioner or health care practitioner. – A physician or other provider of  
2           health services licensed or otherwise permitted to distribute, dispense, or  
3           administer drugs or medical devices.

4           (10) Supplies. – Supplies associated with or necessary for the administration of a  
5           drug.

6           (b)   The Board shall establish and administer a drug and medical device repository  
7           program (program). The purpose of the program is to allow a patient or the patient's family to  
8           donate unused drugs, supplies to administer the drug, and medical devices to uninsured and  
9           underinsured patients in this State. The unused drugs, supplies, and medical devices shall be  
10          donated to a free clinic facility or pharmacy that elects to participate in the program. A free  
11          clinic facility that receives a donated unused drug, supplies, or medical device under the  
12          program may distribute the drug, supplies, or medical device to another free clinic facility or  
13          pharmacy for use under the program.

14          (c)   A pharmacist may accept and dispense drugs, supplies, and medical devices donated  
15          to the program to eligible patients if all of the following requirements are met:

16           (1)   The drug, supplies, or medical device is in its original, unopened, sealed, and  
17           tamper-evident packaging or, if packaged in single-unit doses, the  
18           single-unit dose packaging is unopened.

19           (2)   The pharmacist has determined that the drug, supplies, or medical device is  
20           safe for redistribution.

21           (3)   The drug bears an expiration date that is later than six months after the date  
22           that the drug was donated.

23           (4)   The drug, supplies, or medical device is not adulterated or misbranded, as  
24           determined by a pharmacist.

25           (5)   The drug, supplies, or medical device is prescribed by a health care  
26           practitioner for use by an eligible patient and is dispensed by a pharmacist.

27          (d)   A drug, supplies, or a medical device donated to the program shall not be resold. A  
28          free clinic facility or pharmacy may charge an eligible patient a handling fee to receive a  
29          donated drug, supplies, or medical device, which shall not exceed the amount specified in rules  
30          adopted by the Board.

31          (e)   Nothing in this section requires a free clinic facility or pharmacy to participate in the  
32          program.

33          (f)   The Board shall establish eligibility criteria for individuals to receive donated drugs,  
34          supplies, or medical devices. Dispensing shall be prioritized to patients who are uninsured or  
35          underinsured. Dispensing to other patients shall be permitted if an uninsured or underinsured  
36          patient is not available.

37          (g)   The Board shall adopt rules necessary for the implementation of the program. Rules  
38          adopted by the Board shall provide for the following:

39           (1)   Requirements for free clinic facilities and pharmacies to accept and dispense  
40           donated drugs, supplies, and medical devices pursuant to the program,  
41           including eligibility criteria and standards and procedures for a free clinic  
42           facility or pharmacy to accept, and safely store and dispense donated drugs  
43           and medical devices.

44           (2)   The amount of the maximum handling fee that a free clinic facility or  
45           pharmacy may charge for distributing or dispensing donated drugs, supplies,  
46           or medical devices.

47           (3)   A list of drugs, supplies to administer drugs, and medical devices, arranged  
48           either by category or by individual drug, supply or medical device, that the  
49           program will accept for dispensing.

50          (h)   Unless a pharmaceutical manufacturer exercises bad faith, the manufacturer is not  
51          subject to criminal or civil liability for injury, death, or loss to a person or property for matters

1 related to the donation, acceptance, or dispensing of a drug or medical device manufactured by  
2 the manufacturer that is donated by any person under the program, including liability for failure  
3 to transfer or communicate product or consumer information or the expiration date of the  
4 donated drug or medical device.

5 (i) The following individuals or entities are immune from civil liability for an act or  
6 omission that causes injury to or the death of an individual to whom the drug, supplies, or  
7 medical device that is dispensed under the program, and no disciplinary action may be taken  
8 against a pharmacist or practitioner as long as the drug, supply, or device is donated in  
9 accordance with the requirements of this section.

10 (1) A pharmacy or free clinic facility participating in the program.

11 (2) A pharmacist dispensing a drug, supply, or medical device pursuant to the  
12 program.

13 (3) A practitioner administering a drug or supply pursuant to the program.

14 (4) The donor of a drug, supply, or medical device donated pursuant to the  
15 program."

16 **SECTION 2.** Article 4A of Chapter 90 of the General Statutes is amended by  
17 adding the following new section to read:

18 **"§ 90-85.42. Pharmacies may elect to participate in the drug and medical device**  
19 **repository program.**

20 A pharmacy operating in this State may elect to participate in the cancer drug and medical  
21 device repository program established under G.S. 130A-216."

22 **SECTION 3.** This act is effective when it becomes law.
