2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE  
3 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE AND  
4 THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND TO APPOINT A  
5 MEMBER OF THE BOARD OF DIRECTORS FOR THE NORTH CAROLINA  
6 PARTNERSHIP FOR CHILDREN, INC., UPON THE RECOMMENDATION OF THE  
7 MINORITY AND MAJORITY LEADERS OF THE SENATE AND THE HOUSE OF  
8 REPRESENTATIVES.

9 Whereas, G.S. 120-121 authorizes the General Assembly to make certain  
10 appointments to public offices upon the recommendation of the President Pro Tempore of the  
11 Senate and the Speaker of the House of Representatives; and

12 Whereas, the President Pro Tempore of the Senate and the Speaker of the House of  
13 Representatives have made recommendations; and

14 Whereas, G.S. 143B-168.12 authorizes the General Assembly to appoint a member  
15 of the public to the Board of Directors of the North Carolina Partnership for Children, Inc.,  
16 upon recommendation of the Minority and Majority Leaders of the Senate and the House of  
17 Representatives; and

18 Whereas, the Minority and the Majority Leaders of the Senate and the House of  
19 Representatives have made recommendations; Now, therefore,  
20 The General Assembly of North Carolina enacts:
