5	SECTION 1. G.S. 143-138(b4) reads as rewritten:	
6	"(b4) <u>Farm Exemption. – Building rules do not apply to (i) farm buildings that are locate</u>	
7	outside the building-rules jurisdiction of any municipality, or (ii) farm buildings that are locate	
8	inside the building-rules jurisdiction of any municipality if the farm buildings are greenhouse	s.
9	For the purposes of this subsection:	
10	(1) A "farm building" shall include any structure used or associated with equir	
11 12	activities, including, but not limited to, the care, management, boarding, of training of homes and the instruction and training of riders.

13 14	standing or attached sheds, barns, or other structures that are utilized to stor	
14	any equipment, tools, commodities, or other items that are maintained of

17	activities, structures, and uses set forth in this subdivision are for illustrativ	
18	purposes, and should not be construed to limit, in any manner, the types of	
19	activities, structures, or uses that may be considered under this subsection a

21	for exemption from building rules shall not be exempt if it is used for	
22	spectator event and more than 10 members of the public are present at the

26	"temporary" means that the spectator event and all other spectate	
27	events in the building have a total duration of no more than 12	<u>20</u>

30	establishes a fire watch for the duration of the event. For purposes of	
31	this subdivision, a fire watch is an employee of the event or	
32	volunteer serving as staff for the event with no job duty other than the building for first on other emergency situations. The first

2	fire department in case of an emergency.
3	(2) A "greenhouse" is a structure that has a glass or plastic roof, has one or more
4	glass or plastic walls, has an area over ninety-five percent (95%) of which is
5	used to grow or cultivate plants, is built in accordance with the National
6	Greenhouse Manufacturers Association Structural Design manual, and is not
7	used for retail sales. Additional provisions addressing distinct life safety
8	hazards shall be approved by the local building-rules jurisdiction."
9	SECTION 2. This act is effective when it becomes law and applies to all farm
10	buildings, including farm buildings where construction either began or was completed prior to

10 11 the effective date of this act.
