17 '(b) Level 1. – A person who is at least 15 years old but less than 18 years old may
18 obtain a limited learner's permit if the person meets all of the following requirements:

- 19 (1) Passes a course of driver education prescribed in ~~G.S. 20-88.1~~ G.S.115C-215
20 or a course of driver instruction at a licensed commercial driver training
21 school.
22 (2) Passes a written test administered by the Division.
23 (3) Has a driving eligibility certificate or a high school diploma or its
24 equivalent.'

27 **SECTION 3.(b)** G.S. 20-322(b) reads as rewritten:

29 '(b) Regulations adopted by the Commissioner shall state the requirements for a school
30 license, including requirements concerning location, equipment, courses of instruction,
31 instructors, financial statements, schedule of fees and charges, character and reputation of the
32 operators, insurance, bond or other security in such sum and with such provisions as the
33 Commissioner deems necessary to protect adequately the interests of the public, and such other


