18 **SECTION 25.1A.** Notwithstanding any other provision of this act, the Lobbyist  
19 Registration and Compliance Division in the Department of Secretary of State and the three  
20 positions that staff those functions shall not be transferred to the State Ethics Commission but  
21 shall remain in the Department of Secretary of State."; and

23 on page 230, lines 21-22, by inserting the following new section between those lines to read:

24 **"ELIMINATE TRANSFER OF THE CAMPAIGN FINANCE DIVISION OF THE**  
25 **STATE BOARD OF ELECTIONS TO THE STATE ETHICS COMMISSION**

26 **SECTION 26.2.** Notwithstanding any other provision of this act, the Campaign  
27 Reporting Division of the State Board of Elections and the 12 positions that staff those  
28 functions shall not be transferred to the State Ethics Commission but shall remain in the State  
29 Board of Elections.";
