2	AN ACT TO PROVIDE GREATER ACCOUNTABILITY FOR NONPROFIT ENTITIES
3	THAT RECEIVE PUBLIC FUNDING.
4	The General Assembly of North Carolina enacts:
5	SECTION 1. Part 2 of Article 16 of Chapter 55A of the General Statutes is
6	amended by adding a new section to read:
7	" <u>§ 55A-16-24. Financial statements for the public.</u>
8	Notwithstanding any provisions in the articles of incorporation or bylaws, a corporation that
9	receives any public funding in the form of grants or loans from a local government, the State,
10	or the federal government shall provide its latest annual financial statements upon written
11	demand from any member of the public. The statements shall be substantively similar to those
12 13	required under G.S. 55A-16-20 but shall contain additional details about the amount of public
13 14	funds received and how those funds were used. Additionally, a corporation that receives public funding shall provide upon written demand from any member of the public a copy of its most
14 15	funding shall provide, upon written demand from any member of the public, a copy of its most recently completed and filed Internal Revenue Service Form 990, except of any information not
15 16	required for public disclosure pursuant to 26 U.S.C. § 6104(d)(3). A corporation may comply
10	with the provisions of this section by maintaining on its public Web site a financial report as
18	described in this section and a copy of its most recent Internal Revenue Service Form 990 or by
19	having such materials posted, as part of a database of similar documents of other tax-exempt
20	organization, on a Web site established and maintained by another entity, provided that the
21	entity does not charge a fee or require Web site registration to access the information."
22	SECTION 2. This act becomes effective October 1, 2011, and applies to nonprofit
23	corporations receiving public funding in the form of grants or loans on or after that date.
