A BILL TO BE ENTITLED

AN ACT TO VOLUNTARILY ANNEX CERTAIN DESCRIBED AREAS TO THE  
CORPORATE LIMITS OF THE CITY OF WILMINGTON.

The General Assembly of North Carolina enacts:

**SECTION 1.** The corporate limits of the City of Wilmington are extended to include the following described area:

Belle Meade Plaza Tract: Commencing at an existing concrete monument in the centerline of St. Andrews Drive at its intersection with the north right-of-way line of U.S. 421 (Carolina Beach Road); thence along and with the north line of Carolina Beach Road South 39 degrees, 30 minutes, 53 seconds East a distance of 501.00 feet to an existing iron pipe, said pipe being the Point of Beginning; thence North 50 degrees, 25 minutes, 51 seconds East a distance of 200.00 feet to a point; thence North 39 degrees, 30 minutes, 53 seconds West a distance of 49.88 feet to an existing iron pipe; thence North 50 degrees, 29 minutes, 05 seconds East a distance of 732.86 feet to a point; thence North 40 degrees, 35 minutes, 47 seconds West a distance of 24.42 feet to a point; thence North 04 degrees, 24 minutes, 13 seconds East a distance of 45.26 feet to a point; thence North 40 degrees, 35 minutes, 46 seconds West a distance of 293.65 feet to a point; thence following along a curve to the left (Arc=50.11', Radius=170.00') a chord which bears North 49 degrees, 02 minutes, 29 seconds West a chord distance of 49.93 feet to a point; thence South 50 degrees, 29 minutes, 21 seconds West a distance of 627.43 feet to a point; thence North 03 degrees, 34 minutes, 31 seconds East a distance of 398.81 feet to a point; thence North 50 degrees, 28 minutes, 31 seconds East a distance of 299.73 feet to an existing iron pipe; thence South 03 degrees, 37 minutes, 27 seconds West a distance of 275.57 feet to an existing iron pipe; thence North 50 degrees, 23 minutes, 26 seconds East a distance of 1384.07 feet to an existing iron pipe; thence North 17 degrees, 05 minutes, 15 seconds East a distance of 225.05 feet to an existing iron pipe; thence South 46 degrees, 53 minutes, 49 seconds East a distance of 595.10 feet to a point; thence South 40 degrees, 53 minutes, 56 seconds West a distance of 39.64 feet to a point located in the Run of Barnard's Creek; thence North 67 degrees, 36 minutes, 33 seconds West a distance of 250.15 feet to a point; thence North 66 degrees, 54 minutes, 20 seconds West a distance of 131.32 feet to a point; thence South 49 degrees, 36 minutes, 10 seconds West a distance of 53.47 feet to a point; thence South 62 degrees, 59 minutes, 20 seconds West a distance of 202.70 feet to a point; thence South 04 degrees, 50 minutes, 57 seconds East a distance of 92.97 feet to a point; thence South 23 degrees, 24 minutes, 26 seconds East a distance of 167.04 feet to an existing iron pipe; thence South 39 degrees, 26 minutes, 08 seconds East a

14 feet to a point located in the north right-of-way line of U.S. 421 (Carolina Beach Road); thence  
15 along and with said north right-of-way line North 39 degrees, 30 minutes, 53 seconds West a  
16 distance of 365.27 feet to an existing iron pipe; thence North 50 degrees, 26 minutes, 55  
17 seconds East a distance of 200.00 feet to an existing iron pipe; thence North 39 degrees, 30  
18 minutes, 53 seconds West a distance of 50.00 feet to an existing iron pipe; thence South 50  
19 degrees, 26 minutes, 55 seconds West a distance of 200.00 feet to an existing R.R. spike  
20 located in the north right-of-way line of U.S. 421 (Carolina Beach Road); thence along and  
21 with said north right-of-way line North 39 degrees, 30 minutes, 53 seconds West a distance of  
22 100.00 feet to the Point of Beginning; containing 34.69 acres, more or less. Subject to all of  
23 Grantor's right, title, and interest, if any, in the following: (1) "Non-exclusive access easement  
24 for ingress and egress" as recorded in Book 4137 Page 0536 at the New Hanover County  
25 Registry. (2) "20' x 50' Bellsouth Easement" as recorded in Book 4639 Page 0721 at the New  
26 Hanover County Registry. (3) "Deed of Easement" for Progress Energy Carolinas, Inc., as  
27 recorded in Book 4169 Page 239 at the New Hanover County Registry. (4) "90-Foot Wide  
28 Carolina Power & Light Company right-of-way" as recorded in Book 3760 Page 405 at the  
29 New Hanover County Registry. (5) "30' Public Sanitary Sewer Easement" per New Hanover  
30 County As-Built of "Sanitary Sewer Locations Johnson Farm" dated January 4, 1987. (6) "30'  
31 Public Sanitary Sewer Easement" per Carolina Power & Light Co. survey map prepared by  
32 Moore, Gardner & Associates, Inc., dated May 1971, revised date: December 16, 1999. Added  
33 sanitary sewer easement per New Hanover County. Together with all of Grantor's right, title,  
34 and interest, if any, in the following: (1) "25' Drainage and Utility Easement" as recorded in  
35 Book 4765 Page 0803 at the New Hanover County Registry. (2) "Deed of Right-of-Way" Tract  
36 1 St. Andrews Place II as recorded in Book 4897 Page 0148 at the New Hanover County  
37 Registry. (3) "Reciprocal Easement" Tract 2 and Tract 3 St. Andrews Place II as recorded in  
38 Book 4897 Page 0156 at the New Hanover County Registry.

39 **SECTION 2.** The corporate limits of the City of Wilmington are extended to  
40 include the following described area:

41 Lockwood Village Apartments Tract: Commencing at an old concrete monument  
42 situated at point and place where the centerline of Greenbriar Road (S.R. 1698, being 60 feet in  
43 width) intersects the easterly right-of-way of South College Road (NC Highway 132, being 200  
44 feet in width) and runs thence N 57-34-35 W, 232.65 feet to an old concrete monument located  
45 in the westerly right-of-way of said College Road, said monument lying at the southeasterly  
46 corner of the United Advent Christian Church, Inc., property (now or formerly) as recorded in  
47 Deed Book 1873, Page 9070; thence along the southerly line of said United Advent Christian  
48 Church, Inc., property N 70-06-47 W, 408.0 feet to the south easterly corner of the Simpson  
49 Property (now or formerly), as recorded in Deed Book 1851, Page 405 and the point and place  
50 of beginning of this description. thence N 70-06-47 W, 331.26 feet to the southeasterly corner  
51 of the Myrtle Properties LLC property (now or formerly) as shown on an easement plat

1 recorded in Map Book 54, Page 277; thence along the southeasterly line of said Myrtle  
2 Properties LLC property N 25-54-03 E, 382.24 feet to a point; thence S 71-37-38 E, 566.40 feet  
3 to a point of the westerly right-of-way of said College Road; thence along the right-of-way of  
4 said College Road S 01-16-52 W, 248.55 feet to a point; thence N 70-06-49 W, 354.29 feet to a  
5 point; thence S 19-53-13 W, 159.54 feet to the point of beginning. The above described parcel  
6 contains 4.42 acres, more or less, and is a combination of record information described in  
7 record deeds (Book/Page) 4962/296, 1905/485, and 1851/405, and is not a result of a boundary  
8 survey. The bearing directions have been rotated to a bearing base as shown on Map Book 54,  
9 Page 277.

10 **SECTION 3.** The corporate limits of the City of Wilmington are extended to  
11 include the following described area:

12 Certain parcel or parcels of land situated in Masonboro Township, New Hanover  
13 County, North Carolina, and being more particularly described as follows: Beginning at a point  
14 on the mean high water line along the eastern bank of the Cape Fear River and the southern  
15 bank and mouth of Barnard's Creek, said point having NC GRID NAD 83(86) coordinates of  
16 North 149760.05 and East 2319807.02 and being located South 62° 54' 02" West 1733.67 feet  
17 from a point in the centerline of Barnard's Creek Bridge on River Road, said centerline point  
18 having NC GRID NAD 83(86) coordinates of North 150478.77 and East 2321328.74, said  
19 point being the true Point of Beginning; thence from said Point of Beginning, along the eastern  
20 bank of said Cape Fear River the following courses and distances: S 01° 07' 11" E 400.25 feet,  
21 S 09° 04' 11" W 68.47 feet, S 00° 19' 35" E 47.79 feet, S 32° 18' 52" W 34.11 feet, S 01° 13' 39"  
22 W 45.88 feet, S 12° 03' 24" W 36.72 feet, S 21° 28' 10" W 25.70 feet, S 00° 06' 15" W 32.82  
23 feet, S 08° 17' 04" W 100.02 feet, S 16° 08' 19" W 98.71 feet, S 38° 12' 53" W 37.66 feet, S 18°  
24 02' 03" W 73.66 feet, S 29° 55' 48" W 119.32 feet, S 27° 01' 35" W 44.69 feet, S 15° 32' 10" W  
25 54.99 feet, S 33° 19' 47" E 108.56 feet, S 13° 01' 34" E 79.17 feet, S 24° 40' 46" E 63.75 feet, S  
26 18° 33' 42" E 75.11 feet, S 13° 21' 04" E 149.64 feet, S 19° 17' 08" E 80.31 feet, S 24° 57' 12" E  
27 72.60 feet, and S 06° 48' 54" E 5.17 feet; thence leaving said eastern bank South 62° 54' 02"  
28 West 880.44 feet to a point; thence North 00° 00' 00" East 1761.24 feet to a point; thence North  
29 62° 54' 02" East 881.82 feet to the Point of Beginning, containing 28.919 acres, more or less.

30 **SECTION 4.** This act becomes effective July 1, 2012.
