15 "(b1) School Personnel. – The chief district court judge shall appoint a magistrate or
16 magistrates to review any application for a warrant for arrest, order for arrest, criminal
17 summons, or other criminal process against a school employee, as defined in G.S. 14-33(c)(6),
18 where the allegation is that the school employee committed a misdemeanor offense while
19 discharging his or her duties of employment. The failure to comply with any of the
20 requirements in this subsection shall not affect the validity of any warrant, order, summons, or
21 other criminal process. The following exceptions apply to the requirements in this subsection:

- 22 (1) The offense is a traffic offense.
23 (2) The offense occurred in the presence of a sworn law enforcement officer.
24 (3) There is no appointed magistrate available to review the application.";


