The executive board shall provide for an annual financial audit unless any of the (b) following conditions are met: Two-thirds of all association members vote not to require an annual audit for (1) that year and an audit is not otherwise required by the association's declaration or bylaws. The association has annual revenues or expenditures of less than hundred (2) thousand dollars (\$100,000) and an audit is not otherwise required by the association's declaration or bylaws.".
