15 Technology Accelerator for FY 2011-2012 and  
16 FY 2012-2013.";

19 and on page H32, Item 177, by reducing the reduction for that Item by \$401,752 for FY 2011-  
20 2012 and FY 2012-2013; and by rewriting the description for that Item to read as follows:  
21 "Reduces the recurring pass-through appropriation for the Rural Center, leaving \$19,646,444 in  
22 recurring funding.";

25 and moves to amend the bill on page 237, lines 35-36, by deleting the phrase "three million  
26 three hundred eighty-four thousand six hundred dollars (\$3,384,600)" and substituting "three




