7 ~~Administrative Code or any member of the General Assembly.~~

8 (b) Code. – The Codifier of Rules shall make available the North Carolina
9 Administrative Code on the Internet at no charge. ~~The Codifier shall distribute copies of the~~
10 ~~North Carolina Administrative Code as soon after publication as practical, without charge, to~~
11 ~~the following:~~

12 (1) ~~One copy to the board of commissioners of each county that specifically requests a~~

14 ~~the board of commissioners. The Codifier of Rules is not required to provide a copy of the~~
15 ~~Administrative Code to any board of county commissioners unless a request is made.~~

17 (3) ~~One copy to the Clerk of the Supreme Court and to the Clerk of the Court of~~
18 ~~Appeals of North Carolina.~~

19 (4) ~~One copy to the Supreme Court Library and one copy to the library of the Court of~~
20 ~~Appeals.~~

21 (5) ~~One copy to the Administrative Office of the Courts.~~

22 (6) ~~One copy to the Governor.~~

23 (7) ~~One copy to the Legislative Services Commission for the use of the General~~


