`§ 150B-21.24. Access to Register and Code.

- Register. The Codifier of Rules shall make available the North Carolina Register on the Internet at no charge. <del>Upon request the Codifier shall provide a free copy of the current</del> volume of the Register to any person who receives a free copy of the North Carolina Administrative Code or any member of the General Assembly.
- Code. The Codifier of Rules shall make available the North Carolina Administrative Code on the Internet at no charge. The Codifier shall distribute copies of the North Carolina Administrative Code as soon after publication as practical, without charge, to the following:
- One copy to the board of commissioners of each county that specifically requests a printed copy, to be placed at the county clerk of court's office or at another place selected by the board of commissioners. The Codifier of Rules is not required to provide a copy of the Administrative Code to any board of county commissioners unless a request is made.
  - One copy to the Commission.
- (3)One copy to the Clerk of the Supreme Court and to the Clerk of the Court of Appeals of North Carolina.
- One copy to the Supreme Court Library and one copy to the library of the Court of (4)Appeals.
  - (5)One copy to the Administrative Office of the Courts.
  - (6)One copy to the Governor.
- 23 (7)One copy to the Legislative Services Commission for the use of the General 24 Assembly.
  - (8)Repealed by Session Laws 2002-97, s. 1, effective August 29, 2002.
  - (9)One copy to the Division of State Library of the Department of Cultural Resources pursuant to G.S. 125-11.7.";
