1	Speaker of the House of Representatives, the initial veterinarian appointed by the North
2	Carolina Veterinary Board, and the initial animal shelter manager appointed by the North
3	Carolina Association of County Commissioners shall serve two-year terms. The remainder of
4	the initial appointees shall serve for four-year terms. Subsequent terms shall be for four years.
5	Initial terms shall begin July 1, 2011.
6	(d) All current members shall continue to serve until the expiration of their terms unless
7	a member is removed or the position becomes vacant, in which case the vacancy shall be filled
8	in accordance with subsection (e) of this section.
9	(e) The appointing authorities provided for in subsection (a) of this section may remove
10	any member for good cause shown and shall fill any vacancies on the Board. Members
11	appointed to fill vacancies shall serve the remainder of the unexpired term and until their
12	successors have been appointed and qualified.
13	(f) Members of the Board shall serve as volunteers and shall not receive reimbursement
14	for expenses.
15	"§ 19A-59.1. Spay/Neuter Donation and Memorial Fund.
16	(a) The Spay/Neuter Donation and Memorial Fund is established as a nonreverting,
17	interest-bearing special account in the Department of Agriculture and Consumer Services. The
18	Fund shall consist of donations, memorials, and other private contributions made to the Fund
19	for the purpose of spaying and neutering dogs and cats in order to reduce the population of
20	unwanted animals in the State. The Fund shall be separate from the Spay/Neuter Account
21	established in G.S. 19A-62. Monies in the Fund shall be used only to reimburse eligible
22	counties, cities, and nonprofit organizations for the direct costs of spay/neuter surgeries for
23	dogs and cats, including feral cats; provided that up to two percent (2%) of the fund annually
24	may be used to defray the administrative costs for the Fund.
25	(b) A county, city, or nonprofit organization is eligible for reimbursement from the
26	Spay/Neuter Donation and Memorial Fund if the Spay/Neuter Advisory Board established in
27	G.S. 19A-59 determines that the county, city, or nonprofit organization offers one or more of
28	the following programs to low-income persons on a year-round basis for the purpose of
29	reducing the cost of spaying and neutering procedures for dogs and cats. For purposes of this
30	section, the term "low-income person" shall mean an individual whose income is less than three
31	hundred percent (300%) of the federal poverty guidelines. Programs offered also shall provide
32	reduced-cost spaying and neutering procedures for feral cats, regardless of the income status of
33	the person presenting the feral cat for spaying or neutering.
34	(1) <u>A spay/neuter clinic operated by the county, city, or nonprofit organization.</u>
35	(2) <u>A spay/neuter clinic operated by a private organization under contract or</u>
36	other arrangement with the county, city, or nonprofit organization.
37	(3) A contract or contracts with one or more veterinarians, whether or not
38	located within the county, to provide reduced-cost spaying and neutering
39	procedures.
40	(4) Subvention of the spaying and neutering costs incurred by pet owners
41	through the use of vouchers or other procedure that provides a discount of
42	the cost of the spaying or neutering procedure fixed by a participating
43	veterinarian or other provider.
44	(5) Subvention of the spaying and neutering costs incurred by persons who
45	adopt a pet from an animal shelter operated by or under contract with the
46	county, city, or nonprofit organization.
47	(c) In February of each year, the Department shall report to the Joint Legislative
48	Commission on Governmental Operations and the Fiscal Research Division on all contributions
49	made to the Fund and all reimbursements made by the Fund as provided in this section."
50	<b>SECTION 2.</b> This act becomes effective July 1, 2011.
