## "USE GOVERNOR'S ADDITIONAL TRANSITION FUNDS TO BOLSTER THE ONE NORTH CAROLINA FUND

**SECTION 7A.(a)** If House Bill 950, 2012 Regular Session of the General Assembly, becomes law, then, notwithstanding any provision of the law to the contrary, no expansion funds shall be appropriated for fiscal year 2012-2013 to fund a reserve for operating expenses and temporary staff for planning, reorganization, and other activities related to the transition of Executive Branch offices.

**SECTION 7A.(b)** If House Bill 950, 2012 Regular Session of the General Assembly, becomes law, then the portion of Section 2.1 of that act setting out the appropriation to the Office of State Budget and Management Reserve for Special Appropriations reads as rewritten:

'OSBM – Reserve for Special Appropriations

1,438,3881,108,388'

**SECTION 7A.(c)** If House Bill 950, 2012 Regular Session of the General Assembly, becomes law, then, notwithstanding any provision of the law to the contrary, the funds appropriated to the One North Carolina Fund shall be nine million three hundred thirty thousand dollars (\$9,330,000) for fiscal year 2012-2013."

**SECTION 7A.(d)** If House Bill 950, 2012 Regular Session of the General Assembly, becomes law, then the portion of Section 2.1 of that act setting out the appropriation to the One North Carolina Fund reads as rewritten:

'One North Carolina Fund
