A BILL TO BE ENTITLED

AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE.

Whereas, G.S. 120-121 authorizes the General Assembly to make certain
appointments to public offices upon the recommendation of the President Pro Tempore of the
Senate; and

Whereas, the President Pro Tempore of the Senate has made recommendations;

Now, therefore,

The General Assembly of North Carolina enacts:

SECTION 1. Effective October 1, 2011, Pierre Crawford of Gaston County is
appointed to the African-American Heritage Commission for a term expiring on September 30,
