1 Moves to amend the bill on page 1, lines 2 through 7, by rewriting the lines to read:

3 "AN ACT TO CREATE THE OFFENSE OF ASSAULT CAUSING PHYSICAL INJURY
4 AGAINST A LAW ENFORCEMENT OFFICER OR DETENTION PERSONNEL AND TO
5 INCREASE THE PENALTY FOR ASSAULT CAUSING PHYSICAL INJURY, AND FOR
6 ASSAULT WITH A DEADLY WEAPON OR INFLECTING SERIOUS BODILY INJURY
7 ON EMERGENCY PERSONNEL.", and

8

9 moves to amend the bill on page 1, lines 9 through 16, by deleting those lines, and substituting
10 the following:

12 **"SECTION 1.** G.S. 14-34.7 is amended to add a new subsection to read:

13 "(c) Unless covered under some other provision of law providing greater punishment, a
14 person is guilty of a Class I felony if the person does either of the following:

15 (1) Assaults a law enforcement officer, probation officer, or parole officer while
16 the officer is discharging or attempting to discharge his or her official duties
17 and inflicts physical injury on the officer.

18 (2) Assaults a person who is employed at a detention facility operated under the
19 jurisdiction of the State or a local government while the employee is in the
20 performance of the employee's duties and inflicts physical injury on the
21 employee.

22 For the purposes of this subsection, "physical injury" includes cuts, scrapes, bruises, or
23 other physical injury which does not constitute serious injury."; and

25 On page 1, by rewriting line 22 to read:

27 "assault or affray causing physical injury on any of the following persons who are
28 discharging or attempting to", and

30 On page 1, line 24, by rewriting the line to read:

32 "(1) An emergency medical technician-technician or other emergency healthcare
33 provider."
