5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 126-23(a) reads as rewritten:

7 "(a) Each department, agency, institution, commission and bureau of the State shall
8 maintain a record of each of its employees, showing the following information with respect to
9 each such employee:

- 10 (1) Name.
11 (2) Age.
12 (3) Date of original employment or appointment to State service.
13 (4) The terms of any contract by which the employee is employed whether
14 written or oral, past and current, to the extent that the agency has the written
15 contract or a record of the oral contract in its possession.
16 (5) Current position.
17 (6) Title.
18 (7) Current salary.
19 (8) Date and amount of each increase or decrease in salary with that department,
20 agency, institution, commission, or bureau.
21 (9) Date and type of each promotion, demotion, transfer, suspension, separation,
22 or other change in position classification with that department, agency,
23 institution, commission, or bureau.
24 ~~(10) Date and general description of the reasons for each promotion with that~~
25 ~~department, agency, institution, commission, or bureau.~~

SECTION 2. G.S. 115C-320(a) reads as rewritten:

"(a) Each local board of education shall maintain a record of each of its employees, showing the following information with respect to each employee:

- (1) Name.
- (2) Age.
- (3) Date of original employment or appointment.
- (4) The terms of any contract by which the employee is employed whether written or oral, past and current, to the extent that the board has the written contract or a record of the oral contract in its possession.
- (5) Current position.
- (6) Title.
- (7) Current salary.
- (8) Date and amount of each increase or decrease in salary with that local board of education.
- (9) Date and type of each promotion, demotion, transfer, suspension, separation, or other change in position classification with that local board of education.
- ~~(10) Date and general description of the reasons for each promotion with that local board of education.~~
- ~~(11) Date and type of each dismissal, suspension, or demotion for disciplinary reasons taken by the local board of education.~~

- (4) The terms of any contract by which the employee is employed whether written or oral, past and current, to the extent that the board has the written contract or a record of the oral contract in its possession.
- (5) Current position.
- (6) Title.
- (7) Current salary.
- (8) Date and amount of each increase or decrease in salary with that community college.
- (9) Date and type of each promotion, demotion, transfer, suspension, separation, or other change in position classification with that community college.

SECTION 4. G.S. 122C-158(b) reads as rewritten:

- (4) The terms of any contract by which the employee is employed whether written or oral, past and current, to the extent that the agency has the written contract or a record of the oral contract in its possession.
- (5) Current position.
- (6) Title.
- (7) Current salary.
- (8) Date and amount of each increase or decrease in salary with that area authority.

(9) Date and type of each promotion, demotion, transfer, suspension, separation, or other change in position classification with that area authority.

~~(10) Date and general description of the reasons for each promotion with that area authority.~~

~~(11) Date and type of each dismissal, suspension, or demotion for disciplinary reasons taken by the area authority.~~

17 **SECTION 8.** G.S. 143-318.16B reads as rewritten:

18 "**§ 143-318.16B. Assessments and awards of attorneys' fees.**

19 (a) In any action brought pursuant to this Article in which a party successfully enjoins a
20 violation of this Article, or succeeds in having a court of competent jurisdiction declare a party
21 in violation of this Article, or succeeds in having a court declare an action taken in violation of
22 this Article as null and void, the court shall allow a party who substantially prevails in seeking
23 compliance by a public body with the requirements of this Article to recover its reasonable
24 attorneys' fees if attributable to that noncompliance. The court may not assess attorneys' fees
25 against the governmental body or governmental unit if the court finds that the governmental
26 body or governmental unit acted in reasonable reliance on any of the following:

- 27 (1) A judgment or an order of a court applicable to the governmental unit or
28 governmental body.
29 (2) The published opinion of an appellate court, an order of the North Carolina
30 Business Court, or a final order of the Trial Division of the General Court of
31 Justice.
32 (3) A written opinion, decision, or letter of the Attorney General.

33 The court may order that all or any portion of any fee assessed be paid personally by any
34 individual member or members of the public body found by the court to have knowingly or
35 intentionally committed the violation; provided that no order against any individual member
36 shall issue in any case where the public body or that individual member seeks the advice of an
37 attorney and such advice is followed.

38 (b) Notwithstanding subsection (a) of this section, the court may not assess attorneys'
39 fees against a public hospital created under Article 2 of Chapter 131E of the General Statutes if
40 the court finds that the action was brought by, or on behalf of, a competing health care provider
41 for obtaining information to be used to gain a competitive advantage.

42 ~~When an action is brought pursuant to G.S. 143-318.16 or G.S. 143-318.16A, the court may~~
43 ~~make written findings specifying the prevailing party or parties, and may award the prevailing~~
44 ~~party or parties a reasonable attorney's fee, to be taxed against the losing party or parties as part~~
45 ~~of the costs. The court may order that all or any portion of any fee as assessed be paid~~
46 ~~personally by any individual member or members of the public body found by the court to have~~
47 ~~knowingly or intentionally committed the violation; provided, that no order against any~~
48 ~~individual member shall issue in any case where the public body or that individual member~~
49 ~~seeks the advice of an attorney, and such advice is followed."~~

50 **SECTION 9.** This act becomes effective December 1, 2013.
