4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 7B-101 reads as rewritten:

6 "§ 7B-101. Definitions.

7 As used in this Subchapter, unless the context clearly requires otherwise, the following
8 words have the listed meanings:

9 ...

10 (5) ~~Community based program. — A program providing nonresidential or~~
11 ~~residential treatment to a juvenile in the community where the juvenile's~~
12 ~~family lives. A community based program may include specialized foster~~
13 ~~care, family counseling, shelter care, and other appropriate treatment.~~

14 ...

15 (8) Custodian. — The person or agency that has been awarded legal custody of a
16 juvenile by a court or a person, other than parents or legal guardian, who has
17 assumed the status and obligation of a parent without being awarded the
18 legal custody of a juvenile by a court.

19 (9) Dependent juvenile. — A juvenile in need of assistance or placement because
20 (i) the juvenile has no parent, guardian, or custodian responsible for the
21 juvenile's care or supervision or whose (ii) the juvenile's parent, guardian, or
22 custodian is unable to provide for the juvenile's care or supervision and lacks
23 an appropriate alternative child care arrangement.

24 ...

25 (18b) Return home or reunification. — Placement of the juvenile in the home of
26 either parent or placement of the juvenile in the home of a guardian or
27 custodian from whose home the child was removed by court order.

28 ...

29 (20) ~~Shelter care. — The temporary care of a juvenile in a physically unrestricting~~
30 ~~facility pending court disposition.~~

31 ...

32 The singular includes the plural, the masculine singular includes the feminine singular and
33 masculine and feminine plural unless otherwise specified."

34 SECTION 2. G.S. 7B-200(b) reads as rewritten:

35 "(b) The court shall have jurisdiction over the ~~parent or guardian~~parent, guardian,
36 custodian, or caretaker of a juvenile who has been adjudicated abused, neglected, or dependent,



1 as ~~provided by G.S. 7B-904,~~ provided the ~~parent or guardian~~parent, guardian, custodian, or
 2 caretaker has (i) been properly served with summons pursuant to ~~G.S. 7B-406.~~G.S. 7B-406, (ii)
 3 waived service of process, or (iii) automatically become a party pursuant to G.S. 7B-401.1(c) or
 4 (d)."

5 **SECTION 3.** G.S. 7B-311(b)(2) reads as rewritten:

6 "(b) The Department shall also maintain a list of responsible individuals. The
 7 Department may provide information from this list to child caring institutions, child placing
 8 agencies, group home facilities, and other providers of foster care, child care, or adoption
 9 services that need to determine the fitness of individuals to care for or adopt children. The
 10 name of an individual who has been identified as a responsible individual shall be placed on the
 11 responsible individuals list only after one of the following:

12 ...

13 (2) The court determines that the individual is a responsible individual as a
 14 result of a hearing ~~either on the individual's petition for judicial review.~~

15 a. ~~On the individual's petition for judicial review; or~~

16 b. ~~On a juvenile petition that alleges and seeks a determination that the~~
 17 ~~individual is a responsible person.~~

18"

19 **SECTION 4.** G.S. 7B-320 reads as rewritten:

20 "**§ 7B-320. Notification to individual determined to be a responsible individual.**

21 (a) Within five working days after the completion of an investigative assessment
 22 response that results in a determination of abuse or serious neglect and the identification of a
 23 responsible individual, the director shall personally deliver written notice of the determination
 24 to the identified individual.

25 (b) If personal written notice is not made within 15 days of the
 26 ~~determination,~~determination and the director has made diligent efforts to locate the identified
 27 individual, the director shall send the notice to the ~~identified~~individual by registered or
 28 certified mail, ~~restricted delivery,~~return receipt requested, and addressed to the individual at
 29 the individual's last known address.

30 (c) The notice shall include all of the following:

31 (1) A statement informing the individual of the nature of the investigative
 32 assessment response and whether the director determined abuse or serious
 33 neglect or both.

34 (1a) A statement that the individual has been identified as a responsible
 35 individual.

36 (2) A statement summarizing the substantial evidence supporting the director's
 37 determination without identifying the reporter or collateral contacts.

38 (3) A statement informing the individual that unless the individual petitions for
 39 judicial review, the individual's name will be placed on the responsible
 40 individuals list as provided in G.S. 7B-311, and that the Department of
 41 Health and Human Services may provide information from this list to child
 42 caring institutions, child placing agencies, group home facilities, and other
 43 providers of foster care, child care, or adoption services that need to
 44 determine the fitness of individuals to care for or adopt children.

45 (4) A clear description of the actions the individual must take to seek judicial
 46 review of the director's determination.

47 (d) In addition to the notice, the director shall provide the individual with a copy of a
 48 petition for judicial review ~~form and instructions for how to file and serve the petition form.~~"

49 **SECTION 5.** G.S. 7B-323 reads as rewritten:

50 "...

1 (a1) If the director cannot show that the individual has received actual notice, the
2 director shall not place the individual on the responsible individuals list until an ex parte
3 hearing is held at which a district court judge determines that the director made diligent efforts
4 to find the individual. A finding that the individual is evading service is relevant to the
5 determination that the director made diligent efforts.

6 (b) The clerk of court shall maintain a separate docket for judicial review actions. Upon
7 the filing of a petition for judicial review, the clerk shall calendar the matter for hearing within
8 ~~15-45~~ days from the date the petition is filed at a session of district court hearing juvenile
9 matters or, if there is no such session, at the next session of juvenile court. The clerk shall send
10 notice of the hearing to the petitioner and to the director who determined the abuse or serious
11 neglect and identified the individual as a responsible individual. Upon the request of a party,
12 the court shall close the hearing to all persons, except officers of the court, the parties, and their
13 witnesses. At the hearing, the director shall have the burden of proving by a preponderance of
14 the evidence the abuse or serious neglect and the identification of the individual seeking
15 judicial review as a responsible individual. The hearing shall be before a judge without a jury.
16 The rules of evidence applicable in civil cases shall apply. However, the court, in its discretion,
17 may permit the admission of any reliable and relevant evidence if the general purposes of the
18 rules of evidence and the interests of justice will best be served by its admission.

19 "

20 **SECTION 6.** G.S. 7B-324 reads as rewritten:

21 **"§ 7B-324. Persons ineligible to petition for judicial review; ~~stay of judicial review~~**
22 **~~proceeding pending juvenile court case.~~ review.**

23 (a) An individual who has been identified by a director as a responsible individual may
24 not petition for judicial review if any of the following apply:

25 (1) The individual is criminally convicted as a result of the same incident. The
26 district attorney shall inform the director of the result of the criminal
27 proceeding.

28 (2) ~~The individual is a respondent in a juvenile court proceeding regarding~~
29 ~~abuse or neglect resulting from the same incident that concludes with an~~
30 ~~adjudication of abuse or neglect and a determination that the individual has~~
31 ~~abused or seriously neglected the juvenile and is a responsible individual.~~

32 (3) Repealed by Session Laws 2010-90, s. 8, effective July 11, 2010.

33 (4) After proper notice, the individual fails to file a petition for judicial review
34 with the district court in a timely manner.

35 (5) Repealed by Session Laws 2010-90, s. 8, effective July 11, 2010.

36 (b) If an individual seeking judicial review is named as a respondent in a juvenile court
37 case or a defendant in a criminal court case resulting from the same incident, the district court
38 judge may stay the judicial review ~~proceeding or consolidate the proceeding with the juvenile~~
39 ~~court case. If the juvenile court case is involuntarily dismissed, or concludes without an~~
40 ~~adjudication of abuse or neglect and a determination that the individual has abused or seriously~~
41 ~~neglected a juvenile and is a responsible individual, the director shall not place the individual's~~
42 ~~name on the responsible individuals list. If a juvenile court case concludes with an adjudication~~
43 ~~of abuse or neglect and a determination that the individual has abused or seriously neglected a~~
44 ~~juvenile and is a responsible individual, the director shall place that individual's name on the~~
45 ~~responsible individuals list, consistent with the court's order.~~ proceeding."

46 **SECTION 7.** G.S. 7B-400 reads as rewritten:

47 **"§ 7B-400. Venue.**

48 (a) A proceeding in which a juvenile is alleged to be abused, neglected, or dependent
49 may be commenced in the district in which the juvenile resides or is present. Notwithstanding
50 G.S. 153A-257, the absence of a juvenile from the juvenile's home pursuant to a protection plan
51 during an assessment or the provision of case management services by a department of social

1 services shall not change the original venue if it subsequently becomes necessary to file a
2 juvenile petition.

3 (b) When the director in one county conducts an assessment pursuant to G.S. 7B-302 in
4 another county because a conflict of interest exists, the director in the county conducting the
5 assessment may file a resulting petition in either county.

6 (c) For good cause, the court may grant motion for change of venue before
7 adjudication. A pre-adjudication change of venue shall not affect the identity of the petitioner.

8 (d) Any change of venue after adjudication shall be pursuant to G.S. 7B-900.1."

9 **SECTION 8.** G.S. 7B-401 reads as rewritten:

10 **"§ 7B-401. Pleading and process.**

11 (a) The pleading in an abuse, neglect, or dependency action is the petition. The process
12 in an abuse, neglect, or dependency action is the summons.

13 (b) If the court has retained jurisdiction over a juvenile whose custody was granted to a
14 parent and there are no periodic judicial reviews of the placement, the provisions of Article 8 of
15 this subchapter shall apply to any subsequent report of abuse, neglect, or dependency
16 determined by the director of social services to require court action pursuant to G.S. 7B-302."

17 **SECTION 9.** Article 4 of Chapter 7B of the General Statutes is amended by adding
18 the following new section to read:

19 **"§ 7B-401.1. Parties.**

20 (a) Petitioner. – Only a county director of social services or the director's authorized
21 representative may file a petition alleging that a juvenile is abused, neglected, or dependent.
22 The petitioner shall remain a party until the court terminates its jurisdiction in the case.

23 (b) Parents. – The juvenile's parent shall be a party unless one of the following applies:

24 (1) The parent's rights have been terminated.

25 (2) The parent has relinquished the juvenile for adoption, unless the court orders
26 that the parent be made a party.

27 (3) The parent has been convicted under G.S. 14-27.2 or G.S. 14-27.3 for an
28 offense that resulted in the conception of the juvenile.

29 (c) Guardian. – A person who is the child's court-appointed guardian of the person or
30 general guardian when the petition is filed shall be a party. A person appointed as the child's
31 guardian pursuant to G.S. 7B-600 shall automatically become a party, but only if the court has
32 found that the guardianship is the permanent plan for the juvenile.

33 (d) Custodian. – A person who is the juvenile's custodian, as defined in G.S. 7B-101(8),
34 when the petition is filed shall be a party. A person to whom custody of the juvenile is awarded
35 in the juvenile proceeding shall automatically become a party, but only if the court has found
36 that the custody arrangement is the permanent plan for the juvenile.

37 (e) Caretaker. – A caretaker shall be a party only if (i) the petition includes allegations
38 relating to the caretaker, (ii) the caretaker has assumed the status and obligation of a parent, or
39 (iii) the court orders that the caretaker be made a party.

40 (f) The Juvenile. – The juvenile shall be a party.

41 (g) Removal of a Party. – If a guardian, custodian, or caretaker is a party, the court may
42 discharge that person from the proceeding, making the person no longer a party, if the court
43 finds that the person does not have legal rights that may be affected by the action and that the
44 person's continuation as a party is not necessary to meet the juvenile's needs.

45 (h) Intervention. – Except as provided in G.S. 7B-1103(b), the court shall not allow
46 intervention by a person who is not the juvenile's parent, guardian, custodian, or caretaker, but
47 may allow intervention by another county department of social services that has an interest in
48 the proceeding. This section shall not prohibit the court from consolidating a juvenile
49 proceeding with a civil action or claim for custody pursuant to G.S. 7B-200."

50 **SECTION 10.** G.S. 7B-402 reads as rewritten:

51 **"§ 7B-402. Petition.**

1 (a) The petition shall contain the name, date of birth, address of the juvenile, the name
2 and last known address of ~~the juvenile's parent, guardian, or custodian,~~each party as determined
3 by G.S. 7B-401.1, and allegations of facts sufficient to invoke jurisdiction over the juvenile. A
4 ~~petition alleging that a juvenile is abused or neglected may also allege and seek a determination~~
5 ~~that a respondent is a responsible individual as defined in G.S. 7B-101(18a). A person whose~~
6 ~~actions resulted in a conviction under G.S. 14-27.2 or G.S. 14-27.3 and the conception of the~~
7 ~~juvenile need not be named in the petition.~~ The petition may contain information on more than
8 one juvenile when the juveniles are from the same home and are before the court for the same
9 reason.

10 (b) The petition, or an affidavit attached to the petition, shall contain the information
11 required by G.S. 50A-209.

12 (c) Sufficient copies of the petition shall be prepared so that copies will be available for
13 ~~each parent if living separate and apart, the guardian, custodian, or caretaker,~~party named in the
14 petition, except the juvenile, and for the juvenile's guardian ad litem, the social worker, and any
15 person determined by the court to be a necessary party.

16 (d) If the petition is filed in a county other than the county of the juvenile's residence,
17 the petitioner shall provide a copy of the petition and any notices of hearing to the director of
18 the department of social services in the county of the juvenile's residence."

19 **SECTION 11.** G.S. 7B-406 reads as rewritten:

20 "**§ 7B-406. Issuance of summons.**

21 (a) Immediately after a petition has been filed alleging that a juvenile is abused,
22 neglected, or dependent, the clerk shall issue a summons to ~~the parent, guardian, custodian, or~~
23 ~~caretaker~~each party named in the petition, except the juvenile, requiring them to appear for a
24 hearing at the time and place stated in the summons. ~~No summons is required for any person~~
25 ~~whose actions resulted in a conviction under G.S. 14-27.2 or G.S. 14-27.3 and the conception~~
26 ~~of the juvenile.~~ A copy of the petition shall be attached to each summons. Service of the
27 summons shall be completed as provided in G.S. 7B-407, but the parent of the juvenile shall
28 not be deemed to be under a disability even though the parent is a minor.

29 (b) A summons shall be on a printed form supplied by the Administrative Office of the
30 Courts and shall include each of the following:

- 31 (1) Notice of the nature of the proceeding.
- 32 (2) Notice of any right to counsel and information about how ~~to a parent may~~
33 seek the appointment of counsel prior to a ~~hearing.~~hearing if provisional
34 counsel is not identified.
- 35 (2a) ~~Notice that, if the petition alleges and the court determines that the~~
36 ~~respondent is a responsible individual, the respondent's name will be placed~~
37 ~~on the responsible individuals list as provided in G.S. 7B-311, and that the~~
38 ~~Department of Health and Human Services may provide information from~~
39 ~~the list to child caring institutions, child placing agencies, group home~~
40 ~~facilities, and other providers of foster care, child care, or adoption services~~
41 ~~that need to determine the fitness of individuals to care for or adopt children.~~
- 42 (3) Notice that, if the court determines at the hearing that the allegations of the
43 petition are true, the court will conduct a dispositional hearing to consider
44 the needs of the juvenile and enter an order designed to meet those needs and
45 the objectives of the State.
- 46 (4) Notice that the dispositional order or a subsequent order:
 - 47 a. May remove the juvenile from the custody of the parent, guardian, or
48 custodian.
 - 49 b. May require that the juvenile receive medical, psychiatric,
50 psychological, or other treatment and that the parent participate in the
51 treatment.

- 1 c. May require the parent to undergo psychiatric, psychological, or
2 other treatment or counseling for the purpose of remedying the
3 behaviors or conditions that are alleged in the petition or that
4 contributed to the removal of the juvenile from the custody of that
5 person.
6 d. May order the parent to pay for treatment that is ordered for the
7 juvenile or the parent.
8 e. May, upon proper notice and hearing and a finding based on the
9 criteria set out in G.S. 7B-1111, terminate the parental rights of the
10 respondent parent.

11 (c) The summons shall advise the parent that upon service, jurisdiction over that person
12 is obtained and that failure to comply with any order of the court pursuant to G.S. 7B-904 may
13 cause the court to issue a show cause order for contempt.

14 (d) A summons shall be directed to the person summoned to appear and shall be
15 delivered to any person authorized to serve process."

16 **SECTION 12.** G.S. 7B-407 reads as rewritten:

17 **"§ 7B-407. Service of summons.**

18 The summons shall be served under G.S. 1A-1, Rule 4(j) upon the parent, guardian,
19 custodian, or caretaker, not less than five days prior to the date of the scheduled hearing. The
20 time for service may be waived in the discretion of the court.

21 ~~If the parent, guardian, custodian, or caretaker entitled to receive a summons cannot be~~
22 ~~found by a diligent effort, the court may authorize service of the summons and petitions~~service
23 by publication under G.S. 1A-1, Rule 4(j1). The Rule 4(j1) is required, the cost of the service by
24 publication shall be advanced by the petitioner and may be charged as court costs as the court
25 may direct.

26 ~~If the parent, guardian, custodian, or caretaker is served as herein provided and fails without~~
27 ~~reasonable cause to appear and to bring the juvenile before the court, the parent, guardian,~~
28 ~~custodian, or caretaker may be proceeded against as for contempt of court."~~

29 **SECTION 13.** G.S. 7B-505 reads as rewritten:

30 **"§ 7B-505. Place of Placement while in nonsecure custody.**

31 (a) A juvenile meeting the criteria set out in G.S. 7B-503 may be placed in nonsecure
32 custody with the department of social services or a person designated in the order for temporary
33 residential placement in:

- 34 (1) A licensed foster home or a home otherwise authorized by law to provide
35 such care; or
36 (2) A facility operated by the department of social services; or
37 (3) Any other home or facility, including a relative's home approved by the
38 court and designated in the order.

39 (b) In placing a juvenile in nonsecure custody under this section, the court shall first
40 consider whether a relative of the juvenile is willing and able to provide proper care and
41 supervision of the juvenile in a safe home. If the court finds that the relative is willing and able
42 to provide proper care and supervision in a safe home, then the court shall order placement of
43 the juvenile with the relative unless the court finds that placement with the relative would be
44 contrary to the best interests of the juvenile.

45 (c) If the court does not place the juvenile with a relative, the court may consider
46 whether nonrelative kin is willing and able to provide proper care and supervision of the
47 juvenile in a safe home. Nonrelative kin is an individual having a substantial relationship with
48 the juvenile. In the case of a juvenile member of a State-recognized tribe as set forth in
49 G.S. 143B-407(a), nonrelative kin also includes any member of a State-recognized tribe or a
50 member of a federally recognized tribe, whether or not there is a substantial relationship with
51 the juvenile. The court may order the Department to notify the juvenile's State-recognized tribe

1 of the need for nonsecure custody for the purpose of locating relatives or nonrelative kin for
2 placement. The court may order placement of the juvenile with nonrelative kin if the court finds
3 the placement is in the juvenile's best interests.

4 (d) In placing a juvenile in nonsecure custody under this section, the court shall also
5 consider whether it is in the juvenile's best interest to remain in the juvenile's community of
6 residence. In placing a juvenile in nonsecure custody under this section, the court shall consider
7 the Indian Child Welfare Act, Pub. L. No. 95-608, 25 U.S.C. §§ 1901, et seq., as amended, and
8 the Howard M. Metzenbaum Multiethnic Placement Act of 1994, Pub. L. No. 103-382, 108
9 Stat. 4056, as amended, as they may apply. Placement of a juvenile with a relative outside of
10 this State must be in accordance with the Interstate Compact on the Placement of Children,
11 Article 38 of this Chapter."

12 **SECTION 14.** G.S. 7B-506 reads as rewritten:

13 **"§ 7B-506. Hearing to determine need for continued nonsecure custody.**

14 ...

15 (b) At a hearing to determine the need for continued custody, the court shall receive
16 testimony and shall allow the guardian ad litem, or juvenile, and the juvenile's parent, guardian,
17 custodian, or caretaker the right to introduce evidence, to be heard in the person's own behalf,
18 and to examine witnesses. The ~~State~~petitioner shall bear the burden at every stage of the
19 proceedings to provide clear and convincing evidence that the juvenile's placement in custody
20 is necessary. The court shall not be bound by the usual rules of evidence at such hearings.

21 ...

22 (g) ~~Reserved.~~In addition to the hearings required under this section, any party may
23 schedule a hearing on the issue of placement.

24 (h) At each hearing to determine the need for continued custody, the court ~~shall~~shall
25 determine the following:

26 (1) Inquire as to the identity and location of any missing parent and ~~as to~~
27 whether paternity is at issue. The court shall include findings as to the efforts
28 undertaken to locate the missing parent and to serve that parent, as well as
29 efforts undertaken to establish paternity when paternity is an issue. The order
30 may provide for specific efforts aimed at determining the identity and
31 location of any missing parent, as well as specific efforts aimed at
32 establishing paternity.

33 (2) Inquire about efforts made to identify and notify relatives as potential
34 resources for placement or support and as to whether a relative of the
35 juvenile is willing and able to provide proper care and supervision of the
36 juvenile in a safe home. If the court finds that the relative is willing and able
37 to provide proper care and supervision in a safe home, then the court shall
38 order temporary placement of the juvenile with the relative unless the court
39 finds that placement with the relative would be contrary to the best interests
40 of the juvenile. In placing a juvenile in nonsecure custody under this section,
41 the court shall consider the Indian Child Welfare Act, Pub. L. No. 95-608,
42 25 U.S.C. §§ 1901, et seq., as amended, and the Howard M. Metzenbaum
43 Multiethnic Placement Act of 1994, Pub. L. No. 103-382, 108 Stat. 4056, as
44 amended, as they may apply. Placement of a juvenile with a relative outside
45 of this State must be in accordance with the Interstate Compact on the
46 Placement of Children set forth in Article 38 of this ~~Chapter~~Chapter.

47 (2a) If the court does not place the juvenile with a relative, the court may
48 consider whether nonrelative kin is willing and able to provide proper care
49 and supervision of the juvenile in a safe home. Nonrelative kin is an
50 individual having a substantial relationship with the juvenile. In the case of a
51 juvenile member of a State-recognized tribe as set forth in G.S. 143B-407(a),

1 nonrelative kin also includes any member of a State-recognized tribe or a
2 member of a federally recognized tribe, whether or not there is a substantial
3 relationship with the juvenile. The court may order the Department to notify
4 the juvenile's State-recognized tribe of the need for nonsecure custody for
5 the purpose of locating relatives or nonrelative kin for placement. The court
6 may order placement of the juvenile with nonrelative kin if the court finds
7 the placement is in the juvenile's best interests.

- 8 (3) Inquire as to whether there are other juveniles remaining in the home from
9 which the juvenile was removed and, if there are, inquire as to the specific
10 findings of the assessment conducted under G.S. 7B-302 and any actions
11 taken or services provided by the director for the protection of the other
12 juveniles."

13 **SECTION 15.** G.S. 7B-507(c) reads as rewritten:

14 "(c) When the court determines that reunification efforts are not required or shall cease,
15 the court shall order a plan for permanence as soon as possible, after providing each party with
16 a reasonable opportunity to prepare and present evidence. If the court's determination to cease
17 reunification efforts is made in a hearing that was duly and timely noticed as a permanency
18 planning hearing, then the court may immediately proceed to consider all of the criteria
19 contained in ~~G.S. 7B-907(b)~~, G.S. 7B-906.1(e), make findings of fact, and set forth the best plan
20 of care to achieve a safe, permanent home within a reasonable period of time. If the court's
21 decision to cease reunification efforts arises in any other hearing, the court shall schedule a
22 subsequent hearing within 30 days to address the permanent plan in accordance with
23 ~~G.S. 7B-907~~, G.S. 7B-906.1. At any hearing at which the court orders that reunification efforts
24 shall cease, the affected parent, guardian, or custodian may give notice to preserve the right to
25 appeal that order in accordance with G.S. 7B-1001. The party giving notice shall be permitted
26 to make a detailed offer of proof as to any evidence that party sought to offer in opposition to
27 cessation of reunification that the court refused to admit."

28 **SECTION 16.** G.S. 7B-600 reads as rewritten:

29 **"§ 7B-600. Appointment of guardian.**

30 (a) In any case when no parent appears in a hearing with the juvenile or when the court

36 consent to certain actions on the part of the juvenile in place of the parent including (i)
37 marriage, (ii) enlisting in the Armed Forces of the United States, and (iii) enrollment in school.
38 The guardian may also consent to any necessary remedial, psychological, medical, or surgical
39 treatment for the juvenile. The authority of the guardian shall continue until the guardianship is
40 terminated by court order, until the juvenile is emancipated pursuant to Article 35 of
41 Subchapter IV of this Chapter, or until the juvenile reaches the age of majority.

42 (b) In any case where the court has determined that the appointment of a relative or
43 other suitable person as guardian of the person for a juvenile is ~~in the best interest of the~~
44 ~~juvenile and has also made findings in accordance with G.S. 7B-907 that guardianship is the~~
45 permanent plan for the juvenile and appoints a guardian under this section, the guardian is
46 becomes a party to the ~~proceeding, the proceeding~~. The court may ~~not~~ terminate the
47 guardianship ~~or order that the juvenile be reintegrated into a parent's home unless only if~~ (i) the
48 court finds that the relationship between the guardian and the juvenile is no longer in the
49 juvenile's best interest, ~~that~~ (ii) the guardian is unfit, ~~that~~ (iii) the guardian has neglected a
50 guardian's duties, or ~~that~~ (iv) the guardian is unwilling or unable to continue assuming a
51 guardian's duties.

1 (b1) If a party files a motion ~~or petition under G.S. 7B-906~~ under G.S. 7B-906.1 or
2 G.S. 7B-1000, the court may, prior to conducting a review hearing, do one or more of the
3 following:

- 4 (1) Order the county department of social services to conduct an investigation
5 and file a written report of the investigation regarding the performance of the
6 guardian of the person of the juvenile and give testimony concerning its
7 investigation.
- 8 (2) Utilize the community resources in behavioral sciences and other
9 professions in the investigation and study of the guardian.
- 10 (3) Ensure that a guardian ad litem has been appointed for the juvenile in
11 accordance with G.S. 7B-601 and has been notified of the pending motion or
12 petition.
- 13 (4) Take any other action necessary in order to make a determination in a
14 particular case.

15 (c) If the court appoints an individual guardian of the person pursuant to this section,
16 the court shall verify that the person being appointed as guardian of the juvenile understands
17 the legal significance of the appointment and will have adequate resources to care appropriately
18 for the juvenile."

19 **SECTION 17.** G.S. 7B-602 reads as rewritten:

20 "**§ 7B-602. Parent's right to counsel; guardian ad litem.**

21 (a) In cases where the juvenile petition alleges that a juvenile is abused, neglected, or
22 dependent, the parent has the right to counsel and to appointed counsel in cases of indigency
23 unless that person waives the right. When a petition is filed alleging that a juvenile is abused,
24 neglected, or dependent, the clerk shall appoint provisional counsel for each parent named in
25 the petition in accordance with rules adopted by the Office of Indigent Defense Services and
26 shall indicate the appointment on the juvenile summons or attached notice. At the first hearing,
27 the court shall dismiss the provisional counsel if the respondent parent:

- 28 (1) Does not appear at the hearing;
- 29 (2) Does not qualify for court-appointed counsel;
- 30 (3) Has retained counsel; or
- 31 (4) Waives the right to counsel.

32 The court shall confirm the appointment of counsel if subdivisions (1) through (4) of this

34 The court may reconsider a parent's eligibility and desire for appointed counsel at any stage
35 of the proceeding.

36 (a1) A parent qualifying for appointed counsel may be permitted to proceed without the
37 assistance of counsel only after the court examines the parent and makes findings of fact
38 sufficient to show that the waiver is knowing and voluntary. The court's examination shall be
39 reported as provided in G.S. 7B-806.

40 (b) In addition to the right to appointed counsel set forth above, a guardian ad litem
41 shall be appointed in accordance with the provisions of G.S. 1A-1, Rule 17, to represent a
42 parent who is under the age of 18 years and who is not married or otherwise emancipated. The
43 appointment of a guardian ad litem under this subsection shall not affect the minor parent's
44 entitlement to a guardian ad litem pursuant to G.S. 7B-601 in the event that the minor parent is
45 the subject of a separate juvenile petition.

46 (c) On motion of any party or on the court's own motion, the court may appoint a
47 guardian ad litem for a parent who is incompetent in accordance with G.S. 1A-1, Rule 17, if the
48 court determines that there is a reasonable basis to believe that the parent is incompetent or has
49 diminished capacity and cannot adequately act in his or her own interest. The parent's counsel
50 shall not be appointed to serve as the guardian ad litem. Rule 17.

1 (d) The parent's counsel shall not be appointed to serve as the guardian ad litem and the
 2 guardian ad litem shall not act as the parent's attorney. Communications between the guardian
 3 ad litem appointed under this section and the parent and between the guardian ad litem and the
 4 parent's counsel shall be privileged and confidential to the same extent that communications
 5 between the parent and the parent's counsel are privileged and confidential.

6 (e) ~~Guardians ad litem appointed under this section may engage in all of the following~~
 7 ~~practices:~~

8 (1) ~~Helping the parent to enter consent orders, if appropriate.~~

9 (2) ~~Facilitating service of process on the parent.~~

10 (3) ~~Assuring that necessary pleadings are filed.~~

11 (4) ~~Assisting the parent and the parent's counsel, if requested by the parent's~~
 12 ~~counsel, to ensure that the parent's procedural due process requirements are~~
 13 ~~met."~~

14 **SECTION 18.** Article 8 of Chapter 7B of the General Statutes is amended by

17 (a) Prior to the adjudicatory hearing, the court shall consider the following:

 21 including the identity and location of any missing parent.

22 (4) Whether relatives have been identified and notified as potential resources for

34 (c) The parties may enter stipulations in accordance with G.S. 7B-807 or enter a
 35 consent order in accordance with G.S. 7B-801."

36 **SECTION 19.** G.S. 7B-803 reads as rewritten:

37 "**§ 7B-803. Continuances.**

38 The court may, for good cause, continue the hearing for as long as is reasonably required to
 39 receive additional evidence, reports, or assessments that the court has requested, or other

16 (b) The adjudicatory order shall be in writing and shall contain appropriate findings of
17 fact and conclusions of law. The order shall be reduced to writing, signed, and entered no later
18 than 30 days following the completion of the hearing. If the order is not entered within 30 days
19 following completion of the hearing, the clerk of court for juvenile matters shall schedule a
20 subsequent hearing at the first session of court scheduled for the hearing of juvenile matters
21 following the 30-day period to determine and explain the reason for the delay and to obtain any
22 needed clarification as to the contents of the order. The order shall be entered within 10 days of
23 the subsequent hearing required by this subsection."

24 **SECTION 22.** G.S. 7B-901 reads as rewritten:

25 "**§ 7B-901. Dispositional hearing.**

26 The dispositional hearing shall take place immediately following the adjudicatory hearing

39 undertaken to locate the missing parent and to serve that parent and efforts undertaken to
40 establish paternity when paternity is an issue. The order may provide for specific efforts in
41 determining the identity and location of any missing parent and specific efforts in establishing
42 paternity. The court shall also inquire about efforts made to identify and notify relatives as
43 potential resources for placement or support."

44 **SECTION 23.** G.S. 7B-905 reads as rewritten:

45 "**§ 7B-905. Dispositional order.**

46 (a) The dispositional order shall be in writing, signed, and entered no later than 30 days
47 from the completion of the hearing, and shall contain appropriate findings of fact and
48 conclusions of law. The court shall state with particularity, both orally and in the written order
49 of disposition, the precise terms of the disposition including the kind, duration, and the person
50 who is responsible for carrying out the disposition and the person or agency in whom custody is
51 vested. If the order is not entered within 30 days following completion of the hearing, the clerk

9 and, if practicable, shall set the date and time for the review hearing.

10 (c) Any dispositional order shall comply with the requirements of G.S. 7B-507. ~~Any~~
11 ~~dispositional order under which a juvenile is removed from the custody of a parent, guardian,~~
12 ~~custodian, or caretaker, or under which the juvenile's placement is continued outside the home~~
13 ~~shall provide for appropriate visitation as may be in the best interests of the juvenile and~~
14 ~~consistent with the juvenile's health and safety. If the juvenile is placed in the custody or~~
15 ~~placement responsibility of a county department of social services, the court may order the~~
16 ~~director to arrange, facilitate, and supervise a visitation plan expressly approved by the court. If~~
17 ~~the director subsequently makes a good faith determination that the visitation plan may not be~~
18 ~~in the best interests of the juvenile or consistent with the juvenile's health and safety, the~~
19 ~~director may temporarily suspend all or part of the visitation plan. The director shall not be~~

22 (d) When a county department of social services having custody or placement
23 responsibility of a juvenile intends to change the juvenile's placement, the department shall give
24 the guardian ad litem for the juvenile notice of its intention unless precluded by emergency
25 circumstances from doing so. Where emergency circumstances exist, the department of social
26 services shall notify the guardian ad litem or the attorney advocate within 72 hours of the
27 placement change, unless local rules require notification within a shorter time period."

28 **SECTION 24.** Article 9 of Chapter 7B of the General Statutes is amended by
29 adding the following new section to read:

30 **"§ 7B-905.1. Visitation.**

31 (a) An order that removes custody of a juvenile from a parent, guardian, or custodian or
32 that continues the juvenile's placement outside the home shall provide for appropriate visitation
33 as may be in the best interests of the juvenile consistent with the juvenile's health and safety.
34 The court may specify in the order conditions under which visitation may be suspended.

35 (b) If the juvenile is placed or continued in the custody or placement responsibility of a
36 county department of social services, the court may order the director to arrange, facilitate, and
37 supervise a visitation plan expressly approved or ordered by the court. The plan shall indicate
38 the minimum frequency and length of visits and whether the visits shall be supervised. Unless
39 the court orders otherwise, the director shall have discretion to determine who will supervise
40 visits when supervision is required, to determine the location of visits, and to change the day
41 and time of visits in response to scheduling conflicts, illness of the child or party, or
42 extraordinary circumstances. The director shall promptly communicate a limited and temporary
43 change in the visitation schedule to the affected party. Any ongoing change in the visitation
44 schedule shall be communicated to the party in writing and state the reason for the change.

45 If the director makes a good faith determination that the visitation plan is not consistent
46 with the juvenile's health and safety, the director may temporarily suspend all or part of the
47 visitation plan. The director shall not be subject to any motion to show cause for this
48 suspension but shall expeditiously file a motion for review.

49 (c) If the juvenile is placed or continued in the custody or guardianship of a relative or
50 other suitable person, any order providing for visitation shall specify the minimum frequency

1 and length of the visits and whether the visits shall be supervised. The court may authorize
2 additional visitation as agreed upon by the respondent and custodian or guardian.

3 (d) If the court retains jurisdiction, all parties shall be informed of the right to file a
4 motion for review of any visitation plan entered pursuant to this section. Upon motion of any
5 party and after proper notice and a hearing, the court may establish, modify, or enforce a
6 visitation plan that is in the juvenile's best interest. Prior to or at the hearing, the court may
7 order the department and guardian ad litem to investigate and make written recommendations
8 as to appropriate visitation and give testimony concerning its recommendations. For resolution
9 of issues related to visitation, the court may order the parents, guardian, or custodian to
10 participate in custody mediation where there is a program established pursuant to G.S. 7A-494.
11 In referring a case to custody mediation, the court shall specify the issue or issues for
12 mediation, including, but not limited to, whether or not visitation shall be supervised and
13 whether overnight visitation may occur. Custody mediation shall not permit the participants to
14 consent to a change in custody. A copy of any agreement reached in custody mediation shall be
15 provided to all parties and counsel and shall be approved by the court. The provisions of
16 G.S. 50-13.1(d) through (f) apply to this section."

21 (a) In any case where custody is removed from a parent, guardian, or custodian, the
22 court shall conduct a review hearing within 90 days from the date of the dispositional hearing
23 and shall conduct a review hearing within six months thereafter. Within 12 months of the date
24 of the initial order removing custody, there shall be a review hearing designated as a
25 permanency planning hearing. Review hearings after the initial permanency planning hearing
26 shall be designated as subsequent permanency planning hearings. The subsequent permanency
27 planning hearings shall be held at least every six months thereafter or earlier as set by the court
28 to review the progress made in finalizing the permanent plan for the juvenile, or if necessary, to
29 make a new permanent plan for the juvenile.

30 (b) The director of social services shall make a timely request to the clerk to calendar
31 each hearing at a session of court scheduled for the hearing of juvenile matters. The clerk shall
32 give 15 days' notice of the hearing and its purpose to (i) the parents, (ii) the juvenile if 12 years
33 of age or more, (iii) the guardian, (iv) the person providing care for the juvenile, (v) the
34 custodian or agency with custody, (vi) the guardian ad litem, and (vii) any other person or
35 agency the court may specify. The department of social services shall either provide to the clerk
36 the name and address of the person providing care for the juvenile for notice under this
37 subsection or file written documentation with the clerk that the juvenile's current care provider
38 was sent notice of hearing. Nothing in this subsection shall be construed to make the person
39 providing care for the juvenile a party to the proceeding solely based on receiving notice and
40 the right to be heard.

41 (c) At each hearing, the court shall consider information from the parents, the juvenile,
42 the guardian, any person providing care for the juvenile, the custodian or agency with custody,
43 the guardian ad litem, and any other person or agency that will aid in the court's review. The
44 court may consider any evidence, including hearsay evidence as defined in G.S. 8C-1, Rule
45 801, or testimony or evidence from any person that is not a party, that the court finds to be
46 relevant, reliable, and necessary to determine the needs of the juvenile and the most appropriate
47 disposition.

48 (d) At each hearing, the court shall consider the following criteria and make written
49 findings regarding those that are relevant:

- 1 (1) Services which have been offered to reunite the juvenile with either parent
2 whether or not the juvenile resided with the parent at the time of removal or
3 the guardian or custodian from whom the child was removed.
- 4 (2) Reports on visitation that has occurred and whether there is a need to create,
5 modify, or enforce an appropriate visitation plan in accordance with
6 G.S. 7B-905.1.
- 7 (3) Whether efforts to reunite the juvenile with either parent clearly would be
8 futile or inconsistent with the juvenile's safety and need for a safe,
9 permanent home within a reasonable period of time. The court shall consider
10 efforts to reunite regardless of whether the juvenile resided with the parent,
11 guardian, or custodian at the time of removal. If the court determines efforts
12 would be futile or inconsistent, the court shall consider a permanent plan of
13 care for the juvenile.
- 14 (4) Reports on the placements the juvenile has had, the appropriateness of the
15 juvenile's current foster care placement, and the goals of the juvenile's foster
16 care plan, including the role the current foster parent will play in the
17 planning for the juvenile.
- 18 (5) If the juvenile is 16 or 17 years of age, a report on an independent living
19 assessment of the juvenile and, if appropriate, an independent living plan
20 developed for the juvenile.
- 21 (6) When and if termination of parental rights should be considered.
- 22 (7) Any other criteria the court deems necessary.
- 23 (e) At any permanency planning hearing where the juvenile is not placed with a parent,
24 the court shall additionally consider the following criteria and make written findings regarding
25 those that are relevant:
- 26 (1) Whether it is possible for the juvenile to be placed with a parent within the
27 next six months and, if not, why such placement is not in the juvenile's best
28 interests.
- 29 (2) Where the juvenile's placement with a parent is unlikely within six months,
30 whether legal guardianship or custody with a relative or some other suitable
31 person should be established and, if so, the rights and responsibilities that
32 should remain with the parents.
- 33 (3) Where the juvenile's placement with a parent is unlikely within six months,
34 whether adoption should be pursued and, if so, any barriers to the juvenile's
35 adoption.
- 36 (4) Where the juvenile's placement with a parent is unlikely within six months,
37 whether the juvenile should remain in the current placement, or be placed in
38 another permanent living arrangement and why.
- 39 (5) Whether the county department of social services has since the initial
40 permanency plan hearing made reasonable efforts to implement the
41 permanent plan for the juvenile.
- 42 (6) Any other criteria the court deems necessary.
- 43 (f) In the case of a juvenile who is in the custody or placement responsibility of a
44 county department of social services and has been in placement outside the home for 12 of the
45 most recent 22 months, or a court of competent jurisdiction has determined that the parent (i)
46 has abandoned the child, (ii) has committed murder or voluntary manslaughter of another child
47 of the parent, or (iii) has aided, abetted, attempted, conspired, or solicited to commit murder or
48 voluntary manslaughter of the child or another child of the parent, the director of the
49 department of social services shall initiate a proceeding to terminate the parental rights of the
50 parent unless the court finds any of the following:

1 (1) The permanent plan for the juvenile is guardianship or custody with a
2 relative or some other suitable person.

3 (2) The court makes specific findings as to why the filing of a petition for
4 termination of parental rights is not in the best interests of the child.

5 (3) The department of social services has not provided the juvenile's family with
6 services the department deems necessary when reasonable efforts are still
7 required to enable the juvenile's return to a safe home.

8 (g) At the conclusion of each permanency planning hearing, the judge shall make
9 specific findings as to the best plan of care to achieve a safe, permanent home for the juvenile
10 within a reasonable period of time.

11 (h) The order shall be reduced to writing, signed, and entered no later than 30 days
12 following the completion of the hearing. If the order is not entered within 30 days following
13 completion of the hearing, the clerk of court for juvenile matters shall schedule a subsequent
14 hearing at the first session of court scheduled for the hearing of juvenile matters following the
15 30-day period to determine and explain the reason for the delay and to obtain any needed
16 clarification as to the contents of the order. The order shall be entered within 10 days of the
17 subsequent hearing required by this subsection.

18 (i) The court may maintain the juvenile's placement under review or order a different
19 placement, appoint a guardian of the person for the juvenile pursuant to G.S. 7B-600, or order
20 any disposition authorized by G.S. 7B-903, including the authority to place the child in the
21 custody of either parent or any relative found by the court to be suitable and found by the court
22 to be in the best interest of the juvenile.

23 (j) If the court determines that the juvenile shall be placed in the custody of an
24 individual other than a parent or appoints an individual guardian of the person pursuant to
25 G.S. 7B-600, the court shall verify that the person receiving custody or being appointed as
26 guardian of the juvenile understands the legal significance of the placement or appointment and
27 will have adequate resources to care appropriately for the juvenile.

28 (k) If at any time custody is placed with a parent or findings are made in accordance
29 with subsection (n) of this section, the court shall be relieved of the duty to conduct periodic
30 judicial reviews of the placement.

31 (l) If the court continues the juvenile's placement in the custody or placement
32 responsibility of a county department of social services, the provisions of G.S. 7B-507 shall
33 apply to any order entered under this section.

34 (m) If the court finds that a proceeding to terminate the parental rights of the juvenile's
35 parents is necessary in order to perfect the permanent plan for the juvenile, the director of the
36 department of social services shall file a petition to terminate parental rights within 60 calendar
37 days from the date of the entry of the order unless the court makes written findings regarding
38 why the petition cannot be filed within 60 days. If the court makes findings to the contrary, the
39 court shall specify the time frame in which any needed petition to terminate parental rights
40 shall be filed.

41 (n) Notwithstanding other provisions of this Article, the court may waive the holding of
42 hearings required by this section, may require written reports to the court by the agency or
43 person holding custody in lieu of review hearings, or order that review hearings be held less
44 often than every six months if the court finds by clear, cogent, and convincing evidence each of
45 the following:

46 (1) The juvenile has resided in the placement for a period of at least one year.

47 (2) The placement is stable and continuation of the placement is in the juvenile's
48 best interest.

49 (3) Neither the juvenile's best interest nor the rights of any party require that
50 review hearings be held every six months.

1 (4) All parties are aware that the matter may be brought before the court for

15 (2) If a juvenile is not placed with prospective adoptive ~~parents,~~parents as

17 finds to be in the juvenile's best interest after considering the department's

19 In either case, the court may require specific additional steps that are necessary to accomplish a
20 permanent placement that is in the best interests of the juvenile.

42 **SECTION 40.** G.S. 7B-2506(1)c. reads as rewritten:

43 **"§ 7B-2506. Dispositional alternatives for delinquent juveniles.**

44 The court exercising jurisdiction over a juvenile who has been adjudicated delinquent may
 45 use the following alternatives in accordance with the dispositional structure set forth in
 46 G.S. 7B-2508:

50 c. If the director of the county department of social services has
 51 received notice and an opportunity to be heard, place the juvenile in

1 the custody of the department of social services in the county of his

5 juvenile to the responsible authorities in the juvenile's home state. An
6 order placing a juvenile in the custody or placement responsibility of
