Short Title: Epi Pen in Schools.

1 A BILL TO BE ENTITLED  
2 AN ACT TO REQUIRE LOCAL BOARDS OF EDUCATION TO PROVIDE FOR A  
3 SUPPLY OF EMERGENCY EPINEPHRINE AUTO-INJECTORS ON SCHOOL  
4 PROPERTY FOR USE IN AN EMERGENCY.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. Article 25A of Chapter 115C of the General Statutes is amended by  
7 adding a new section to read:

8 "**§ 115C-375.2A. School supply of epinephrine auto-injectors.**

9 (a) A local board of education shall provide for a supply of emergency epinephrine  
10 auto-injectors on school property and at school-sponsored events for use by trained school  
11 personnel to provide emergency medical aid to persons suffering from an anaphylactic reaction.  
12 Each school shall store in a secure but easily accessible location, a minimum of two  
13 epinephrine auto-injectors.

14 (b) For the purposes of this section and G.S. 115C-375.2, "epinephrine auto-injector"  
15 means a disposable drug delivery system with a spring-activated, concealed needle that is  
16 designed for emergency administration of epinephrine to provide rapid, convenient first aid for  
17 persons suffering a potentially fatal reaction to anaphylaxis.

18 (c) The principal shall designate one or more school personnel, as part of the medical  
19 care program under G.S. 115C-375.1, to receive initial training and annual retraining from a  
20 school nurse or qualified representative of the local health department regarding the storage and  
21 emergency use of an epinephrine auto-injector. The school nurse or other designated school  
22 personnel who has received training under this subsection shall obtain a prescription for  
23 epinephrine auto-injectors from the medical director of the local health department or the local  
24 emergency medical services director in the local school administrative unit.

25 (d) The principal shall collaborate with appropriate school personnel to develop an  
26 emergency action plan for the use of epinephrine auto-injectors in an emergency. The plan shall  
27 include at least the following components:

28 (1) Standards and procedures for the storage and emergency use of epinephrine  
29 auto-injectors.

30 (2) Techniques for recognizing symptoms of anaphylaxis.

31 (3) Emergency follow-up procedures, including calling emergency services and  
32 contacting a student's parent and physician.

33 (4) Instruction and certification in cardiopulmonary resuscitation.

34 (e) A supply of emergency epinephrine auto-injectors provided in accordance with this  
35 section shall not be used as a medication supply for students known to have a medical condition  
36 requiring the availability or use of an epinephrine auto-injector. Those students may be



1 authorized to possess and self-administer their asthma medication on school property under  
2 G.S. 115C-375.2.

3 (f) No local board of education, nor its members, employees, designees, agents, or  
4 volunteers, shall be liable in civil damages to any party for any act authorized by this section or  
5 for any omission relating to that act unless that act or omission amounts to gross negligence,  
6 wanton conduct, or intentional wrongdoing."

7 **SECTION 2.** This act is effective when it becomes law and applies beginning with  
8 the 2013-2014 school year.
