2 "ADJUSTMENTS ARE TRIGGERED; AND TO PROVIDE NOTICE AND AN
3 OPPORTUNITY FOR A HEARING WHEN A SUPERIOR COURT JUDGE IS CALLED
4 UPON TO SELECT AN UMPIRE IN CERTAIN PROPERTY INSURANCE
5 DISPUTES.";

7 and on page 14, line 37, by inserting after that line the following:

8 "SECTION 23. G.S. 58-44-35 reads as rewritten:
9 '§ 58-44-35. Judge to select umpire.

10 ~~The Any~~ resident judge of the superior court of the district in which the property insured is
11 located is designated as the judge of the court of record to select the umpire referred to in the
12 standard form of ~~policy-policy~~ as set forth in G.S. 58-44-16(f)(14). The judge may not select
13 the umpire until all of the following conditions have been met:

- 14 (1) Proof of notice to all parties of record has been filed with the court, and at
15 least 15 days have passed since the filing of the proof of notice.
16 (2) Upon the request of any party of record, the judge has conducted a hearing.
17 The hearing by the judge shall be governed by the practice for hearings in
18 other civil actions before a judge without a jury, and shall be limited to the
19 issue of umpire selection."

21 and on page 14, lines 28-30, by rewriting the lines to read:

22 "SECTION 24. Section 10 of this act becomes effective January 1, 2016. Section
23 22 of this act is effective when it becomes law. Section 23 of this act becomes effective
24 October 1, 2013. The remainder of this act becomes effective July 1, 2013."
