1 A BILL TO BE ENTITLED  
2 AN ACT TO MAKE ADJUSTMENTS TO THE FEE SCHEDULE FOR PERMITS FOR  
3 SANITARY LANDFILLS AND TRANSFER STATIONS TO REFLECT EXTENSION  
4 OF THE DURATION OF THESE PERMITS AS DIRECTED BY S.L. 2012-187, AS  
5 RECOMMENDED BY THE ENVIRONMENTAL REVIEW COMMISSION.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 130A-294 is amended by adding a new subsection to read:

8 "(a2) Permits for sanitary landfills and transfer stations shall be issued for (i) a design and  
9 operation phase of five years or (ii) a design and operation phase of 10 years. A permit issued  
10 for a design and operation phase of 10 years shall be subject to a limited review within five  
11 years of the issuance date."

12 **SECTION 2.** G.S. 130A-295.8 reads as rewritten:

13 **"§ 130A-295.8. Fees applicable to permits for solid waste management facilities.**

14 (a) The Solid Waste Management Account is established as a nonreverting account  
15 within the Department. All fees collected under this section shall be credited to the Account  
16 and shall be used to support the solid waste management program established pursuant to  
17 G.S. 130A-294.

18 (b) As used in this section:

19 (1) "New permit" means any of the following:

- 20 a. An application for a permit for a solid waste management facility  
21 that has not been previously permitted by the Department. The term  
22 includes one site suitability review, the initial permit to construct,  
23 and one permit to operate the constructed portion of a phase included  
24 in the permit to construct.
- 25 b. An application that proposes to expand the boundary of a permitted  
26 waste management facility for the purpose of expanding the  
27 permitted activity.
- 28 c. An application that includes a proposed expansion to the boundary of  
29 a waste disposal unit within a permitted solid waste management  
30 facility.
- 31 d. An application for a substantial amendment to a solid waste permit,  
32 as defined in G.S. 130A-294.

33 (2) "Permit amendment" means any of the following:

- 34 a. An application for a permit to construct and one permit to operate for  
35 the second and subsequent phases of landfill development described

- 1 in the approved facility plan for a permitted solid waste management  
2 facility.
- 3 b. An application for the five-year renewal of a permit for a permitted  
4 solid waste management facility or for a permit review of a permitted  
5 solid waste management facility.
- 6 c. Any application that proposes a change in ownership or corporate  
7 structure of a permitted solid waste management facility.
- 8 (3) "Permit modification" means any of the following:
- 9 a. An application for any change to the plans approved in a permit for a  
10 solid waste management facility that does not constitute a "permit  
11 amendment" or a "new permit".
- 12 b. A second or subsequent permit to operate for a constructed portion of  
13 a phase included in the permit to construct.
- 14 c. An application for a five-year limited review of a 10-year permit, as  
15 required by G.S. 130A-294(a2), including review of the operations  
16 plan, closure plan, post-closure plan, financial assurance cost  
17 estimates, environmental monitoring plans, and any other applicable  
18 plans for the facility.
- 19 (4) "Major permit modification" means an application for any change to the  
20 approved engineering plans for a sanitary landfill or transfer station  
21 permitted for a 10-year design capacity that does not constitute a "permit  
22 amendment," "new permit," or "permit modification."
- 23 (c) An applicant for a permit shall pay an application fee upon submission of an  
24 application according to the following schedule:
- 25 (1) Municipal Solid Waste Landfill accepting less than 100,000 tons/year of  
26 solid waste, ~~New Permit~~—Permit (Five-Year) – \$25,000.
- 27 (1a) Municipal Solid Waste Landfill accepting less than 100,000 tons/year of

- 29 (2) Municipal Solid Waste Landfill accepting less than 100,000 tons/year of

- 21 (d) A permitted solid waste management facility shall pay an annual permit fee on or  
22 before 1 August of each year according to the following schedule:
- 23 (1) Municipal Solid Waste Landfill – \$3,500.  
24 (2) Post-Closure Municipal Solid Waste Landfill – \$1,000.  
25 (3) Construction and Demolition Landfill – \$2,750.  
26 (4) Post-Closure Construction and Demolition Landfill – \$500.  
27 (5) Industrial Landfill – \$2,750.  
28 (6) Post-Closure Industrial Landfill – \$500.  
29 (7) Transfer Station – \$750.  
30 (8) Treatment and Processing Facility – \$500.  
31 (9) Tire Monofill – \$500.  
32 (10) Incinerator – \$500.  
33 (11) Large Compost Facility – \$500.  
34 (12) Land Clearing and Inert Debris Landfill – \$500.
- 35 (e) The Department shall determine whether an application for a permit for a solid  
36 waste management facility that is subject to a fee under this section is complete within 90 days  
37 after the Department receives the application for the permit. A determination of completeness  
38 means that the application includes all required components but does not mean that the required  
39 components provide all of the information that is required for the Department to make a  
40 decision on the application. If the Department determines that an application is not complete,  
41 the Department shall notify the applicant of the components needed to complete the  
42 application. An applicant may submit additional information to the Department to cure the  
43 deficiencies in the application. The Department shall make a final determination as to whether  
44 the application is complete within the later of: (i) 90 days after the Department receives the  
45 application for the permit less the number of days that the applicant uses to provide the  
46 additional information; or (ii) 30 days after the Department receives the additional information  
47 from the applicant. The Department shall issue a draft permit decision on an application for a  
48 permit within one year after the Department determines that the application is complete. The  
49 Department shall hold a public hearing and accept written comment on the draft permit  
50 decision for a period of not less than 30 or more than 60 days after the Department issues a  
51 draft permit decision. The Department shall issue a final permit decision on an application for a

1 permit within 90 days after the comment period on the draft permit decision closes. The  
2 Department and the applicant may mutually agree to extend any time period under this  
3 subsection. If the Department fails to act within any time period set out in this subsection, the  
4 applicant may treat the failure to act as a denial of the permit and may challenge the denial as  
5 provided in Chapter 150B of the General Statutes."

6 **SECTION 3.** This act is effective when it becomes law and applies to permit  
7 applications submitted on or after July 1, 2013.
