14 adding a new section to read:

15 **'§ 138A-16. Drug testing by the Commission.**

16 (a) The following individuals shall submit to a drug test annually:

17 (1) The members of the General Assembly.

18 (2) Constitutional officers of the State, including the Governor.

19 (3) Heads of all principal State departments, as set forth in G.S. 143B-6, who are
20 appointed by the Governor.

21 (4) The chief deputy of each individual designated under subdivision (2) or (3) of
22 this section.

23 (b) The following individuals shall submit to a drug test prior to taking an oath of
24 office:

25 (1) The members of the General Assembly.

26 (2) Constitutional officers of the State, including the Governor.

27 (c) The Commission shall administer a drug test under this section. The cost of the drug
28 testing is the responsibility of the individual tested.

29 (e) After completion of the drug test required by this section, the Commission shall
30 release the results of the individual's drug test no later than the 30th day after the submission
31 has been received.
