(Public) Sponsors: Referred to: February 27, 2013 A BILL TO BE ENTITLED 1 2 AN ACT ESTABLISHING THE JOINT LEGISLATIVE OVERSIGHT COMMITTEE ON 3 GENERAL GOVERNMENT. 4 The General Assembly of North Carolina enacts: 5 SECTION 1. Chapter 120 of the General Statutes is amended by adding a new 6 Article to read: 7 "Article 34. 8 "Joint Legislative Oversight Committee on General Government. 9 "§ 120-295. Creation and membership of Joint Legislative Oversight Committee on <u>General Gove</u>rnment. 10 The Joint Legislative Oversight Committee on General Government is established. 11 (a) The Committee consists of 12 members as follows: 12 Six members of the Senate appointed by the President Pro Tempore of the 13 (1)14 Senate. 15 (2)Six members of the House of Representatives appointed by the Speaker of the House of Representatives. 16 17 (b) Terms on the Committee are for two years and begin on the convening of the General Assembly in each odd-numbered year. Members may complete a term of service on 18 the Committee even if they do not seek reelection or are not reelected to the General Assembly, 19 20 but resignation or removal from service in the General Assembly constitutes resignation or 21 removal from service on the Committee. 22 A member continues to serve until a successor is appointed. A vacancy shall be (c) 23 filled within 30 days by the officer who made the original appointment. "§ 120-296. Purpose and powers of Committee. 24 25 The Joint Legislative Oversight Committee on General Government shall examine (a) on a continuing basis the services provided by the departments and agencies set out in this 26 subsection, in order to make ongoing recommendations to the General Assembly on ways to 27 28 improve the effectiveness, efficiency, and quality of State government services. The Committee 29 has the following powers and duties: 30 Study the programs, organization, operations, and policies of the following (1)31 agencies: 32 Department of Administration. a. 33 b.
