April 1, 2013 1 A BILL TO BE ENTITLED 2 AN ACT TO PROVIDE REGULATORY CERTAINTY FOR NORTH CAROLINA BY 3 REOUIRING THE DEVELOPMENT OF MINIMUM DESIGN CRITERIA FOR STORMWATER PERMITS TO GUIDE THE DEPARTMENT OF ENVIRONMENT 4 AND NATURAL RESOURCES IN PERMIT ISSUANCE AND TO REFORM THE 5 6 PERMITTING PROCESS TO ALLOW A FAST-TRACK PERMITTING PROCESS FOR APPLICATIONS CERTIFIED BY A QUALIFIED PROFESSIONAL TO BE IN 7 8 COMPLIANCE WITH THE MINIMUM DESIGN CRITERIA. 9 The General Assembly of North Carolina enacts: 10 SECTION 1. The Department of Environment and Natural Resources shall 11 develop Minimum Design Criteria for permits issued by the stormwater runoff permitting 12 programs authorized by G.S. 143-214.7. The Minimum Design Criteria shall include all requirements for siting, site preparation, design and construction, and post-construction 13 monitoring and evaluation necessary for the Department to issue a stormwater permit. In 14 developing and updating the Minimum Design Criteria, the Department shall consult with a 15 technical working group that consists of industry experts, engineers, environmental consultants, 16 relevant faculty from The University of North Carolina, and other interested stakeholders. The 17 18 Department shall submit its recommendations to the Environmental Review Commission no 19 later than September 1, 2014. 20 SECTION 2. Article 21 of Chapter 143 of the General Statutes is amended by 21 adding a new section to read: 22 "§ 143-214.7B. Fast-track permitting for stormwater management systems. 23 The Commission shall adopt rules to establish a fast-track permitting process that allows for the issuance of stormwater management system permits without a technical review when the 24 25 permit applicant (i) complies with the Minimum Design Criteria for stormwater management 26 developed by the Department and (ii) submits a permit application prepared by a qualified professional. In developing the rules, the Commission shall consult with a technical working 27 group that consists of industry experts, engineers, environmental consultants, relevant faculty 28 29 from The University of North Carolina, and other interested stakeholders. The rules shall, at a minimum, provide for all of the following: 30 A process for permit application, review, and determination. 31 (1)32 The types of professionals that are qualified to prepare a permit application (2)33 submitted pursuant to this section and the types of qualifications such professionals must have. 34 A process for ensuring compliance with the Minimum Design Criteria. 35 (3)

4	SECTION 3. The Environmental Management Commission shall adopt rule
5	implementing Section 2 of this act no later than July 1, 2016.
6	SECTION 4. This act is effective when it becomes law.
