- 10 By rewriting those lines to read:
 - "SECTION 13. G.S. 14-415.21 reads as rewritten:

12 '§ 14-415.21. Violations of this Article punishable as an infraction.

(a) A person who has been issued a valid permit who is found to be carrying a
concealed handgun without the permit in the person's possession or who fails to disclose to any
law enforcement officer that the person holds a valid permit and is carrying a concealed
handgun, as required by G.S. 14-415.11, shall be guilty of an infraction and shall be punished
in accordance with G.S. 14-3.1. In lieu of paying a fine the person may surrender the permit.

18 (a1) Any person who is found to be carrying a concealed handgun in violation of G.S.

19 <u>14-415.11(c2) is guilty of a Class A1 misdemeanor and shall pay a minimum fine of one</u>
 20 <u>thousand dollars (\$1,000). In addition to the criminal penalty imposed under this subsection,</u>
 21 <u>the sheriff shall also revoke the permit of any person convicted under this subsection pursuant</u>

22 to G.S. 14-415.18 for a period of five years.

(b) A person who violates the provisions of this Article other than as set forth in subsection
(a) or (a1) of this section is guilty of a Class 2 misdemeanor.'

25 **SECTION 14.** Sections 1 through 6 of this act and Section 13 of this act become 26 effective October 1, 2013, and apply to offenses committed on or after that date. The 27 remainder of this act becomes effective October 1, 2013. "
