6 **STRATEGIC PRIORITIZATION FUNDING PLAN FOR TRANSPORTATION**
7 **INVESTMENTS**

8 **SECTION 1.1.(a)** Chapter 136 of the General Statutes is amended by adding a new
9 Article to read:

10 "Article 14B.

11 "Strategic Prioritization Funding Plan for Transportation Investments.

12 "**§ 136-189.10. Definitions.**

13 The following definitions apply in this Article:

- 14 (1) Statewide strategic mobility projects. – Includes only the following:
- 15 a. Interstate highways and future interstate highways approved by the
16 federal government.
 - 17 b. Routes on the National Highway System as of July 1, 2012,
18 excluding intermodal connectors.
 - 19 c. Highway routes on the United States Department of Defense
20 Strategic Highway Network (STRAHNET).
 - 21 d. Highway toll routes designated by State law or by the Department of
22 Transportation, pursuant to its authority under State law.
 - 23 e. Highway projects listed in G.S. 136-179, as it existed on July 1,
24 2012, that are not authorized for construction as of July 1, 2015.
 - 25 f. Appalachian Development Highway System.
 - 26 g. Commercial service airports included in the Federal Aviation
27 Administration's National Plan of Integrated Airport Systems
28 (NPIAS) that provide international passenger service or 375,000 or
29 more enplanements annually, provided that the State's annual
30 financial participation in any single airport project included in this
31 subdivision may not exceed five hundred thousand dollars
32 (\$500,000).
 - 33 h. Freight capacity and safety improvements to Class I freight rail
34 corridors.

- 1 (2) Regional impact projects. – Includes only the following:
2 a. Projects listed in subdivision (1) of this section, subject to the
3 limitations noted in that subdivision.
4 b. U.S. highway routes not included in subdivision (1) of this section.
5 c. N.C. highway routes not included in subdivision (1) of this section.
6 d. Commercial service airports included in the NPIAS that are not
7 included in subdivision (1) of this section, provided that the State's
8 annual financial participation in any single airport project included in
9 this subdivision may not exceed three hundred thousand dollars
10 (\$300,000).
11 e. State-maintained ferry system, excluding passenger vessel
12 replacement.
13 f. Rail lines that span two or more counties not included in subdivision
14 (1) of this section.
15 g. Public transportation service that spans two or more counties and that
16 serves more than one municipality.
17 (3) Division needs projects. – Includes only the following:
18 a. Projects listed in subdivision (1) or (2) of this section, subject to the
19 limitations noted in those subsections.
20 b. State highway routes not included in subdivision (1) or (2) of this
21 section.
22 c. Airports included in the NPIAS that are not included in subdivision
23 (1) or (2) of this section, provided that the State's total annual
24 financial participation under this sub-subdivision shall not exceed
25 eighteen million five hundred thousand dollars (\$18,500,000).
26 d. Rail lines not included in subdivision (1) or (2) of this section.
27 e. Public transportation service not included in subdivision (1) or (2) of
28 this section.
29 f. Multimodal terminals and stations serving passenger transit systems.
30 g. Bicycle and pedestrian improvements.
31 h. Replacement of State-maintained ferry vessels.
32 (4) Distribution Regions. – The following Distribution Regions apply to this
33 Article:
34 a. Distribution Region A consists of the following counties: Bertie,
35 Camden, Chowan, Currituck, Dare, Edgecombe, Gates, Halifax,
36 Hertford, Hyde, Johnston, Martin, Nash, Northampton, Pasquotank,
37 Perquimans, Tyrrell, Washington, Wayne, and Wilson.
38 b. Distribution Region B consists of the following counties: Beaufort,
39 Brunswick, Carteret, Craven, Duplin, Greene, Jones, Lenoir, New
40 Hanover, Onslow, Pamlico, Pender, Pitt, and Sampson.
41 c. Distribution Region C consists of the following counties: Bladen,
42 Columbus, Cumberland, Durham, Franklin, Granville, Harnett,
43 Person, Robeson, Vance, Wake, and Warren.
44 d. Distribution Region D consists of the following counties: Alamance,
45 Caswell, Davidson, Davie, Forsyth, Guilford, Orange, Rockingham,
46 Rowan, and Stokes.
47 e. Distribution Region E consists of the following counties: Anson,
48 Cabarrus, Chatham, Hoke, Lee, Mecklenburg, Montgomery, Moore,
49 Randolph, Richmond, Scotland, Stanly, and Union.

1 f. Distribution Region F consists of the following counties: Alexander,
2 Alleghany, Ashe, Avery, Caldwell, Catawba, Cleveland, Gaston,
3 Iredell, Lincoln, Surry, Watauga, Wilkes, and Yadkin.

4 g. Distribution Region G consists of the following counties: Buncombe,
5 Burke, Cherokee, Clay, Graham, Haywood, Henderson, Jackson,
6 Macon, Madison, McDowell, Mitchell, Polk, Rutherford, Swain,
7 Transylvania, and Yancey.

8 **"§ 136-189.11. Transportation Investment Strategy Formula.**

9 (a) Funds Subject to Formula. – The following sources of funds are subject to this
10 section:

11 (1) Highway Trust Fund funds, in accordance with G.S. 136-176.

12 (2) Federal aid funds.

13 (b) Funds Excluded From Formula. – The following funds are not subject to this
14 section:

15 (1) Federal congestion mitigation and air quality improvement program funds
16 appropriated to the State by the United States pursuant to 23 U.S.C. §
17 104(b)(2) and 23 U.S.C. § 149.

18 (2) Funds received through competitive awards or discretionary grants through
19 federal appropriations either for local governments, transportation
20 authorities, transit authorities, or the Department.

21 (3) Funds received from the federal government that under federal law may only
22 be used for Appalachian Development Highway System projects.

23 (4) Funds used in repayment of "GARVEE" bonds related to Phase I of the
24 Yadkin River Veterans Memorial Bridge project.

25 (5) Funds committed to gap funding for toll roads funded with bonds issued
26 pursuant to G.S. 136-176.

27 (6) Funds obligated for projects in the State Transportation Improvement
28 Program that are scheduled for construction as of April 1, 2013, in State
29 fiscal year 2012-2013, 2013-2014, or 2014-2015.

30 (7) Toll collections from a turnpike project under Article 6H of this Chapter and
31 other revenue from the sale of the Authority's bonds or notes or project
32 loans, in accordance with G.S. 136-89.192.

33 (c) Funds With Alternate Criteria. – The following federal program activities shall be
34 included in the applicable category of the Transportation Investment Strategy Formula set forth
35 in subsection (d) of this section but shall not be subject to the prioritization criteria set forth in
36 that subsection:

37 (1) Bridge replacement.

38 (2) Interstate maintenance.

39 (3) Highway safety improvement.

40 (d) Transportation Investment Strategy Formula. – Funds subject to the Formula shall
41 be distributed as follows:

42 (1) Statewide Strategic Mobility Projects. – Forty percent (40%) of the funds
43 subject to this section shall be used for Statewide Strategic Mobility
44 Projects.

45 a. Criteria. – Transportation-related quantitative criteria shall be used
46 by the Department to rank highway projects that address
47 cost-effective Statewide Strategic Mobility needs and promote
48 economic and employment growth. The criteria for selection of
49 Statewide Strategic Mobility Projects shall utilize a numeric scale of
50 100 points, based on consideration of the following quantitative
51 criteria:

1. Benefit-cost.
 2. Congestion.
 3. Economic competitiveness.
 4. Safety.
 5. Freight.
 6. Multimodal.
 7. Pavement condition.
 8. Lane width.
 9. Shoulder width.
- b. Project cap. – No more than ten percent (10%) of the funds projected to be allocated to the Statewide Strategic Mobility category over any five-year period may be assigned to any contiguous project or group of projects in the same corridor within a Highway Division or within adjoining Highway Divisions.
- (2) Regional Impact Projects. – Thirty percent (30%) of the funds subject to this section shall be used for Regional Impact Projects and allocated by population of Distribution Regions, based on the most recent estimates certified by the Office of State Budget and Management.
- a. Criteria. – A combination of transportation-related quantitative criteria, qualitative criteria, and local input shall be used to rank Regional Impact Projects involving highways that address cost-effective needs from a region-wide perspective and promote economic growth. Local input is defined as the rankings identified by the Department's Transportation Division Engineers, Metropolitan Planning Organizations, and Rural Transportation Planning Organizations. The criteria utilized for selection of Regional Impact Projects shall be based thirty percent (30%) on local input and seventy percent (70%) on consideration of a numeric scale of 100 points, based on the following quantitative criteria:
1. Benefit-cost.
 2. Congestion.
 3. Economic competitiveness.
 4. Safety.
 5. Freight.
 6. Multimodal.
 7. Pavement condition.
 8. Lane width.
 9. Shoulder width.
 10. Accessibility/connectivity.
- (3) Division Need Projects. – Thirty percent (30%) of the funds subject to this section shall be allocated in equal share to each of the Department divisions, as defined in G.S. 136-14.1, and used for Division Need Projects.
- a. Criteria. – A combination of transportation-related quantitative criteria, qualitative criteria, and local input shall be used to rank Division Need Projects involving highways that address cost-effective needs from a Division-wide perspective, provide access, and address safety-related needs of local communities. Local input is defined as the rankings identified by the Department's Transportation Division Engineers, Metropolitan Planning Organizations, and Rural Transportation Planning Organizations. The criteria utilized for selection of Division Need Projects shall be based

- 1 fifty percent (50%) on local input and fifty percent (50%) on
2 consideration of a numeric scale of 100 points, based on the
3 following quantitative criteria, except as provided in sub-subdivision
4 b. of this subdivision:
- 5 1. Benefit-cost.
 - 6 2. Congestion.
 - 7 3. Economic competitiveness.
 - 8 4. Safety.
 - 9 5. Freight.
 - 10 6. Multimodal.
 - 11 7. Pavement condition.
 - 12 8. Lane width.
 - 13 9. Shoulder width.
- 14 b. Alternate criteria. – Funding from the following programs shall be
15 included in the computation of each of the Department division equal
16 shares but shall be subject to alternate quantitative criteria:
- 17 1. Federal Surface Transportation Program-Direct Attributable
18 funds appropriated to the State.
 - 19 2. Federal Transportation Alternatives funds appropriated to the
20 State.
 - 21 3. Federal Railway-highway crossings program funds
22 appropriated to the State.
 - 23 4. Projects requested from the Department in support of a
24 time-critical job creation opportunity, when the opportunity
25 would be classified as transformational under the Job
26 Development Investment Grant program established pursuant
27 to G.S. 143B-437.52, provided that the total State investment
28 in each fiscal year for all projects funded under this
29 sub-subdivision shall not exceed ten million dollars
30 (\$10,000,000) in the aggregate or two million dollars
31 (\$2,000,000) per project.
- 32 (4) Criteria for nonhighway projects. – Nonhighway projects subject to this
33 subsection shall be evaluated through a separate prioritization process
34 established by the Department that complies with all of the following:
- 35 a. The criteria used for selection of Statewide Strategic Mobility
36 Projects for a particular transportation mode shall be based on a
37 minimum of four quantitative criteria.
 - 38 b. Local input shall include rankings of projects identified by the
39 Department's Transportation Division Engineers, Metropolitan
40 Planning Organizations, and Rural Transportation Planning
41 Organizations.
 - 42 c. The criteria shall be based on a scale not to exceed 100 points that
43 includes no bonus points or other alterations favoring any particular
44 mode of transportation.
- 45 (e) Authorized Formula Variance. – The Department may vary from the Formula set
46 forth in this section if it complies with the following:
- 47 (1) Limitation on variance. – The Department, in obligating funds in accordance
48 with this section, shall ensure that the percentage amount obligated to
49 Statewide Strategic Mobility Projects, Regional Impact Projects, and
50 Division Need Projects does not vary by more than five percent (5%) over
51 any five-year period from the percentage required to be allocated to each of

1 those categories by this section. Funds obligated among distribution regions
2 or divisions pursuant to this section may vary up to ten percent (10%) over
3 any five-year period.

4 (2) Calculation of variance. – Each year the Secretary shall calculate the amount
5 of Regional Impact and Division Need funds allocated in that year to each
6 division and region, the amount of funds obligated, and the amount the
7 obligations exceeded or were below the allocation. In the first variance
8 calculation under this subdivision following the end of fiscal year
9 2015-2016, the target amounts obtained according to the Formula set forth in
10 this section shall be adjusted to account for any differences between
11 allocations and obligations reported for the previous year. In the first
12 variance calculation under this subdivision following the end of fiscal year
13 2016-2017, the target amounts obtained according to the Formula set forth in
14 this section shall be adjusted to account for any differences between
15 allocations and obligations reported for the previous two fiscal years. In the
16 first variance calculation under this subdivision following the end of fiscal
17 year 2017-2018, the target amounts obtained according to the Formula set
18 forth in this section shall be adjusted to account for any differences between
19 allocations and obligations reported for the previous three fiscal years. In the
20 first variance calculation under this subdivision following the end of fiscal
21 year 2018-2019, the target amounts obtained according to the Formula set
22 forth in this section shall be adjusted to account for any differences between
23 allocations and obligations reported for the previous four fiscal years. The
24 new target amounts shall be used to fulfill the requirements of subdivision
25 (1) of this subsection for the next update of the Transportation Improvement
26 Program. The adjustment to the target amount shall be allocated by
27 Distribution Region or Division, as applicable.

28 (f) Incentives for Local Funding and Highway Tolling. – The Department may revise
29 highway project selection ratings based on local government funding initiatives and capital
30 construction funding directly attributable to highway toll revenue. Projects authorized for
31 construction after November 1, 2013, and contained in the 10-year Department of
32 Transportation work program are eligible for a bonus allocation under this subsection.

33 (1) Definitions. – The following definitions apply in this subsection:

34 a. Bonus allocation. – The allocation obtained as a result of local
35 government funding participation or highway tolling.

36 b. Local funding participation. – Non-State or nonfederal funds
37 committed by local officials to leverage the commitment of State or
38 federal transportation funds towards construction.

39 (2) Funds obtained from local government funding participation. – Upon
40 authorization to construct a project with funds obtained by local government
41 funding participation, the Department shall make available for allocation as
42 set forth in subdivision (4) of this section an amount equal to one-half of the
43 local funding commitment for other eligible highway projects that serve the
44 local entity or entities that provided the local funding.

45 (3) Funds obtained through highway tolling. – Upon authorization to construct a
46 project with funding from toll revenue, the Department shall make available
47 for allocation an amount equal to one-half of the project construction cost
48 derived from toll revenue bonds. The amount made available for allocation
49 to other eligible highway projects shall not exceed two hundred million
50 dollars (\$200,000,000) of the capital construction funding directly
51 attributable to the highway toll revenues committed in the Investment Grade

1 Traffic and Revenue Study. If the toll project is located in one or more
 2 Metropolitan Planning Organization or Rural Transportation Planning
 3 Organization boundaries, based on the boundaries in existence at the time of
 4 letting of the project construction contract, the bonus allocation shall be
 5 distributed proportionately to lane miles of new capacity within the
 6 Organization's boundaries. The Organization shall apply the bonus allocation
 7 only within those counties in which the toll project is located.

8 (4) Use of bonus allocation. – The Metropolitan Planning Organization, Rural
 9 Transportation Planning Organization, or the local government may choose
 10 to apply its bonus allocation in one of the three categories or in a
 11 combination of the three categories as provided in this subdivision.

12 a. Statewide Strategic Mobility Projects category. – The bonus
 13 allocation shall apply over the five-year period in the State
 14 Transportation Improvement Program in the cycle following the
 15 contractual obligation.

16 b. Regional Impact Projects category. – The bonus allocation is capped
 17 at ten percent (10%) of the regional allocation, or allocation to
 18 multiple regions, made over a five-year period and shall be applied
 19 over the five-year period in the State Transportation Improvement
 20 Program in the cycle following the contractual obligation.

21 c. Division Needs Projects category. – The bonus allocation is capped
 22 at ten percent (10%) of the division allocation, or allocation to
 23 multiple divisions, made over a five-year period and shall be applied
 24 over the five-year period in the State Transportation Improvement
 25 Program in the cycle following the contractual obligation."

26 **SECTION 1.1.(b) (Effective July 1, 2019) G.S. 136-189.11(e)(2) reads as**

27 rewritten:

28 "(e) Authorized Formula Variance. – The Department may vary from the Formula set
 29 forth in this section if it complies with the following:

- 30 ...
- 31 (2) Calculation of Variance. – Each year, the Secretary shall calculate the
 32 amount of Regional Impact and Division Need funds allocated in that year to
 33 each ~~division, division and region~~, the amount of funds obligated, and the
 34 amount the obligations exceeded or were below the allocation. ~~In the first~~
 35 ~~variance calculation under this subdivision following the end of fiscal year~~
 36 ~~2015-16, the target amounts obtained according to the Formula set forth in~~
 37 ~~this section shall be adjusted to account for any differences between~~
 38 ~~allocations and obligations reported for the previous year. In the first~~

4 **SECTION 1.2.** Strategic Prioritization Process Reporting. – The Department shall
5 issue a draft revision to the State Transportation Improvement Program required by
6 G.S. 143B-350(f)(4) no later than January 1, 2015. The Board of Transportation shall approve
7 the revised State Transportation Improvement Program no later than July 1, 2015.

8 9 **SECONDARY ROADS CHANGES**

10 **SECTION 2.1.** G.S. 20-85(b) reads as rewritten:

11 "**§ 20-85. Schedule of fees.**

12 ...
13 (b) Except as otherwise provided in subsection (a1) of this section, the fees collected
14 under subdivisions (a)(1) through (a)(9) of this section shall be credited to the North Carolina
15 Highway Trust Fund. The fees collected under subdivision (a)(10) of this section shall be
16 credited to the Highway Fund. ~~Fifteen dollars (\$15.00) of each title fee credited to the Trust~~
17 ~~Fund under subdivision (a)(1) shall be added to the amount allocated for secondary roads under~~
18 ~~G.S. 136-176 and used in accordance with G.S. 136-44.5.~~

19"

20 **SECTION 2.2.(a) (Expires June 30, 2014)** G.S. 136-44.2 reads as rewritten:

21 "**§ 136-44.2. Budget and appropriations.**

22 (a) The Director of the Budget shall include in the "Current Operations Appropriations
23 Act" an enumeration of the purposes or objects of the proposed expenditures for each of the
24 ~~construction and maintenance~~ construction, maintenance, and improvement programs for that
25 budget period for the State primary, secondary, State parks road systems, and other
26 transportation systems. The State primary system shall include all portions of the State highway
27 system located both inside and outside municipal corporate limits that are designated by N.C.,
28 U.S. or Interstate numbers. The State secondary system shall include all of the State highway
29 system located both inside and outside municipal corporate limits that is not a part of the State
30 primary system. The State parks system shall include all State parks roads and parking lots that
31 are not also part of the State highway system. The transportation systems shall include
32 State-maintained, nonhighway modes of ~~transportation as well as~~ transportation.

33 (b) All ~~construction and maintenance~~ construction, maintenance, and improvement
34 programs for which appropriations are requested shall be enumerated separately in the budget.
35 Programs that are entirely State funded shall be listed separately from those programs involving
36 the use of federal-aid funds. Proposed appropriations of State matching funds for each of the
37 federal-aid construction programs shall be enumerated separately as well as the federal-aid
38 funds anticipated for each program in order that the total construction requirements for each
39 program may be provided for in the budget. Also, proposed State matching funds for the
40 highway planning and research program shall be included separately along with the anticipated
41 federal-aid funds for that purpose.

42 (c) Other program categories for which appropriations are requested, such as, but not
43 limited to, maintenance, channelization and traffic control, bridge maintenance, public service
44 and access road construction, transportation projects and systems, and ferry operations shall be
45 enumerated in the budget.

46 (d) The Department of Transportation shall have all powers necessary to comply fully
47 with provisions of present and future federal-aid acts. For purposes of this section, "federally
48 eligible construction project" means any construction project except secondary road projects
49 developed pursuant to G.S. 136-44.7 and 136-44.8 eligible for federal funds under any
50 federal-aid act, whether or not federal funds are actually available.

1 (e) The "Current Operations Appropriations Act" shall also contain the proposed
2 appropriations of State funds for use in each county for ~~maintenance and~~
3 ~~construction~~ construction, maintenance, and improvement of secondary roads, to be allocated in
4 accordance with G.S. 136-44.5 and 136-44.6. State funds appropriated for secondary roads
5 shall not be transferred nor used except for the ~~construction and maintenance~~ construction,
6 maintenance, and improvement of secondary roads in the county for which they are allocated
7 pursuant to G.S. 136-44.5 and 136-44.6.

8 (f) If the unreserved credit balance in the Highway Fund on the last day of a fiscal year
9 is greater than the amount estimated for that date in the Current Operations Appropriations Act
10 for the following fiscal year, the excess shall be used in accordance with this subsection. The
11 Director of the Budget shall allocate the excess to a reserve (i) for access and public roads or
12 (ii) for other urgent needs. The use of this reserve shall be subject to the following:

- 13 (1) Restrictions on use. – No more than five million dollars (\$5,000,000) from
14 this reserve may be spent on a single project. Funds from this reserve being
15 used for an "other urgent need" project cannot be used for administrative
16 costs, information technology costs, or economic development.
- 17 (2) Approval. – The Department of Transportation shall submit for approval to
18 the Director of the Budget all expenditures from the reserve established
19 under this subsection.
- 20 (3) Reporting. – At least five days, not including State holidays or weekend
21 days, prior to submitting an expenditure request to the Director of the
22 Budget under subdivision (2) of this subsection, the Department of
23 Transportation shall submit a report on the expenditure request to the Fiscal
24 Research Division and to the members of the House Appropriations
25 Subcommittee on Transportation and the Senate Appropriations Committee
26 on Department of Transportation. Such report shall be certified by the chief
27 financial officer of the Department of Transportation and shall include (i) a
28 project description, (ii) whether the project is for access and public roads or
29 for other urgent needs, (iii) a justification of the project, (iv) the total project
30 cost, (v) the amount of funding for the project coming from the reserve, and
31 (vi) other funding sources for the project.
- 32 (4) Carryforward. – If on the last day of the fiscal year the balance in the reserve
33 established by this subsection is greater than five million dollars
34 (\$5,000,000), then the Director of the Budget shall transfer the amount in
35 excess of that sum to the Reserve for General Maintenance in the Highway
36 Fund.

37 (g) The Department of Transportation may provide for costs incurred or accrued for
38 traffic control measures to be taken by the Department at major events which involve a high
39 degree of traffic concentration on State highways, and which cannot be funded from regular
40 budgeted items. This authorization applies only to events which are expected to generate
41 30,000 vehicles or more per day. The Department of Transportation shall provide for this
42 funding by allocating and reserving up to one hundred thousand dollars (\$100,000) before any
43 other allocations from the appropriations for State maintenance for primary, secondary, and
44 urban road systems are made, based upon the same proportion as is appropriated to each
45 system."

46 **SECTION 2.2.(b) (Effective July 1, 2014)** G.S. 136-44.2 reads as rewritten:

If the toll is an open road toll, the person who is the registered owner of the motor vehicle is liable for payment of the toll unless the registered owner establishes that the motor vehicle was in the care, custody, and control of another person when it was driven on the Turnpike project.

(b) A person establishes that a motor vehicle was in the care, custody, and control of another person when it was driven on a Turnpike project by submitting to the Authority a sworn affidavit stating one of the following:

- (1) The name and address of the person who had the care, custody, and control of the motor vehicle when it was driven. If the motor vehicle was leased or rented under a long-term lease or rental, as defined in G.S. 105-187.1, the affidavit must be supported by a copy of the lease or rental agreement or other written evidence of the agreement.
- (2) The motor vehicle was stolen. The affidavit must be supported by an insurance or police report concerning the theft or other written evidence of the theft.
- (3) The person transferred the motor vehicle to another person by sale or otherwise before it was driven on the Turnpike project. The affidavit must be supported by insurance information, a copy of the certificate of title, or other evidence of the transfer.

(c) If a person establishes that a motor vehicle was in the care, custody, and control of another person under subsection (b) of this section, the other person shall be liable for the payment of the toll, and the Authority may send a bill to collect and enforce the toll in accordance with this Article; provided, however, that such other person may contest such toll in accordance with this Article.

"§ 136-89.213. Administration of tolls and requirements for open road tolls.

(a) Administration. – The Authority is responsible for collecting tolls on Turnpike projects. In exercising its authority under G.S. 136-89.183 to perform or procure services required by the Authority, the Authority may contract with one or more providers to perform part or all of the collection functions and may enter into agreements to exchange information, including confidential information under subsection (a1) of this section, that identifies motor vehicles and their owners with one or more of the following entities: the Division of Motor Vehicles of the Department of Transportation, another state, another toll operator, ~~or~~ a toll collection-related ~~organization~~ organization, or a private entity that has entered into a partnership agreement with the Authority pursuant to G.S. 136-89.183(a)(17). Further, the Authority may assign its authority to fix, revise, charge, retain, enforce, and collect tolls and fees under this Article to a private entity that has entered into a partnership agreement with the Authority pursuant to G.S. 136-89.183(a)(17).

(b) Open Road Tolls. – If a Turnpike project uses an open road tolling system, the Authority must operate a facility that is in the immediate vicinity of the Turnpike project ~~and that accepts or provide an alternate means to accept~~ cash payment of the toll and must place signs on the Turnpike project that give drivers the following information:

- 1 (1) Notice that the driver is approaching a highway for which a toll is required.
- 2 Signs providing this information must be placed before the toll is incurred.
- 3 (2) The methods by which the toll may be paid.
- 4 (3) ~~Directions~~ If applicable, directions to the nearby facility that accepts cash
- 5 payment of the toll.

6 **"§ 136-89.214. Bill for unpaid open road toll.**

7 (a) Bill. – If a motor vehicle travels on a Turnpike project that uses an open road tolling
8 system and a toll for traveling on the project is not paid prior to travel or at the time of travel,
9 the Authority must send a bill by first-class mail to the registered owner of the motor vehicle or
10 the person who had care, custody, and control of the vehicle as established under
11 G.S. 136-89.212(b) for the amount of the unpaid toll. The Authority must send the bill within
12 90 days after the travel ~~occurs~~ occurs, or within 90 days of receipt of a sworn affidavit
13 submitted under G.S. 136-89.212(b) identifying the person who had care, custody, and control
14 of the motor vehicle. If a bill is not sent within the required time, the Authority waives
15 collection of the toll. The Authority must establish a billing period for unpaid open road tolls
16 that is no shorter than 15 days. A bill for a billing period must include all unpaid tolls incurred
17 by the same person during the billing period.

18 (b) Information on Bill. – A bill sent under this section must include all of the following
19 information:

- 20 (1) The name and address of the registered owner of the motor vehicle that
21 traveled on the Turnpike ~~project~~ project or of the person identified under
22 G.S. 136-89.212(b).
- 23 (2) The date the travel occurred, the approximate time the travel occurred, and
24 each segment of the Turnpike project on which the travel occurred.
- 25 (3) An image of the registration plate of the motor vehicle, if the Authority
26 captured an electronic image of the motor vehicle when it traveled on the
27 Turnpike project.
- 28 (4) The amount of the toll due and an explanation of how payment may be
29 made.
- 30 (5) The date by which the toll must be paid to avoid the imposition of a
31 processing fee under G.S. 136-89.215 and the amount of the processing fee.
- 32 (6) A statement that a vehicle owner who has unpaid tolls is subject to a civil
33 penalty and may not renew the vehicle's registration until the tolls and civil
34 penalties are paid.
- 35 (7) A clear and concise explanation of how to contest liability for the toll.
- 36 (8) If applicable, a copy of the affidavit submitted under G.S. 136-89.212(b)
37 identifying the person with care, custody, and control of the motor vehicle.

38 **"§ 136-89.215. Required action upon receiving bill for open road toll and processing fee**
39 **for unpaid toll.**

40 (a) Action Required. – A person who receives a bill from the Authority for an unpaid
41 open road toll must take one of the following actions within 30 days of the date of the bill:

- 42 (1) Pay the bill.
- 43 (2) Send a written request to the Authority for a review of the toll.

44 (b) Fee. – If a person does not take one of the actions required under subsection (a) of
45 this section within the required time, the Authority may add a processing fee to the amount the
46 person owes. The processing fee may not exceed six dollars (\$6.00). A person may not be
47 charged more than forty-eight dollars (\$48.00) in processing fees in a 12-month period.

2 **SECTION 5.7.(a)** DOT/Southeast Extension-Triangle Expressway. – The
3 Department of Transportation shall strive to expedite the federal environmental impact
4 statement process to define the route for the Southeast Extension of the Triangle Expressway
5 Turnpike Project by promptly garnering input from local officials and other stakeholders,
6 accelerating any required State studies, promptly submitting permit applications to the federal
7 government, working closely with the federal government during the permitting process, and
8 taking any other appropriate actions to accelerate the environmental permitting process.

9 **SECTION 5.7.(b)** Monitoring. – As part of its oversight of the Department of
10 Transportation, the Joint Legislative Transportation Oversight Committee shall closely monitor
11 the progress of the Southeast Extension of the Triangle Expressway Turnpike Project.

12 **TRANSITION STUDY AND REPORTING REQUIREMENTS**

13 **SECTION 6.1.** Formula Implementation Report. – The Department of
14 Transportation shall report to the Joint Legislative Transportation Oversight Committee and the
15 Fiscal Research Division no later than August 15, 2013, on the Department's recommended
16 formulas that will be used in the prioritization process to rank highway and nonhighway
17 projects. The Department of Transportation's Prioritization Office shall develop the
18 prioritization processes and formulas for all modes of transportation. The report will include a
19 statement on the process used by the Department to develop the formulas, include a listing of
20 external partners consulted during this process, and include feedback from its 3.0 workgroup
21 partners on the Department's proposed recommendations. The Department shall not finalize the
22 formula without consulting with the Joint Legislative Transportation Oversight Committee. The
23 Joint Legislative Transportation Oversight Committee has 30 days after the report is received to
24 meet and consult on the Department's recommendations. If no meeting occurs within 30 days
25 after the report is received, the consultation requirement will be met. If consultation occurs and
26 a majority of members serving on the Committee request changes to the Department's
27 recommended formulas for highway and nonhighway modes, the Department shall review the
28 requests and provide to the Committee its response to the requested changes no later than
29 October 1, 2013. A final report on the highway and intermodal formulas shall be submitted to
30 the Joint Legislative Transportation Oversight Committee by January 1, 2014.

31 **SECTION 6.2.** State Transportation Improvement Program Transition Report. –
32 The Department of Transportation shall submit transition reports to members of the Joint
33 Legislative Transportation Oversight Committee, House Appropriations Subcommittee on
34 Transportation and Senate Committee on Appropriations on Department of Transportation, and
35 the Fiscal Research Division on March 1, 2014, and November 1, 2014. The reports shall
36 include information on the Department's transition to Strategic Prioritization, overview changes
37 to the State Transportation Improvement Program (STIP) and other internal and external
38 processes that feed into the STIP, and offer statutory and policy recommendations or items for
39 consideration to the General Assembly that will enhance the prioritization process. The March
40 1, 2014, report shall also include an analysis of the distribution of tax and fee revenues between
41 the Highway Fund and Highway Trust Fund and an analysis to determine if maintenance,
42 construction, operations, administration, and capital expenditures are properly budgeted within
43 the two funds and existing revenues are most effectively distributed between the two funds.

44 **EFFECTIVE DATE/APPLICABILITY**

45 **SECTION 7.1.** This act shall become effective and applies as follows:
