1 A BILL TO BE ENTITLED
2 AN ACT TO CREATE THE NORTH CAROLINA MILITARY AFFAIRS COMMISSION.
3 The General Assembly of North Carolina enacts:

4 SECTION 1. The North Carolina Advisory Commission on Military Affairs is
5 hereby abolished.

6 SECTION 2. Chapter 127C of the General Statutes reads as rewritten:

7 "Chapter 127C.

8 "~~Advisory Commission on Military Affairs.~~ **North Carolina Military Affairs Commission.**

9 "~~§ 127C-1. Creation of the North Carolina Advisory Commission on Military~~
10 ~~Affairs.~~ **Commission established; purpose; transaction of business.**

11 (a) Establishment. – There is established the North Carolina Military Affairs
12 Commission. The Commission shall be established within the Office of the Governor. The
13 Department of Commerce is responsible for organizational, budgetary, and administrative
14 purposes.

15 (b) Purpose. – The Commission shall provide advice, counsel, and recommendations to
16 the Governor, the General Assembly, the Secretary of Commerce, and other State agencies on
17 initiatives, programs, and legislation that will continue and increase the role that North
18 Carolina's military installations, the National Guard, and Reserves play in America's defense
19 strategy and the economic health and vitality of the State. The Commission is authorized to:

20 (1) Coordinate and provide recommendations to the Governor, General
21 Assembly, and State agencies to protect North Carolina's military
22 installations from incompatible development, encroachment, or other
23 initiatives that could result in degradation or restrictions to military
24 operations, training ranges, or low level routes.

25 (2) Cooperate with military installations to facilitate the military mission,
26 training, and continued presence of major military installations in the State,
27 and notify the commanding military officer of a military installation and the
28 governing body in affected counties and municipalities of any economic
29 development or other projects that may impact military installations.

30 (3) Identify and support ways to promote quality of life for military members
31 and their families, such as providing a sound infrastructure, affordable
32 housing, affordable education, and transition support into North Carolina's
33 workforce for military members and their families, military retirees, and
34 veterans.

- 1 (4) Lead the State's initiative to prepare for the next round of Base Realignment
2 and Closure (BRAC), as defined by the Governor and the General
3 Assembly, with input from local military communities.
- 4 (5) Identify and support economic development organizations and initiatives
5 that focus on leveraging the military and other business opportunities to help
6 create jobs and expand defense and homeland security related economic
7 development activity in North Carolina.
- 8 (6) Assist military installations located within the State by coordinating with
9 commanders, communities, and State and federal agencies on affairs that
10 affect military installations and may require State coordination and
11 assistance.
- 12 (7) Support the long-term goal of a viable and prosperous military presence in
13 the State, which shall include development of comprehensive economic
14 impact studies of military activities in North Carolina, updated every two
15 years with recommendations for initiatives to support this goal.
- 16 (8) Supporting environmental and sustainability initiatives such as the Southeast
17 Regional Partnership for Planning and Sustainability, the Army's Compatible
18 Use Buffer Program, the Working Lands Group, Regional Environmental
19 Protection Initiative, their successors, and related initiatives.
- 20 (9) Adopt processes to ensure that all planning, coordination, and actions are
21 conducted with timely consideration having been given to relevant military
22 readiness or training concerns and with appropriate communications with all
23 potentially affected military entities.
- 24 (10) Share information and coordinate efforts with the North Carolina
25 congressional delegation and other federal agencies, as appropriate.
- 26 (11) Any other issue or matter that the Commission deems essential to fulfilling
27 its purpose.

28 (c) Transaction of Business. – The Commission shall provide a report on military
29 affairs to the Governor at least every six months, and to the General Assembly prior to the start
30 of the legislative sessions, or as required by the members. Priority actions or issues may be
31 submitted at any time.

32 ~~There is created in the Office of the Governor the North Carolina Advisory Commission on~~
33 ~~Military Affairs to advise the Governor and the Secretary of Commerce on protecting the~~
34 ~~existing military infrastructure in this State and to promote new military missions and~~
35 ~~economic opportunities for the State and its citizens.~~

36 **"§ 127C-2. Membership.**

37 (a) ~~The North Carolina Advisory Commission on Military Affairs~~ Commission shall
38 consist of ~~21 voting members, who shall serve on the Executive Committee, and 17 nonvoting,~~
39 ~~ex officio members who shall serve by reason of their positions~~ voting members who are either
40 appointed by the Governor, the Speaker of the House of Representatives, and the President Pro
41 Tempore of the Senate or serve as nonvoting ex officio members as provided in this section.

42 (b) ~~The Executive Committee voting members of the Commission shall be appointed as~~
43 follows:

- 44 (1) ~~Three members appointed by the Speaker of the House of Representatives,~~
45 ~~one of whom shall be a member of a recognized veterans' organization.~~ Ten
46 members appointed by the Governor, consisting of:
- 47 a. One person residing near Camp Lejeune, who is retired from the
48 military or is involved in military issues through civic, commercial,
49 or governmental relationships.

12 civic, commercial, or governmental relationships.
- 13 f. Five persons who may reside in any part of the State, who are
14 involved in military issues through civic, commercial, or
15 governmental relationships.
- 16 (2) ~~Three members appointed by the President Pro Tempore of the Senate, one~~

- (1) The Lieutenant Governor.

- ~~(2)(3)~~ Secretary of Commerce.
- ~~(2a)(4)~~ The Secretary of Transportation.
- ~~(2b)(5)~~ The Secretary of the Department of Environment and Natural Resources.
- ~~(3)(6)~~ Commanding General 18th Airborne Corps, Fort Bragg. The Commissioner of Agriculture.
- ~~(4)~~ Commanding General Marine Corps Base, Camp Lejeune.
- ~~(5)~~ Commanding General Marine Corps Air Station, Cherry Point.
- ~~(6)~~ Commander 4th FW, Seymour Johnson Air Force Base.
- ~~(7)~~ Commander 43rd Airlift Wing, Pope Air Force Base.
- ~~(8)~~ Commander of the U.S. Coast Guard Support Center, Elizabeth City.
- ~~(9)(7)~~ Adjutant General of the North Carolina National Guard.

(c1) The following officers, or their designee, shall be invited to serve as nonvoting ex officio members of the Commission:

- (1) Commanding General, 18th Airborne Corps, Ft. Bragg.
- (2) Commanding General, Marine Corps Installations East.
- (3) Commanding Officer, Marine Corps Air Station, Cherry Point.
- (4) Commanding Officer, 4th Fighter Wing, Seymour Johnson Air Force Base.
- (5) Commanding Officer, U.S. Army Corps of Engineers, Wilmington District.
- (6) Commanding Officer, U.S. Coast Guard Base, Elizabeth City.
- (7) Commanding Officer, Marine Corps Air Station, New River.
- (8) Commanding Officer, Camp Lejeune Marine Corps Base.
- (9) Commanding Officer, Fleet Readiness Center East.
- (10) Commanding Officer, Military Ocean Terminal, Sunny Point.

(d) The Governor shall designate one member of the Executive Committee appointed pursuant to subsection (b) of this section to serve as chair. The Executive Committee shall elect four persons from amongst its membership to serve as vice chairs. Chair of the Commission shall be appointed by the Governor from the voting members of the Commission.

(e) The terms of the appointed members of the ~~Executive Committee~~ Commission shall be as follows: two years.

- ~~(1) The members initially appointed by the Speaker of the House of Representatives and the President Pro Tempore of the Senate shall serve terms ending on December 31, 2003.~~
- ~~(2) Seven of the members appointed by the Governor shall serve initial terms ending on December 31, 2002.~~
- ~~(3) Eight of the members appointed by the Governor shall serve initial terms ending on December 31, 2003.~~

Thereafter, all members shall serve two-year terms.

(f) The initial meeting of the Commission shall be within 30 days of the effective date of this act at a time and place to be determined by the Secretary of Commerce. The first order

1 of business at the initial meeting of the Commission shall be the adoption of bylaws and
2 establishment of committees, after which the Commission shall meet upon the call of the
3 Chairman or the Military Advisor within the Office of the Governor. The members shall
4 receive no compensation for attendance at meetings, except a per diem expense reimbursement.
5 Members of the Commission who are not officers or employees of the State shall receive
6 reimbursement for subsistence and travel expenses at rates set out in G.S. 138-5 from funds
7 made available to the Commission. Members of the Commission who are officers or employees
8 of the State shall be reimbursed for travel and subsistence at the rates set out in G.S. 138-6 from
9 funds made available to the Commission.

10 **"§ 127C-3. Military Advisor.**

11 The Military Advisor within the Office of the Governor shall serve as the administrative
12 head of the Commission and be responsible for the operations and normal business activities of
13 the Commission, with oversight by the ~~Executive Committee~~.Commission.

14 **~~"§ 127C-4. Purposes.~~**

15 ~~The Commission shall have the following responsibilities and duties:~~

- 16 (1) ~~Advise the Governor and Secretary of Commerce on how to strengthen the~~
17 ~~State's relationship with the military to protect the installations of this State~~
18 ~~from the results of any future defense budget cuts or military downsizing by~~
19 ~~providing a sound infrastructure, affordable housing, and affordable~~
20 ~~education for military members and their families, working to be viewed by~~
21 ~~national military leaders as the most military friendly State in the nation.~~
22 (2) ~~Develop a strategic plan to provide initiatives to support the long term~~
23 ~~viability and prosperity of the military of this State that shall include, at~~
24 ~~least:~~
25 a. ~~A comprehensive Economic Impact Study of Military Activities in~~
26 ~~North Carolina to be conducted by the North Carolina State~~
27 ~~University Department of Economics and the East Carolina~~

38 **SECTION 3.** This act becomes effective July 1, 2013.
