1 A BILL TO BE ENTITLED  
2 AN ACT ENHANCING THE EFFECTIVENESS AND EFFICIENCY OF STATE  
3 GOVERNMENT BY MODERNIZING THE STATE'S SYSTEM OF HUMAN  
4 RESOURCES MANAGEMENT AND BY PROVIDING FLEXIBILITY FOR  
5 EXECUTIVE BRANCH REORGANIZATION AND RESTRUCTURING.

6 The General Assembly of North Carolina enacts:

7  
8 **PART I. ORGANIZATIONAL AND ADMINISTRATIVE CHANGES**

9 **SECTION 1.1.** G.S. 126-3(a) reads as rewritten:

10 "(a) There is hereby established the Office of State Personnel (hereinafter referred to as  
11 'the Office') which shall be placed for organizational purposes within the ~~Department of~~  
12 ~~Administration.~~ Office of the Governor. Notwithstanding the provisions of North Carolina  
13 State government reorganization as of January 1, 1975, and specifically notwithstanding the  
14 provisions of Chapter 864 of the 1971 North Carolina Session Laws, Chapter 143A of the  
15 General Statutes, the Office of State Personnel shall exercise all of its statutory powers in this  
16 ~~Chapter independent of control by the Secretary of Administration and Chapter,~~ which shall be  
17 under the administration and supervision of a State Personnel Director (hereinafter referred to  
18 as 'the Director') appointed by the Governor and subject to the supervision of the Commission  
19 for purposes of this Chapter. The salary of the Director shall be fixed by the Governor. The  
20 Director shall serve at the pleasure of the Governor."

21 **SECTION 1.2.** G.S. 126-3(a)(8) reads as rewritten:

22 "(8) Developing criteria and standards to measure the level of compliance or  
23 noncompliance with established Commission policies, rules, procedures,  
24 criteria, and standards in agencies, departments, and institutions to which  
25 authority has been delegated for classification, salary ~~administration~~  
26 administration, performance management, development, evaluation, and  
27 other decentralized programs, and determining through routine monitoring  
28 and periodic review process, that agencies, departments, and institutions are  
29 in compliance or noncompliance with established Commission policies,  
30 rules, procedures, criteria, and standards."

31 **SECTION 1.3.** G.S. 126-4(5) reads as rewritten:

32 **"§ 126-4. Powers and duties of State Personnel Commission.**

33 Subject to the approval of the Governor, the State Personnel Commission shall establish  
34 policies and rules governing each of the following:

- 1 (5) Hours and days of work, holidays, vacation, sick leave, and other matters  
2 pertaining to the conditions of employment. The legal public holidays  
3 established by the Commission as paid holidays for State employees shall  
4 include Martin Luther King, Jr.'s Birthday and Veterans Day. The  
5 Commission shall not provide for more than ~~14~~12 paid holidays per year  
6 except that in those years in which Christmas Day falls on a Tuesday,  
7 Wednesday, or Thursday, the Commission shall not provide for more than  
8 12 paid holidays year, with three paid holidays being given for Christmas."

9 **SECTION 1.4.** This Part is effective when it becomes law.

10  
11 **PART II. STATE PERSONNEL COMMISSION CHANGES**

12 **SECTION 2.1.** G.S. 126-2 reads as rewritten:

13 **"§ 126-2. State Personnel Commission.**

14 (a) There is hereby established the State Personnel Commission (hereinafter referred to  
15 as "the Commission").

16 (b) ~~The Commission shall consist of nine members, appointed as follows:~~

- 17 (1) ~~Two members shall be attorneys licensed to practice law in North Carolina  
18 appointed by the General Assembly, one of whom shall be appointed upon  
19 the recommendation of the Speaker of the House of Representatives, and one  
20 of whom shall be appointed upon the recommendation of the President Pro  
21 Tempore of the Senate.~~

22 ~~The initial two attorney members appointed under this subdivision shall  
23 serve terms expiring June 30, 2004; the terms of subsequent appointees shall  
24 be six years.~~

- 25 (2) ~~Two persons from private business or industry appointed by the Governor,  
26 both of whom shall have a working knowledge of, or practical experience in,  
27 human resources management. The initial members appointed under this  
28 subdivision shall serve terms expiring June 30, 2003; the terms of  
29 subsequent appointees shall be six years.~~

- 30 (3) ~~Two State employees subject to the State Personnel Act serving in  
31 nonexempt positions, appointed by the Governor, including one of whom is  
32 a veteran of the Armed Forces of the United States appointed upon the  
33 nomination of the Veterans' Affairs Commission. One employee shall serve  
34 in a State government position having supervisory duties, and one employee  
35 shall serve in a nonsupervisory position. Neither employee may be a human  
36 resources professional. The Governor shall consider nominations submitted  
37 by the State Employees Association of North Carolina. The initial members  
38 appointed under this subdivision shall serve terms expiring June 30, 2001;  
39 the terms of subsequent appointees shall be six years.~~

- 40 (4) ~~Two local government employees subject to the State Personnel Act  
41 appointed by the Governor upon recommendation of the North Carolina  
42 Association of County Commissioners, one a nonsupervisory local employee  
43 and one a supervisory local employee. Neither local government employee  
44 may be a human resources professional. The initial members appointed  
45 under this subdivision shall serve terms expiring June 30, 2003; the terms of  
46 subsequent appointees shall be for six years.~~

- 47 (5) ~~One member of the public at large appointed by the Governor. The initial  
48 member appointed under this subdivision shall serve for a term expiring  
49 June 30, 2001; the terms of subsequent appointees shall be for six years.~~

50 (b1) The Commission shall consist of nine members, appointed as follows:

- 1           (1) One member appointed by the General Assembly upon the recommendation  
2 of the Speaker of the House of Representatives who shall be an attorney  
3 licensed to practice law in North Carolina.
- 4           (2) One member appointed by the General Assembly upon the recommendation  
5 of the President Pro Tempore of the Senate who shall be an attorney licensed  
6 to practice law in North Carolina.
- 7           (3) One member appointed by the General Assembly upon the recommendation  
8 of the Speaker of the House of Representatives who shall be from private  
9 business or industry and who shall have a working knowledge of, or  
10 practical experience in, human resources management.
- 11           (4) One member appointed by the General Assembly upon the recommendation  
12 of the President Pro Tempore of the Senate who shall be from private  
13 business or industry and who shall have a working knowledge of, or  
14 practical experience in, human resources management.
- 15           (5) One member who is a veteran of the Armed Forces of the United States  
16 appointed by the Governor upon the nomination of the Veterans Affairs  
17 Commission and who is a State employee subject to this Chapter serving in a  
18 nonexempt supervisory position. The member may not be a human resources  
19 professional. The Governor shall consider nominations submitted by the  
20 State Employees Association of North Carolina.
- 21           (6) One member appointed by the Governor who is a State employee subject to  
22 this Chapter serving in a nonexempt nonsupervisory position. The member  
23 may not be a human resources professional. The Governor shall consider  
24 nominations submitted by the State Employees Association of North  
25 Carolina.
- 26           (7) One member appointed by the Governor upon the recommendation of the  
27 North Carolina Association of County Commissioners who is a local  
28 government employee subject to this Chapter serving in a supervisory  
29 position. The member may not be a human resources professional.
- 30           (8) One member appointed by the Governor upon the recommendation of the  
31 North Carolina Association of County Commissioners who is a local  
32 government employee subject to this Chapter serving in a nonsupervisory  
33 position. The member may not be a human resources professional.
- 34           (9) One member of the public at large appointed by the Governor.
- 35       (c) Each member of the Commission shall be appointed for a term of four years.  
36 Members of the Commission may serve no more than two consecutive terms. Appointments by  
37 the General Assembly shall be made in accordance with G.S. 120-121, and vacancies in those  
38 appointments shall be filled in accordance with G.S. 120-122. Vacancies in appointments made  
39 by the Governor occurring prior to the expiration of a term shall be filled by appointment for  
40 the unexpired term.
- 41       (d) No member of the Commission may serve on a case where there would be a conflict  
42 of interest. The appointing authority may at any time remove any Commission member for  
43 cause.
- 44       (e) Members of the Commission who are State or local government employees subject  
45 to ~~the State Personnel Act~~ this Chapter shall be entitled to administrative leave without loss of  
46 pay for all periods of time required to conduct the business of the Commission.
- 47       (f) Six members of the Commission shall constitute a quorum.
- 48       (g) The Governor shall designate one member of the Commission as chair.
- 49       (h) The Commission shall meet quarterly, and at other times at the call of the chair."

50       **SECTION 2.2.** The terms of the two attorney members appointed under  
51 G.S. 126-2(b)(1), serving on the Commission on January 1, 2013, shall expire on June 30,

1 2013. The terms of the persons from private business or industry appointed under  
2 G.S. 126-2(b)(2), serving on the Commission on January 1, 2013, shall expire on June 30,  
3 2014. The terms of the two State employees appointed under G.S. 126-2(b)(3), serving on the  
4 Commission on January 1, 2013, shall expire on June 30, 2013. The terms of the two local  
5 government employees appointed under G.S. 126-2(b)(4), serving on the Commission on  
6 January 1, 2013, shall expire on June 30, 2014. The term of the public at-large member  
7 appointed under G.S. 126-2(b)(5), serving on the Commission on January 1, 2013, shall expire  
8 June 30, 2013. If the terms of office eliminated in this act have not been set out, then the  
9 appointing authorities shall determine by July 1, 2013, which terms to eliminate to achieve the  
10 membership totals pursuant to this act. After determining which terms to eliminate, the  
11 appointing authority shall notify in writing all the persons and entities required to receive  
12 notification pursuant to G.S. 143-47.7.

13 **SECTION 2.3.** This Part is effective when it becomes law.  
14

### 15 **PART III. PROBATIONARY AND CAREER STATE EMPLOYEES**

16 **SECTION 3.1.** G.S. 126-1.1 reads as rewritten:

#### 17 **"§ 126-1.1. Career State employee defined.**

18 (a) For the purposes of this Chapter, unless the context clearly indicates otherwise,  
19 "career State employee" means a State employee or an employee of a local entity who is  
20 covered by this Chapter pursuant to G.S. 126-5(a)(2) who:

- 21 (1) Is in a permanent position and permanent appointment; and
- 22 (2) Has been continuously employed by the State of North Carolina or a local  
23 entity as provided in G.S. 126-5(a)(2) in a position subject to the State  
24 Personnel Act for the immediate ~~24~~12 preceding months.

25 (b) As used in this Chapter, "probationary State employee" means a State employee  
26 who is in a probationary appointment and is exempt from the provisions of the State Personnel  
27 Act only because the employee has not been continuously employed by the State for the time  
28 period required by subsection (a) of this section."

29 **SECTION 3.2.** G.S. 126-15.1 is repealed.

30 **SECTION 3.3.** This Part is effective when it becomes law.  
31

### 32 **PART IV. EXEMPT POSITION MODIFICATIONS**

33 **SECTION 4.1.** G.S. 126-5(d)(1) reads as rewritten:

- 34 "(d) (1) Exempt Positions in Cabinet Department. – Subject to the provisions of this  
35 Chapter, which is known as the State Personnel Act, the Governor may  
36 designate a total of ~~4,000~~1,500 exempt positions throughout the following  
37 ~~departments;~~ departments and offices:
- 38 a. Department of Administration.
  - 39 b. Department of Commerce.
  - 40 c. Repealed by Session Laws 2012-83, s. 7, effective June 26, 2012,  
41 and by Session Laws 2012-142, s. 25.2E(a), effective January 1,  
42 2013.
  - 43 d. Department of Public Safety.
  - 44 e. Department of Cultural Resources.
  - 45 f. Department of Health and Human Services.
  - 46 g. Department of Environment and Natural Resources.
  - 47 h. Department of Revenue.
  - 48 i. Department of Transportation.
  - 49 j. Repealed by Session Laws 2012-83, s. 7, effective June 26, 2012,  
50 and by Session Laws 2012-142, s. 25.2E(a), effective January 1,  
51 2013.

1                   k.     Office of Information Technology Services.

2                   l.     Office of State Budget and Management.

3                   m.    Office of State Personnel.

4       Notwithstanding the provisions of this subdivision or the other requirements of this  
5 subsection, the Governor may at any time designate up to one percent (1%) of the total number  
6 of full-time positions in the Department of Public Safety, not to exceed 100 positions, as  
7 exempt managerial positions. Notwithstanding the provisions of this subdivision, or the other  
8 requirements of this subsection, the Governor may at any time increase by five the number of  
9 exempt policy-making positions at the Department of Public Safety, but at no time shall the  
10 total number of exempt policy-making positions exceed 105."

11           **SECTION 4.2.** G.S. 147-33.77(a) reads as rewritten:

12       "(a) The State Chief Information Officer may appoint a Chief Deputy Information  
13 Officer. The salary of the Chief Deputy Information Officer shall be set by the State Chief  
14 Information Officer. The State Chief Information Officer may appoint all employees, including  
15 legal counsel, necessary to carry out the powers and duties of the office. These employees shall  
16 be subject to the State Personnel Act.Act, except that employees in positions designated as  
17 exempt under G.S. 126-5(d)(1) are not subject to the Act, in accordance with the provisions of  
18 that section."

19           **SECTION 4.3.** G.S. 126-5(e) is repealed.

20           **SECTION 4.4.** G.S. 126-5(f) is repealed.

21           **SECTION 4.5.** This Part is effective when it becomes law.

## 22

### 23 **PART V.       REDUCTIONS IN FORCE**

24           **SECTION 5.1.** G.S. 126-7.1 reads as rewritten;

25       "**§ 126-7.1. Posting requirement; State employees receive priority consideration;**  
26       **reduction-in-force; Work First hiring.**

27       ...

28       (e) If a State employee subject to this section:

29           (1) Applies for another position of State employment that would constitute a  
30 promotion; and

31           (2) Has substantially equal qualifications as an applicant who is not a State  
32 ~~employee.employee;~~

33 then the State employee shall receive priority consideration over the applicant who is not a  
34 State employee. This priority consideration shall not apply when the only applicants considered  
35 for the vacancy are current State employees.

36       (f) If a State employee who has been separated due to reduction in force or who has  
37 been given notice of imminent separation due to reduction in force:

38           (1) Applies for another position of State employment equal to or lower in salary  
39 grade than the position held by the employee at the time of notification or  
40 separation; and

41           (2) Has substantially equal qualifications as any other applicant;

42 then within all State agencies, the State employee who has been notified of or separated due to  
43 a reduction in force shall receive priority consideration over all other applicants. This priority  
44 shall remain in effect for a period of 12 months from the date the employee receives  
45 notification of separation by reduction in force. State employees separated due to reduction in  
46 force shall receive higher priority than other applicants with employment or reemployment  
47 priorities, except that the reemployment priority created by G.S. 126-5(e)(1) shall be  
48 considered as equal.

49       (f1) If a State employee who has been separated due to reduction-in-force or who has  
50 been given notice of imminent separation due to reduction-in-force accepts or rejects an offer  
51 for a position of State employment equal to or lower in salary grade than the position held by

1 the employee at the time of separation or notification, then the employee's acceptance or  
2 rejection of that offer shall satisfy and terminate the one-time, 12-month priority granted by  
3 subsection (f) of this section.

4 ...."

5 **SECTION 5.2.** This Part is effective when it becomes law and applies to  
6 reductions-in-force implemented on or after that date.

7  
8 **PART VI. EMPLOYEE GRIEVANCES**

9 **SECTION 6.1.** Article 8 of Chapter 126 of the General Statutes reads as rewritten:

10 "Article 8.

11 "Employee Appeals of Grievances and Disciplinary Action.

12 **§ 126-34.01 Grievance appeal; resolution.**

13 Any State employee having a grievance arising out of or due to the employee's employment  
14 shall first discuss the problem or grievance with the employee's supervisor, unless the problem  
15 or grievance is with the supervisor. Then the employee shall follow the grievance procedure  
16 established by the employee's agency and approved by the State Personnel Commission.

17 **§ 126-34.02 Grievance process; grounds.**

18 (a) An applicant for State employment, a State employee, or former State employee  
19 may file a grievance with the State Personnel Commission provided the grievant has followed  
20 the agency grievance procedure.

21 The Office of State Personnel shall administer the grievance hearing process. Grievance  
22 hearings shall be conducted before hearing officers designated by the Director of the Office of  
23 State Personnel. It is the duty of the hearing officer to prepare a record of the hearing and to  
24 submit, within 60 days of the date the hearing officer receives the grievance, a recommended  
25 decision to the State Personnel Commission for its consideration unless the Commission grants  
26 an extension of time for good cause shown.

27 The State Personnel Commission may modify, accept, or reject the recommendation of the  
28 hearing officer. If the hearing officer's recommended decision is rejected by the Commission,  
29 the Commission shall issue its own findings, conclusions, and decision within 90 days.

30 The decision of the State Personnel Commission is subject to review by the Office of  
31 Administrative Hearings under Chapter 150B of the General Statutes. The Office of  
32 Administrative Hearings may reverse or affirm the decision of the State Personnel Commission  
33 within 60 days. If no such order is entered, the decision of the State Personnel Commission  
34 becomes final and is subject to judicial review.

35 The decision of the Office of Administrative Hearings is subject to judicial review pursuant  
36 to Article 4 of Chapter 150B of the General Statutes, except that if the State Personnel  
37 Commission's decision is supported by any competent evidence the decision shall be affirmed  
38 by the superior court.

39 (b) The following issues may be grieved to the State Personnel Commission after the  
40 completion of the agency grievance procedure:

41 (1) Discrimination or harassment. – An applicant for State employment, a State  
42 employee, or former State employee may allege discrimination or  
43 harassment based on race, religion, color, national origin, sex, age,  
44 disability, genetic information, or political affiliation if the employee  
45 believes that he or she has been discriminated against in his or her  
46 application for employment or in the terms and conditions of the employee's  
47 employment, or in the termination of his or her employment.

48 (2) Retaliation. – An applicant for State employment, a State employee, or  
49 former State employee may allege retaliation for protesting discrimination  
50 based on race, religion, color, national origin, sex, age, disability, political  
51 affiliation, or genetic information if the employee believes that he or she has

1 been retaliated against in his or her application for employment or in the  
2 terms and conditions of the employee's employment, or in the termination of  
3 the employee's employment.

4 (3) Just cause for dismissal, demotion, or suspension. – A career State employee  
5 may allege that he or she was dismissed, demoted, or suspended for  
6 disciplinary reasons without just cause. A dismissal, demotion, or suspension  
7 which is not imposed for disciplinary reasons shall not be considered a  
8 disciplinary action within the meaning of this section. In cases of such  
9 disciplinary action the employee shall, before the action is taken, be  
10 furnished with a statement in writing setting forth the specific acts or  
11 omissions that are the reasons for the disciplinary action and the employee's  
12 appeal rights. The employee shall be permitted 15 days from the date the  
13 statement is delivered to appeal under the agency grievance procedure.  
14 However, an employee may be suspended without warning pending the  
15 giving of written reasons in order to avoid undue disruption of work, to  
16 protect the safety of persons or property, or for other serious reasons.

17 (4) Veteran's preference. – An applicant for State employment or State  
18 employee may allege that he or she was denied veteran's preference in  
19 violation of the law.

20 (5) Failure to post. – An applicant for State employment or a State employee  
21 may allege that he or she was denied hiring or promotion because a position  
22 was not posted in violation of this Chapter.

23 (6) Whistleblower. – A whistleblower grievance as provided for in this Chapter.

24 (c) Any issue for which appeal to the State Personnel Commission has not been  
25 specifically authorized by this Chapter shall not be grounds for a grievance to the Commission  
26 or any other State forum.

27 (d) In grievance appeals conducted pursuant to this Chapter, the burden of showing that  
28 a career State employee was discharged, demoted, or suspended for just cause rests with the  
29 employer. In all other grievance appeals, the burden of proof rests on the employee.

30 (e) Any grievance appeal of the final decision of an agency head must be brought  
31 within 30 days from the day of receipt of the decision.

32 (f) The decision of the State Personnel Commission is advisory for covered local  
33 government employees.

34 (g) The State Personnel Commission may award attorneys' fees to an employee where  
35 reinstatement or back pay is ordered or where an employee prevails in a whistleblower  
36 grievance. The remedies in this subsection are not exclusive remedies.

37 ~~"§ 126-34. Grievance appeal for career State employees.~~

38 ~~Unless otherwise provided in this Chapter, any career State employee having a grievance~~  
39 ~~arising out of or due to the employee's employment and who does not allege unlawful~~  
40 ~~harassment or discrimination because of the employee's age, sex, race, color, national origin,~~  
41 ~~religion, creed, handicapping condition as defined by G.S. 168A-3, or political affiliation shall~~  
42 ~~first discuss the problem or grievance with the employee's supervisor and follow the grievance~~  
43 ~~procedure established by the employee's department or agency. Any State employee having a~~  
44 ~~grievance arising out of or due to the employee's employment who alleges unlawful harassment~~  
45 ~~because of the employee's age, sex, race, color, national origin, religion, creed, or handicapping~~  
46 ~~condition as defined by G.S. 168A-3 shall submit a written complaint to the employee's~~  
47 ~~department or agency. The department or agency shall have 60 days within which to take~~  
48 ~~appropriate remedial action. If the employee is not satisfied with the department or agency's~~  
49 ~~response to the complaint, the employee shall have the right to appeal directly to the Office of~~  
50 ~~Administrative Hearings.~~

51 ~~"§ 126-34.1. Grounds for contested case under the State Personnel Act defined.~~

1       (a) ~~A State employee or former State employee may file in the Office of Administrative~~  
2 ~~Hearings a contested case under Article 3 of Chapter 150B of the General Statutes only as to~~  
3 ~~the following personnel actions or issues:~~

- 4       (1) ~~Dismissal, demotion, or suspension without pay based upon an alleged~~  
5 ~~violation of G.S. 126-35, if the employee is a career State employee.~~
- 6       (2) ~~An alleged unlawful State employment practice constituting discrimination,~~  
7 ~~as proscribed by G.S. 126-36, including:~~
  - 8       a. ~~Denial of promotion, transfer, or training, on account of the~~  
9 ~~employee's age, sex, race, color, national origin, religion, creed,~~  
10 ~~political affiliation, or handicapping condition as defined by Chapter~~  
11 ~~168A of the General Statutes.~~
  - 12       b. ~~Demotion, reduction in force, or termination of an employee in~~  
13 ~~retaliation for the employee's opposition to alleged discrimination on~~  
14 ~~account of the employee's age, sex, race, color, national origin,~~  
15 ~~religion, creed, political affiliation, or handicapping condition as~~  
16 ~~defined by Chapter 168A of the General Statutes.~~
- 17       (3) ~~Retaliation against an employee, as proscribed by G.S. 126-17, for protesting~~  
18 ~~an alleged violation of G.S. 126-16.~~
- 19       (4) ~~Denial of the veteran's preference granted in accordance with Article 13 of~~  
20 ~~this Chapter in initial State employment or in connection with a reduction in~~  
21 ~~force, for an eligible veteran as defined by G.S. 126-81.~~
- 22       (5) ~~Denial of promotion for failure to post or failure to give priority~~  
23 ~~consideration for promotion or reemployment, to a career State employee as~~  
24 ~~required by G.S. 126-7.1 and G.S. 126-36.2.~~
- 25       (6) ~~Denial of an employee's request for removal of allegedly inaccurate or~~  
26 ~~misleading information from the employee's personnel file as provided by~~  
27 ~~G.S. 126-25.~~
- 28       (7) ~~Any retaliatory personnel action that violates G.S. 126-85.~~
- 29       (8) ~~Denial of promotion in violation of G.S. 126-14.2, where an initial~~  
30 ~~determination found probable cause to believe there has been a violation of~~  
31 ~~G.S. 126-14.2.~~
- 32       (9) ~~Denial of employment in violation of G.S. 126-14.2, where an initial~~  
33 ~~determination found probable cause to believe that there has been a violation~~  
34 ~~of G.S. 126-14.2.~~
- 35       (10) ~~Harassment in the workplace based upon age, sex, race, color, national~~  
36 ~~origin, religion, creed, or handicapping condition, whether the harassment is~~  
37 ~~based upon the creation of a hostile work environment or upon a quid pro~~  
38 ~~quo.~~
- 39       (11) ~~Violation of any of the following federal statutes as applied to the employee:~~
  - 40       a. ~~The Fair Labor Standards Act, 29 U.S.C. § 201, et seq.~~

12 **PART VIII. REORGANIZATION THROUGH REDUCTION PROGRAM**

- 16           (1) Restructure and reorganize in the executive branch in a manner defined by  
17 the number of positions, employee skills, and employee qualifications.
- 18           (2) Direct that reorganization shall be led by the organizational units that are  
19 being reorganized.
- 20           (3) Direct that organizations collaborate in planning and executing  
21 reorganization and restructuring across executive branch agencies and  
22 departments.

23           **SECTION 8.2.** The Office of State Personnel, in conjunction with the Office of  
24 State Budget and Management (OSBM), may develop the Reorganization Through Reduction  
25 Program (RTR). The RTR shall be one option available for reorganization and restructuring.  
26 The RTR is authorized to serve as an employee volunteer separation program to accomplish  
27 reorganization and restructuring needs through policies approved by the State Personnel  
28 Commission (SPC). The SPC policy shall detail the following:

- 29           (1) The approach to be used in identifying the organizational units.
- 30           (2) The process for identifying employees who may volunteer.
- 31           (3) The availability of severance and other related assistance.

32           **SECTION 8.3.** Notwithstanding any other provision of law to the contrary, if RTR  
33 is deployed and not enough employees volunteer, then selections for reductions-in-force from  
34 the current incumbent employees are authorized based upon skills and qualifications for the  
35 positions needed by the organizational unit. Employees separated from employment in a  
36 reduction-in-force conducted as part of the RTR shall be paid severance in accordance with the  
37 SPC approved policy. The positions retained by the executive branch may be repurposed.

38           **SECTION 8.4.** This Part is effective when it becomes law and expires December  
39 31, 2014.

6 thereof) and substitute references to the North Carolina Human Resources Act, the State  
7 Human Resources Commission, the Director of the Office of State Human Resources, and the  
8 Office of Human Resources (or the appropriate derivative thereof) to effectuate the renaming  
9 set forth in this section wherever conforming changes are necessary. The affected statutes may

1           **SECTION 9.2.** No action or proceeding pending on the effective date of this  
2 section, brought by or against the State Personnel Commission, the Director of the Office of  
3 State Personnel, or the Office of State Personnel, shall be affected by any provision of this  
4 section, but the same may be prosecuted or defended in the new name of the Commission,  
5 Director, and Office. In these actions and proceedings, the renamed Commission, Director, or  
6 Office shall be substituted as a party upon proper application to the courts or other public  
7 bodies.

8           **SECTION 9.3.** Any business or other matter undertaken or commanded by the  
9 former State Personnel Commission, State Personnel Director, or Office of State Personnel  
10 regarding any State program, office, or contract or pertaining to or connected with their  
11 respective functions, powers, obligations, and duties that are pending on the date this act  
12 becomes effective may be conducted and completed by the Commission, Director, or Office in  
13 the same manner and under the same terms and conditions and with the same effect as if  
14 conducted and completed by the formerly named commission, director, or office.

15           **SECTION 9.4.** This Part is effective when it becomes law.
