21 from Western Youth Institution to Foothills Correctional Institution to supervise the youthful
22 offenders being transferred from Western Youth Institution to Foothills Correctional
23 Institution.

24 **SECTION 16C.8.(b)** The Division of Adult Correction shall consolidate minimum
25 custody treatment slots within the Alcoholism and Chemical Dependency Program Section in
26 the Western Prison region to establish a substance abuse treatment center at Foothills
27 Correctional Institution using the minimum custody housing and any necessary administrative
28 space at Western Youth Institution no later than January 1, 2014.

29 **SECTION 16C.8.(c)** The Department of Public shall consolidate all B.R.I.D.G.E.
30 (Young Offenders Forest Conservation Program) units at the minimum custody inmates at
31 Foothills Correctional Institution.




